## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed an audit of the financial statements of Cumberland Plastic Solutions, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

December 31, 2024 and 2023

### **NOTE 1 - PLAN DESCRIPTION**

The following description of Cumberland Plastic Solutions, LLC (“Sponsor”) 401k Plan (“Plan”) provides only general information. The Plan Administrator is Kimberly Edge. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a contributory, defined contribution 401(k) plan available to substantially all salaried and hourly employees of the Sponsor. To be eligible to participate in the Plan and for the purposes of the employer matching contribution, the employee must be 18 years of age or older and must have completed three consecutive months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may contribute, on a pre-tax or Roth basis, up to 100% of their compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations, in the form of a salary deferral. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Such transfers from other qualified plans are reported as rollover contributions. The Sponsor makes safe harbor matching contributions equal to 100% of participants’ deferral contributions, up to a maximum of 3% of compensation, plus 50% of participants’ salary deferral contributions up to a maximum of 5% of compensation. The Sponsor, at its discretion, may also make non-safe harbor matching contributions to the Plan on behalf of participants. No discretionary, non-safe harbor matching or profit-sharing contributions were made during the years ended December 31, 2024 and 2023.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and the Sponsor’s contributions and an allocation of net Plan earnings. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is based on the participant’s vested balance.

#### **Vesting**

Participants are immediately vested in their elective deferrals, employer safe-harbor matching contributions, and any income or loss. Vesting of any additional discretionary employer matching contributions is based on years of continuous service. A participant is fully vested in discretionary employer matching contributions after six years of credited service or upon reaching normal retirement age.

#### **Notes Receivable from Participants**

Loans are not permitted for this Plan.

### **NOTE 1 - PLAN DESCRIPTION - Continued**

#### **Payment of Benefits**

Upon termination of service, due to death, disability, retirement or separation of service, a participant may elect to receive a lump-sum distribution. The Plan also permits withdrawals due to circumstances of financial hardship, in accordance with provisions specified in the Plan document.

#### **Forfeitures**

The nonvested portion of a terminated participant's account balance shall be forfeited and used to pay administrative expenses or to reduce Sponsor contributions. No discretionary employer matching contributions were made during the years ended December 31, 2024 and 2023, therefore, no forfeitures were generated during the aforementioned years.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments. The Sponsor pays the administrative costs of the Plan associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represent custodian fees, investment advisor fees and other recordkeeping fees paid directly from the Plan to the Plan's custodian and recordkeeper.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through the date the financial statements were available to be issued.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Concentration of Market Risk**

As of December 31, 2024 and 2023, approximately 33% and 51%, respectively, of the Plan's net assets were invested in two and four accounts. The underlying value of the investments are dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the guaranteed interest account and pooled separate accounts and their investment holdings in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of change in net assets available for benefits.

**Income Recognition**

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses from security transactions are reported on the average cost method.

**Fair Value**

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Fair Value - Continued**

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodians have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments at fair value, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and the net appreciation in fair value of investments, included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, included in the supplemental information.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in the Sponsor contributions.

**NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 - FAIR VALUES**

The following is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used during the years ended December 31, 2024 or 2023.

- *Pooled Separate Accounts*: valued using the Net Asset Value ("NAV") as a practical expedient and are not categorized in the fair value hierarchy. NAV is provided by the trustee and is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. These funds have no redemption restrictions.
- *Mutual Funds*: valued at the net asset value of shares held by the plan at year end, which are actively traded on the open market.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

**NOTE 7 - INCOME TAX STATUS**

On March 31, 2014, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualified under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is designed and operating in compliance with the applicable requirements of the IRC.

Tax positions are recognized in financial statements when it is more likely than not the position will be sustained upon examination by the tax authorities.

As of December 31, 2024 and 2023, the Plan believes it had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.
