## **INDEPENDENT AUDITOR'S REPORT**

Trustees and Plan Administrator  
Apoyo Financiero, Inc. 401(k) Profit Sharing Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Apoyo Financiero, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### **1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following description of the Apoyo Financiero, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is intended to qualify under 401(a) and other applicable requirements of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is a defined contribution 401(k) profit sharing plan originally adopted effective January 1, 2014 and most recently amended effective August 19, 2021. The Plan generally covers all employees of Apoyo Financiero, Inc. (the "Company") that are at least 18 years of age and are not subject to a collective bargaining agreement. The minimum service requirement is met upon the completion of three months service.

*Administration* - Under the terms of the Plan, a member of the Company's management acts as Trustee, John Hancock Life Insurance Company ("John Hancock") acts as the custodian, and Professional Benefit Services, Inc. ("PBS") serves as the third-party administrator. Expenses incurred for administering the Plan may be paid by either the Plan or the Company at its discretion. For the year ended December 31, 2024, recordkeeping and asset service fees were paid by the Plan. All other administrative expenses were paid by the Company

*Basis of accounting* - The Plan's financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Use of estimates* - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from these estimates.

*Vesting* - Participants are fully vested in their voluntary and rollover contributions, including earnings thereon at all times. Employer profit sharing contributions, if any, paid on the participants' behalf are vested ratably over a six-year period.

*Employee contributions* - Participants may elect to have the Company contribute a percentage or fixed dollar amount, of their pre-tax compensation to the Plan, up to the amount allowable under current income tax regulations. Participants may also elect to have the Company contribute a portion of their compensation post-tax in the form of a Roth deferral. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants may also elect to contribute amounts representing distributions from other qualified plans.

***Employer contributions*** – The Plan allows for discretionary employer contributions in the form of non-elective profit-sharing contributions. Non-elective profit-sharing contributions, if any, would be allocated to certain specified employee allocation groups on a non-discriminatory basis in accordance with Plan provisions. The Plan does not allow for employer matching contributions. For the year ended December 31, 2024, the company has not elected to make any non-elective profit-sharing contributions to the Plan.

For the year ended December 31, 2024, the Company made corrective qualified nonelective contributions totaling \$3,937, which are reported as employer contributions on the accompanying statement of changes in net assets available for benefit.

***Participant accounts*** – A separate account is maintained for each participant. Each participant's account is credited with the participant's voluntary contributions, employer contributions and an allocation of Plan earnings, less withdrawals, distributions and administrative expenses, if any. The benefit to which a participant is entitled is limited to the benefit that may be provided from the participant's vested account balance.

***Notes receivable from participants*** – The Plan provides a provision that allows a participant to borrow up to the lesser of \$50,000 or 50% of their vested account balance, with a minimum of \$1,000. Such loans shall bear interest at fixed rates equal to the published prime rate, plus one percent. The term of the loans cannot exceed five years, except if the loan proceeds are used to finance the purchase of a primary residence, in which case the loan term may not exceed twenty years. The loans are secured by the participant's vested balance. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants, if any, are stated at their unpaid principal balances plus any accrued but unpaid interest.

***Investments, at fair value*** – The Plan's investments are reported at estimated fair values, which are determined, presented and disclosed in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*. Investments of the Plan are held by the Plan's custodian and are invested based solely upon instructions from participants. Pooled separate account investments are valued at fair values as of the last day of the Plan year, as quoted by the Plan's custodian based on net asset values obtained for the underlying mutual funds as quoted on an established exchange, as adjusted for certain fees as disclosed in the underlying annuity contract. Purchases and sales of securities are recorded on a trade date basis. Interest and dividend income is recorded when received.

***Investment income*** – Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost if acquired during the Plan year. In accordance with the Plan's policy of stating investments at fair value, net unrealized appreciation or depreciation is included in the statement of changes in net assets in the period in which the market change occurs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

*Forfeited accounts* – Forfeited non-vested accounts will be used to reduce future employer contributions or to pay expenses of the Plan. At December 31, 2024 and 2023, the Plan had unallocated forfeitures totaling \$1,538. At December 31, 2023, the Plan had no unallocated forfeitures. During the year ended December 31, 2024, no forfeitures were used to pay administrative expenses of the Plan or reduce employer contributions.

*Payment of Benefits* – Upon termination of service or disability, age 59 ½, retirement, death, or hardship, the participants or beneficiaries receive, upon request, a lump-sum payment equal to the value of the vested funds in the participant's account. Benefits (which include rollover transfers to other plans) are recorded when paid.

*Plan Termination* – The Company intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to terminate the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

*Subsequent Events* – The Plan's management evaluates events or transactions occurring after the statement of net assets available for benefits but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. For the purposes of the accompanying financial statements, subsequent events have been evaluated through October 2, 2025, which represents the date the financial statements were available to be issued.

## **2. INCOME TAX STATUS**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and believes that the Plan was qualified as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## **3 INVESTMENTS AT FAIR VALUE**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments are managed by John Hancock, the Plan's custodian, or its affiliate. Therefore, investment transactions involving these investments qualify as party-in-interest transactions as defined by ERISA.

In accordance with the service agreement between John Hancock and the Plan, John Hancock may assess fees for recordkeeping, investment advisory and transactional services to the Plan. For the year ended December 31, 2024, fees assessed by John Hancock for services provided totaled \$15,051 and are included in the administrative expenses.

**6. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist of pooled separate accounts. As the portfolio is well diversified and issuers of the funds' underlying securities are dispersed throughout many industries and geographies, the concentrations of credit risk are limited.
