Independent Auditors' Report

To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the financial statements of Osborn & Barr Communications Employee Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

NOTE A | DESCRIPTION OF PLAN

The following description of Osborn & Barr Communications Employee Savings Plan provides only general information. Participants should refer to the *Plan Document* for a more complete description of the Plan's provisions, which is available from the plan administrator.

General

The Plan is a defined contribution plan covering all eligible and participating employees of Osborn & Barr Communications, Inc. (the Company) who have attained the age of 21.

Leased, seasonal, part-time and temporary employees and independent contractors are ineligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each eligible employee is automatically enrolled in the Plan at a reduction of 3% of their eligible compensation unless a different deferral percentage is chosen or they elect not to enroll in the Plan. Participants may elect to contribute a percentage of their compensation on a pre-tax or after tax basis not to exceed applicable calendar limits under Section 402(g)(1) of the Internal Revenue Code which was \$23,000 for 2024 and \$22,500 2023. Participants age 50 and older may elect an additional catch-up deferral of \$7,500 for 2024 and 2023.

The Company made a discretionary matching contribution in an amount equal to 100% of the first 3% and 50% of the next 2% of the participant's eligible compensation for the period from April 15, 2024 through December 31, 2024 and 50% up to the first 3% for the period from January 1, 2023, through April 14, 2024. Total matching contributions were \$203,535 and \$194,867, for the years ended 2024 and 2023, respectively. The Plan also allows for a discretionary profit-sharing contribution. Active participants who are employed on the last day of the Plan year and have 1,000 or more hours of service in the Plan year are eligible to share in discretionary employer profit-sharing contributions. Employees are eligible to share in the profit-sharing contributions regardless of service if active during the Plan year but terminated due to death, disability, or reaching normal retirement. No profit-sharing contributions were made for years ended December 31, 2024, or 2023.

The participant may also choose to roll funds into the Plan from another qualified plan. Participants direct contributions on their behalf to various investment options the Plan offers. These options include mutual funds, pooled separate accounts, guaranteed investment contracts and common collective trust funds.

Participant Accounts

Each participant's account is credited with the participant's elective and, if applicable, rollover contributions and allocations of (a) the Company's contributions and (b) Plan earnings and charged with (c) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and, if applicable, rollover contributions plus actual earnings thereon. Vesting for the Company's matching contributions and discretionary profit-sharing contribution occurs on a cliff basis after three years of service in which the participant has worked a minimum of 1,000 hours.

Payment of Benefits

Retirement benefits are normally payable upon reaching age 65. Upon termination of service due to death, disability, retirement or other termination of employment, a participant or, in the case of death, the participant's beneficiary, is eligible to receive a distribution equal to the value of his or her vested account in excess of \$5,000 in the form of a lump-sum payment, substantially equal installments, or partial withdrawal. If the balance payable does not exceed \$5,000 then the benefit may only be paid as a lump-sum. The portion of the account that is not 100% vested will be forfeited. The Plan also allows for in-service distributions at age 59 ½ from all participants accounts.

Participant Hardship Withdrawals

Participants who are active employees may withdraw a portion of their vested account balance in the event of undue financial hardship in accordance with requirements as outlined in the Plan document.

Notes Receivable from Participants

Participants may borrow from their fund accounts. A participant cannot have more than one loan outstanding at a time and cannot have more than three loans approved in any 12-month period. The minimum loan amount is \$1,000 and borrowings cannot exceed the lesser of \$50,000 or 50 percent of their vested account balance. Each loan shall bear a reasonable fixed rate of interest to be determined by the Loan Administrator. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

Forfeitures are used to pay plan expenses and reduce the discretionary Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,561 and \$90 respectively. During the year ended December 31, 2024 and 2023, forfeitures of \$34,669 and \$51,031 were used to reduce Company matching contributions and \$15,675 and \$14,214 were used to pay plan expenses, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to plan provisions and ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions, and the interest of each participant would be distributed at the time as prescribed by the Plan terms and the Internal Revenue Code (IRC).

NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual method of accounting.

Valuation of Investments and Income Recognition

The guaranteed investment contract is recorded at contract value which approximates fair value. All other investments are reported at fair value as provided by the trustee and custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and in the principal and most advantageous market for the asset or liability. See Note E for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade date. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses

Certain administrative functions applicable to the Plan are performed by employees of the Company. No such employees receive compensation from the Plan. Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded at the time of payment to participants.

Income Tax Status

The plan sponsor adopted a volume submitter 401(k) plan document which obtained a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated the form of the Plan was acceptable under the applicable requirements of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not received a determination specific of the Plan itself. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Generally accepted accounting principles (GAAP) requires Plan management to evaluate tax positions taken and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The Plan deems all participant notes receivable to be fully collectible; therefore, no allowance for uncollectible accounts is required. Participant notes receivable are treated as distributions when they are determined to be uncollectible.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 23, 2025, the date in which the financial statements were available to be issued.

NOTE C | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE D | INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AND CUSTODIAN

Principal Trust Company (Trustee) and Principal Life Insurance Company (custodian) have certified the completeness and accuracy of certain information used by management to prepare the financial statements, supplemental schedule and accompanying notes. Accordingly, this information was not audited. The following is a summary of the information which was furnished by the trustee and custodian.

NOTE E | FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds classified in Level 1 are valued at net asset value (NAV) of shares held by the Plan at year end. NAV represents the sum of the underlying investments and represent the price at which the funds are traded on active markets.

Pooled separate accounts classified in Level 1 consist mainly of investments reported at quoted prices for similar assets in active or non-active markets. The net asset value (NAV) of a separate account is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the pooled separate accounts can be redeemed at NAV as of the measurement date. Therefore, the pooled separate accounts are considered to have a “readily determinable fair value.”

Common collective trust funds (CCTF) are classified in Level 1 and consist of a variety of underlying investments that do not have publicly quoted pricing inputs. The fair value of the underlying investments are used in determining the NAV of the CCTFs, which is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the CCTFs can be redeemed at NAV as of the measurement date. Therefore, the CCTFs are considered to have a “readily determinable fair value.”

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F | GUARANTEED INVESTMENT CONTRACT

The Plan maintains a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$690,395 and \$758,505 at December 31, 2024 and 2023, respectively. Principal maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdraws and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdraws and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic or regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the plan’s prohibition on competing investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan’s normal operations; (4) the failure of the Plan to qualify under 401(a) of the IRC or the failure of the trust to be tax exempt under section 501(a) of the IRC; or (5) premature termination of the contract. The plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issue to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreements without the consent of the issuer.

NOTE G | RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan incurs expenses related to general administration. Participant accounts may be charged for some or all of these expenses. All fees not charged to Participants will be paid by the Company and are not included in these financial statements. Administrative costs of the Plan totaling \$10,000 and \$9,000 for the years ended December 31, 2024 and 2023, respectively, and were paid directly by Osborn & Barr Communications, Inc. These transactions qualify as party-in-interest transactions as defined by ERISA.

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Principal Trust Company, the Plan's trustee, is an affiliate of Principal Financial Group, which manages certain plan investment options. These transactions qualify as party-in-interest transactions and are denoted as such on the Supplemental Schedule of Assets (Held at End of Year).

NOTE H | PROHIBITED OR NON-EXEMPT TRANSACTIONS

As of December 31, 2024, the Plan Sponsor was in the process of working with the Plan's third party administrator to correct immaterial operational errors related to deferral and matching contributions for a limited number of employees during 2024. The corrections will be self-corrected by the Plan in 2025.
