As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS December 31, 2024 and 2023

(1) Description of Plan

The following description of the Hawthorne Residential Partners 401(k) Profit Sharing Plan and Trust ("Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- (a) **General** - The Plan is a qualified defined contribution plan covering all employees of Hawthorne Residential Partners ("Company") who are at least 21 years of age with two months of eligible service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). All investments are participant directed.
- (b) **Contributions** - Participants may contribute, through payroll deduction, amounts up to 92% of their annual earnings, subject to certain limitations. Participants have the option of making after-tax contributions to a Roth account and participants who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions. In April of 2023, the Company increased its match to an amount equal to 75% of up to the first 3% of participants' compensation. Prior to that, the Company's match was 50% of up to the first 3% of participants' compensation. In April of 2023, the Company increased its additional match to an amount equal to 75% of the first 6% of participants' compensation after 5 years of service. Prior to that, the Company's additional match was 50% up to the first 5% of participants' compensation after 5 years of service. In addition, the Company may make discretionary profit-sharing contributions; however, none were recorded in 2024 or 2023.
- (c) **Participant Accounts** - Each participant's account is credited with the participant's contributions, and allocations of the Company's contributions, Plan earnings (losses), Plan forfeitures and administrative fees. Allocations are based on participant earnings or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
- (d) **Vesting** - Participants are immediately vested with respect to their elective deferral contributions and actual earnings thereon. Vesting in matching employer contributions and actual earnings thereon is based on years of continuous service. A participant is 25% vested after one year and vests an additional 25% every year thereafter, until reaching 100% after four years of credited service.
- (e) **Forfeitures** - Forfeitures of employer matching contributions are used to pay Plan expenses, reduce employer contributions and can also be reallocated to participant's accounts as additional contributions. During 2024 and 2023, forfeitures of \$61,057 and \$46,485, respectively, were used to pay Plan expenses. Forfeitures of \$236,897 and \$135,886 were also used to reduce employer contributions during 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$110,233 and \$104,349, respectively.
- (f) **Payment of Benefits** - In the event of termination of employment, disability, death or retirement (age 65), a participant may elect to receive benefits either by a lump sum distribution or periodic installments over a period of time as described in the Plan Agreement. Distributions of vested account balances of \$1,000 or less will generally be made in a single sum payment. The Plan may make automatic rollovers of vested account balances that are greater than \$1,000 but are not more than \$5,000 in accordance with the Plan Agreement.

- (g) **Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or a maximum equal to 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans funds. Loan terms are based on a five-year term, or longer for the purchase of a primary residence. The loans must be adequately secured and bear interest at the then current prime rate (7.50% at December 31, 2024) plus 1%. Principal and interest are paid through bi-weekly payroll deductions.
- (h) **Plan Termination** - The Company expects to continue the Plan indefinitely but reserves the right to terminate the Plan in whole or in part at any time upon giving written notice to all parties concerned subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Summary of Accounting Policies

- (a) **Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.
- (b) **Management Estimates** - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- (c) **Investment Valuation** - The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment changes includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (d) **Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement.
- (e) **Excess Contributions Payable** - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability and are included as an offset against contributions.

(3) Information Certified by the Custodian

The investment assets and investment income information in the statements of net assets available for benefits and changes in net assets available for benefits, as well as the Schedule, were summarized from information supplied and certified by the custodian, Empower Annuity Insurance Company of America. The information obtained from the custodian was not audited by independent public accountants as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA.

(4) Fair Value Measurements

FASB ASC 820, Fair Value Measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable and Level 3 inputs have the lowest priority and are unobservable inputs of market activity. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common collective trust funds:* Valued at the NAV of units of a financial institution collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

(5) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(6) Tax Status

The Plan is based on a CCH Incorporated ("CCH") prototype non-standardized profit-sharing plan. The Internal Revenue Service ("IRS") has determined and informed CCH on March 31, 2014 that the Plan is in compliance with the applicable requirements of the Internal Revenue Code. The plan has been amended since receiving this letter. However, the Plan trustees and administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan, by expiration of the statute of limitations, is generally no longer subject to U.S. federal and state income tax examinations by tax authorities for the years ending December 31, 2021 or earlier.
