Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Christian Benevolent Outreach, Inc. d/b/a Sayre Christian Village (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan for Christian Benevolent Outreach, Inc. d/b/a Sayre Christian Village's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the 403(b) Thrift Plan for Christian Benevolent Outreach, Inc. d/b/a Sayre Christian Village provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of Christian Benevolent Outreach, Inc. d/b/a Sayre Christian Village, Sayre Christian Village Nursing Home, Inc. and Sayre Christian Village Phase III d/b/a Friendship Towers (collectively, Employer). There is no minimum age or service requirement to make salary reduction contributions to the Plan. A participant must be 21 years of age and complete at least one year of service (1,000 hours) in order to receive an employer matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer's Board of Directors is responsible for the oversight of the Plan.

Contributions:

The Plan is funded by participant salary reduction contributions and an employer matching contribution. Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, subject to the maximum permitted by law. Participants are also eligible to make Roth deferral contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans or 403(b) plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

For all participants, except highly compensated participants, the Employer makes a matching contribution equal to a percentage of the salary reduction amount contributed that does not exceed a percentage of compensation. The matching contribution is based on years of service as follows:

<u>Years of Service</u>	<u>Percentage of Salary Reduction Contributions</u>	<u>Percentage of Compensation</u>
Less than 5 years	25%	5%
5 years or more	50%	5%

Highly compensated employees receive the lower matching percentage of compensation regardless of years of service. Contributions are subject to certain IRS limitations.

NOTES TO FINANCIAL STATEMENTS

Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of the employer matching contribution, plan earnings and administrative expenses. Allocations are based on participant contributions, compensation or account balances, as defined in the plan provisions. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Vesting:

Participants are immediately vested in their elective contributions, as well as earnings on those contributions. Vesting in the employer matching contribution portion of their accounts and earnings on those contributions is based on the years of service as outlined in the following table:

Less than 1	0%
1	20%
2	40%
3	60%
4	80%
5 years or more	100%

Participants will also become fully vested in the employer matching contributions account upon reaching age 55, becoming totally and permanently disabled, or death.

Forfeited accounts:

Forfeitures are utilized to reduce future employer contributions. Employer contributions were reduced by \$1,234 and \$111 for the years ended December 31, 2024 and 2023, respectively, from forfeited nonvested accounts. There were no unallocated forfeited nonvested accounts at December 31, 2024. At December 31, 2023, unallocated forfeited nonvested accounts totaled \$169.

Payment of benefits:

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or monthly installments over a fixed period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

NOTES TO FINANCIAL STATEMENTS

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are held in a group annuity contract and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of the Plan are charged directly to the participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

NOTES TO FINANCIAL STATEMENTS

Contributions:

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Subsequent events:

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information in the accompanying financial statements and supplemental schedules related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, a qualified institution.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active or inactive markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTES TO FINANCIAL STATEMENTS

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Separate accounts have been valued using a market approach. The general account has been valued using a cost approach. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

General account - fair value is determined by the insurance company as of the close of business on each valuation day based on the contributions made to the account, plus interest at the contract rate, less benefits paid to participants and administrative expenses charged by the insurance company.

Separate accounts - fair value of accumulation units is determined by the insurance company as of the close of business on each valuation day based upon the net asset values of the underlying mutual fund shares which are actively traded and separate account charges under the contract.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments Measured Using Net Asset Value Per Share Practical Expedient

All separate accounts have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' net asset value (NAV). The NAV is updated daily.

A description of the investment strategies for separate accounts whose value is derived using NAV are as follows:

Equity funds - seek long-term growth of capital by investing majority of assets in a diversified portfolio of common stocks.

Fixed income funds - seek total return by investing majority of assets in a diversified portfolio of fixed income securities.

Retirement funds - seek current income and capital appreciation appropriate for the asset allocation associated with its target retirement date by investing assets in a diversified portfolio of funds balanced to meet the current target retirement date of the fund.

Asset allocation funds - seek long-term growth of capital by investing assets in a diversified portfolio of equity and fixed income securities.

NOTES TO FINANCIAL STATEMENTS

Real estate investment trust fund - seeks to provide a high level of income and moderate long-term capital appreciation.

Balanced funds - seek long-term growth of capital by investing assets in a diversified portfolio of equity, debt and fixed income securities.

Note 5. Related Party Transactions and Party-In-Interest Transactions

The Plan invests in a group annuity contract sponsored by Mutual of America Life Insurance Company (Mutual of America). Transactions with Mutual of America qualify as party-in-interest transactions. Fees paid by the Plan for administrative services and termination fees, deducted from participant accounts in accordance with the plan document, totaled \$902 and \$326 for the years ended December 31, 2024 and 2023, respectively. Fees incurred by the Plan for investment management services are included in net appreciation and are deducted from participant accounts in accordance with the plan document. The Employer pays directly other fees related to the Plan's operations.

Certain administrative functions are performed by officers or employees of the Employer. No officer or employee receives compensation from the Plan.

Note 6. Prohibited Transactions

During 2024, the Employer did not remit to the Plan certain employee contributions totaling \$26,836 within the period prescribed by the Department of Labor regulations. The Employer will compute the estimated lost income due to the delay and will make a contribution for the lost income to the affected participants' accounts.

During 2023, the Employer did not remit to the Plan certain employee contributions totaling \$18,756 within the period prescribed by the Department of Labor regulations. The Employer made a contribution for the lost income to the affected participants' accounts during 2024.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants would become 100 percent vested in their employer contributions.

NOTES TO FINANCIAL STATEMENTS

Note 8. Income Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the terms of the Plan have been prepared to conform with the requirements of Section 403(b) of the IRC, and is currently being operated in conformity with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 10. Reconciliation of Financial Statements to Form 5500

The Plan holds investments in pooled separate accounts, which are not direct filing entities. As such, per Form 5500 instructions, the Plan's interest in the underlying assets of the pooled separate accounts must be allocated and reported in the appropriate categories on Schedule H. Therefore, these investments are reflected as mutual funds on Form 5500, but as pooled separate accounts for financial statement purposes.
