INDEPENDENT AUDITOR'S REPORT

Participants and the Plan Administrator of
Community Hospital of San Bernardino Tax Sheltered Annuity Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Community Hospital of San Bernardino Tax Sheltered Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. Description of plan

The following description of the Community Hospital of San Bernardino Tax Sheltered Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Copies of the Plan document are available from the Human Resources Department.

General

The Plan was established on August 1, 1985 for employees of Community Hospital of San Bernardino (the "Company", "Plan Sponsor" or "Plan Administrator"). The Plan provides for benefits in the event of retirement, death, disability, and financial hardship. The plan was frozen effective January 1, 1999 and additional employee and employer contributions into the Plan are no longer permitted.

Participant accounts

Each participant's account is: (a) credited with their investment income and gains/losses, and (b) charged with an allocation of administrative expenses as provided for in the Plan document. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

Vesting

Plan vesting under the established Plan was based on a five-year graded vesting schedule. Effective January 1, 2005 the Plan was amended to state that participants are 100% vested immediately and no forfeitures shall arise under the Plan.

Notes receivable from participants

Participants may borrow from their respective accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Participants' promissory notes are secured by the balance in the participant's account and bear interest at rates that range from 3% to 4.50%. Notes receivable are for fixed terms, requiring regular repayments directly to the trustee. Principal and interest are paid ratably through monthly payroll deductions.

Termination provisions

The Plan has been frozen with respect to new participants and contributions. Participants became fully vested in their accounts effective January 1, 2005. Participants' accounts will continue to receive increases or decreases as determined by the value of the investments under the trust agreement until participants receive a full distribution of their account balance.

Administration of the plan

A Plan Administrator, who is appointed by the Plan Sponsor's Board of Directors, administers the Plan.

Benefit payments

The Plan's policy is to make benefit payments under one of the following methods: (a) a single lump-sum cash distribution, (b) purchase of an annuity, or (c) installments over a specified period of time.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

2. Significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

Withdrawals

Participants may request hardship withdrawals from their account balance for certain financial needs, as defined in the Plan documents.

Investment valuation and income recognition

The Plan's fixed accounts are valued at contract value and mutual fund investments are stated at fair value as determined by quoted market prices. Shares of mutual funds are valued at quoted market prices which represent net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Information certified by the trustees

The Plan's investments are held by VALIC and Lincoln National Life Insurance Company (the "trustees") in separate trust funds. The following is a summary of the information included in the Plan's financial statements that was prepared by the trustees and furnished to the Plan Administrator. The trustees have certified that such information is complete and accurate.

4. Tax status

The Plan adopted a prototype plan document and has not obtained an Internal Revenue Service (“IRS”) opinion letter as of December 31, 2024. The terms of the Plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service. The Plan is in process of awaiting its determination letter of the prototype plan and the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable tax-exempt requirements of the Internal Revenue Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for the plan participants under Section 403(b). Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

5. Risk and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

6. Fixed accounts

The Portfolio Director Group Fixed and Variable Deferred Annuity Contract (“Valic fixed accounts”) are fully-benefit-responsive group annuity contracts issued by VALIC totaling \$2,026,185 and \$2,134,742 as of the years ended December 31, 2024 and 2023, respectively. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. These investment contracts are presented on the Plan’s financial statements for the years ended December 31, 2024 and 2023, at contract value. The Valic fixed accounts do not contain any type of market value formula or provision. Participant distributions are paid at contract value.

The Valic fixed accounts are group annuity contracts with a fixed rate of interest. The minimum guaranteed interest rate varies by participant and depends on the date the participant established his or her account. Participant accounts set up before December 1, 2003 have a minimum guaranteed interest rate of 3.00%. The minimum guaranteed interest rate for accounts set up on or after December 1, 2003 is 2.00%. Under the terms of the contract, the average yield of the funds and the crediting yield is one and the same, and the rates reset periodically throughout the year.

6. Fixed accounts (continued)

The Plan also has fixed accounts issued by The Lincoln National Life Insurance Company (“Lincoln fixed accounts”) totaling \$667,719 and \$657,596 as of the years ended December 31, 2024 and 2023, respectively. Funds in these accounts are shown at contract value on the financial statements. Participant accounts have a minimum guaranteed interest rate of 4.00%. Funds in the accounts can be withdrawn without a surrender charge or a market value adjustment and the accounts do not have a maturity date.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the trustees, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

7. Fair value measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Mutual funds*: Valued at the net asset value ("NAV") of shares held by the Plan at the close of each business day as reported by each fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

8. Related party transactions and party in interest transactions

Certain Plan investments are shares of mutual funds managed by VALIC and Lincoln National Life Insurance Company. VALIC and Lincoln National Life Insurance Company are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

9. Commitment and contingencies

Plan management noted that the funds held by VALIC and Lincoln National Life Insurance Company included forfeited amounts. Since Plan participants are 100% vested, the forfeited accounts should have been allocated to all participants effective January 1, 2005. Plan management has filed and received approval under a Voluntary Correction Program ("VCP") with the IRS. Plan management is working to determine the affected participants and then determine the proper allocation. In addition, Plan management is in the process of determining the total loss of earnings due to participants. Once that amount can be determined, that amount will be remitted to the Plan and included in the allocation to the respective participants. Additional amounts due to participants will be provided by the Plan Sponsor. No liability has been recorded at December 31, 2024 and 2023, as the amount, is not currently determinable.

10. Subsequent events

Management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.
