#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Mount Airy #1, LLC Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

#### NOTE 1 Description of Plan

The following description of the Mount Airy #1, LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was created on February 1, 2008 and is a participant-directed defined contribution plan covering most regular employees of the Company who elect to participate and who have met certain requirements as to length of service and age, as defined. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA), as amended. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Owner Managing Trustee.

#### Plan Sponsor

Mount Airy #1 LLC, d/b/a Mount Airy Casino Resort (the Company) is a casino and resort in the Pocono Mountains of Northeastern Pennsylvania.

#### Employee Contributions

Each plan year, participants may elect to make pre-tax or Roth elective deferrals in amounts ranging from 1% to 100% of eligible earnings, in increments of 1%. Participants direct the investment of their contribution into various investment options offered by the Plan. Each participant's contribution is allocated to available investment options according to the percentages specified by the participants. Employee contributions were limited to \$23,000 in 2024. Employees who attained the age of fifty (50) by the end of the year had the option to take a catch-up contribution of \$7,500 in 2024. Contributions are subject to certain IRS limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant.

#### Employer contributions

The Company has the ability to make a discretionary matching contribution equal to a percentage of participant's elective deferrals. In 2024, the match was based on 25% of employee contributions, up to 6%. In addition, the Company may make a profit-sharing contribution to the Plan each year. The eligibility requirement to receive the profit-sharing contribution is specified in the Plan document. The Company will determine the percentage amount of contribution on a yearly basis. There were no discretionary profit-sharing contributions in 2024. The Company contributed \$347,029 to the Plan in 2024.

#### Rollover contributions

Participants may make rollover contributions to the Plan from an eligible account, as defined in the Plan document.

### Participant accounts

Each participant's account is credited with the participant's contributions, including rollovers, and Company matching contributions, as well as allocations of the Plan earnings and losses and discretionary profit-sharing contributions, if any, made by the Company. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are always 100% vested in their elective deferral, rollover and voluntary after-tax contributions plus actual earnings thereon. The following vesting schedule, based on a participant's years of service, applies to employer matching contributions and discretionary profit-sharing contributions:

### Payment of benefits

During employment, a participant may make withdrawals of amounts applicable to employee and vested employer contributions, subject to certain restrictions, as defined under the Plan. Participants are entitled to withdraw funds, exempt from excise tax, upon attaining age 59 ½ or for financial hardship before that age. Participants may qualify for financial hardship withdrawals if they have an immediate and substantial financial need, as defined by the Plan document.

All benefits could be paid to participants upon termination of service due to death, disability, retirement or other reasons, as defined, in the form of a lump sum payment or in installments. If a terminated participant has a vested account balance of less than \$1,000, the entire balance is automatically distributed to the participant. If a terminated participant has a vested account balance of \$1,000 or greater but less than \$7,000, the Company may rollover the entire balance into an Individual Retirement Account in the participant's name. A terminated participant with a vested balance in excess of \$7,000 may choose to leave his or her account balance in the Plan until the terminated participant reaches the required minimum distribution age.

### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000. The loans are secured by the participants' vested account balance. The loans bear interest equal to the prime rate as published in *The Wall Street Journal* at the time the loan is taken, plus one (1%) percentage point, and are stated at unpaid principal balance plus accrued interest. Principal and interest are paid ratably through payroll deductions.

#### SECURE 2.0 Act

President Biden signed the Consolidated Appropriations Act (CAA), including the SECURE 2.0 Act, into law on December 29, 2022. SECURE 2.0 builds on changes made by the SECURE Act of 2019 and the Plan document has been amended for provisions required to be effective in 2024 and will be amended in accordance with the required timeline of the act to meet the applicable provisions effective after December 31, 2024.

#### NOTE 2 Summary of significant accounting policies

##### Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

##### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

##### Risk and uncertainties

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially effect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Investment valuation and income recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date-basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract issued by John Hancock as trustee totaling \$172,188 and \$344,638 at December 31, 2024 and 2023, respectively. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 1.00%. The credit rate is reviewed on a semi-annual basis for resetting. The fixed income guaranteed option contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value with John Hancock.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

The Plan administrator does not believe that any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### Payment of benefits

Benefits are recorded when paid.

#### Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$314,267 and \$234,173, respectively. These accounts may be utilized for certain administrative expenses or to reduce future employer contributions. In 2024, \$11,992 was used to pay administrative expenses of the Plan.

#### NOTE 3 Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Investment advisory and management fees are also included in administrative expenses. Administrative expenses paid by the Plan amounted to \$136,667 for the year ended December 31, 2024.

#### NOTE 4 Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, LLC, the trustee of the Plan.

#### NOTE 5 Participant contributions

As of and for the year ended December 31, 2024, the employer remitted to the third-party administrator all participant contributions to the Plan in a timely manner.

### NOTE 6 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs used in determining valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment company (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

**NOTE 7 Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all interests of participants will become 100% vested in their employer contributions.

**NOTE 8 Related party and party in interest transactions**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The following transactions represent party in interest transactions to the Plan.

- Mutual funds and guaranteed interest fund: Investment options include John Hancock mutual funds and a guaranteed interest fund. The fair value and contract value of these investments was \$12,162,636 and \$172,188, respectively, at December 31, 2024. The fair value and contract value of these investments was \$10,966,196 and \$344,638, respectively at December 31, 2023.
- Notes receivable from participants: The Plan accepts and services loans to Plan

participants as described in Note 1. Notes receivable from participants totaled \$659,641 and \$663,508 as of December 31, 2024 and 2023, respectively.

- Administrative fees: Administrative fees, including amounts paid to the Plan administrators and trustees, were \$136,667 for the year ended December 31, 2024. The Company may pay certain fees and expenses of the Plan.

Plan investments were managed by the trustee (See Note 4) as defined by the Plan and, therefore, these transactions qualify as party in interest transactions.

The aforementioned trustee provided certain administrative services to the Plan pursuant to service agreements between the Company and the trustee. The trustee received revenue from mutual fund service providers for services they provided to the funds. This revenue was used to offset certain amounts owed to the trustee for its administrative services to the Plan.

Certain administrative functions are performed by officers or employees of the Company with no compensation from the Plan.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

#### NOTE 9 Tax status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 10 Subsequent events

The Plan has evaluated subsequent events through October 2, 2025, which is the date these financial statements were available to be issued.
