We have performed audits of the accompanying financial statements of the Pension Plan for Direct Labor Employees, (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. Description of Plan

Effective January 1, 1999, The New York City Chapter of NYSARC, Inc. (the “Employer”), adopted the Pension Plan for Direct Labor Employees (the “Plan”). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a non-contributory defined contribution plan sponsored and administered by the Employer for the benefit of hourly employees included in the Employer’s direct labor program. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Empower Life & Annuity Insurance Company of New York (formerly Prudential Retirement Insurance and Annuity Company) and Empower Trust Company, LLC are the trustees of the Plan.

Eligibility

All hourly employees in the direct labor program will automatically become a participant in the Plan on the first day of the month on or after their date of employment.

Contributions

Contributions to the Plan are made by the Employer in accordance with a specified formula based on a specified dollar amount of contribution for each hour of service for an employee in the applicable period.

Participant Accounts

Each participant’s account is credited with the Employer’s contribution and an allocation of investment earnings (losses). Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account. The investments allocated to participant accounts are directed by the Employer.

Vesting

Participants are immediately vested in the Employer’s contribution to their accounts.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant (“borrower”) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of the lesser of 50% of their vested account balance or \$50,000. The maximum number of outstanding plan loans a participant may borrow is one. The plan administrator will establish a reasonable rate of interest for all Plan loans. Loans are repayable through periodic payroll deductions. Principal and interest are paid ratably through payroll deductions.

1. Description of Plan (*continued*)

Payments of Benefits

Upon termination of service due to death, disability, retirement or other reason, or due to financial hardship a participant is entitled to receive a distribution in the amount equal to the value of the participant's interest in his or her account.

Upon continuing employment with the Employer after the age of 73, a participant can start their distributions at age 73 or delay their distributions until as late as the April 1 after the calendar year in which they retire. A participant may withdraw all or a portion of rollover contributions at any time. Hardship withdrawals are permitted under certain circumstances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis which is a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). Under this basis, investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP.

Use of Estimates

The preparation of financial statements requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

2. Summary of Significant Accounting Policies (*continued*)

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the guaranteed investment contract and the stable value contract, which are valued at contract value since they are fully benefit-responsive. The guaranteed investment contract and the stable value fund are valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price and are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal. Delinquent notes receivable from participants are recorded as deemed distributions.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Administrative expenses are paid by either the Plan or the Employer, as provided by the Plan's provisions. Investment transaction fees are included as reductions to the net appreciation in fair value of investments which are allocated to each participant's account.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 9, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividend income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York (collectively "Empower"), qualified institutions.

4. Investments, at Contract Value

Empower Guaranteed Long-Term Account

The Plan invests in the Empower Guaranteed Long-Term Account (the “Account”) which is a group annuity product issued by Empower Life & Annuity Insurance Company (“Empower Retirement”) and is fully benefit responsive. Empower Retirement maintains the contributions in a general account, which is credited with earnings and charged with participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Empower Retirement is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with Empower Retirement. Such interest rates are announced in advance and guaranteed for a six-month period.

MetLife Stable Value Solutions IV

During 2024, the Plan invested in the MetLife Stable Value Solutions IV Fund (the “Stable Value Fund”). The Stable Value Fund is maintained by Great Gray Trust Company and invests in a group annuity contract issued by Metropolitan Tower Life Insurance Company. It seeks principal stability, liquidity and a competitive yield. Plan level withdrawals generally require 12 months notice.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

5. Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

6. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated November 14, 2022 from the Internal Revenue Service (“IRS”) stating that the Plan is designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

6. Tax Status *(continued)*

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-In-Interest Transactions

Certain investments are managed by Empower. Empower are the trustees as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

The Plan and Empower Annuity Insurance Company have entered into a revenue sharing arrangement whereby a portion of the revenue earned by certain funds is passed through to the Plan for payment of permitted plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay plan expenses, the Company created the ERISA Account. The ERISA Account is invested in the Prudential Guaranteed Long Term Account, similar in design to forfeiture accounts, and is used to record keep the redistribution of plan-generated fund revenue that exceeds the costs associated with plan administration. The ERISA Account balance was \$86,091 and \$64,809 at December 31, 2024 and 2023. During 2024, administrative expenses incurred by the Plan were reduced by \$31,172 from the ERISA account.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
