### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

**1. Summary of Significant Plan Provisions**

The following description of the NADC 403(B) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for the benefit of the employees of Northcentral Arkansas Development Council, Inc. (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

Each employee, who is a common law employee expected to work at least 1,000 hours during the plan year when hired is eligible upon employment, others are eligible to participate in the Plan at the next entry date that coincides with the completion of one year of service during which 1,000 hours or more of service is rendered.

Contributions

Participants may elect to contribute through payroll deductions and may make eligible rollover contributions. Participants may elect to contribute 1% to 100% of their compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants initially have their deferral rate set at 1% of eligible compensation. The Employer contributes 200% of a participant’s contribution during the plan year that does not exceed 5% of their compensation received during the plan year. Additional profit-sharing amounts may be contributed at the option of the Employer’s board of directors. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Employer’s contributions and (b) Plan earnings/losses and is charged with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant compensation, contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting Rights

Participants are, at all times, fully vested with respect to their contributions, safe harbor contributions and rollover contributions plus earnings/losses thereon. Vesting in the Employer’s contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service according to the following schedule:

Forfeitures

The portion of a participant's account to which they are not entitled as a result of being less than fully vested shall be forfeited by the participant upon termination. Forfeitures are used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, \$2,811 and \$3,238 were used to reduce employer contributions, respectively.

Payment of Benefits

Upon retirement, death, disability or termination, a participant may elect to receive a lump sum or various annuity options in amounts equal to the value of the participant's vested interest in their account. Balances under \$7,000 are distributed to participants upon termination from employment. These distributions may be rolled over to another plan, or taken outright at the discretion of the participant.

Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value with the exception of the general account which is considered by the Plan's management as comparable to a cash equivalent and therefore exempt from classification under ASC 820-10. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The fair values of the registered investment company accounts (mutual funds) are computed using closing prices; on nationally recognized stock exchanges or over-the-counter markets. Fair value of shares of the underlying fund equals the number of shares of the respective underlying fund multiplied by the closing net asset value per share quoted by that fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

During the year ended December 31, 2024, certain administrative expenses of the plan were voluntarily paid by the Employer. Expenses paid by the Employer are excluded from these financial statements.

**3. Investments**

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Mutual of America, the custodian of the Plan for the year ended December 31, 2023 and by The Standard Insurance Company, the custodian of the Plan for the year ended December 31, 2024, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplementary schedule:

- a. Total investments as shown in the accompanying statement of net assets available for benefits of \$1,805,388 and \$2,659,133 as of December 31, 2024 and 2023, respectively.
- b. Total change in fair value of investments as shown in the accompanying statement of changes in net assets available for benefits of \$173,136 for the year ended December 31, 2024.
- c. All investment transactions that occurred during the Plan years ended December 31, 2024.
- d. All information included in the supplemental schedule.

**4. Concentration of Investments**

At December 31, 2024 and 2023, four investments and one investment within the Plan, respectively, represented more than 10% of the Net Assets Available for Benefits. These investments represented approximately 68% and 40% of the Net Assets Available for Benefits, respectively.

**5. Fair Value Measurements**

Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical

assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs. There have been no changes to the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* These instruments are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*General account:* These instruments are valued at fair value as reported by the Plan Custodian, investments in the general account are liquid and not subject to any form of interest rate adjustment. Amounts held in the general fund are considered comparable to interest bearing cash equivalents.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **6. Tax Status**

The prototype plan document the Plan is utilizing received an opinion letter dated March 31, 2017, in which the Internal Revenue Service (“IRS”) stated the document is designed in accordance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan was most recently amended effective September 1, 2023. As permitted by the IRS, the Plan is relying on the opinion letter on the prototype plan document for its own qualification. Although the prototype plan document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. Federal and state income tax statutes dictate that tax returns filed in any of the previous three reporting periods remain open to examination. Currently, the Plan has no open examinations with either the Internal Revenue Service or state taxing authorities.

**7. Party-in-Interest Transactions**

Standard Insurance Company is the custodian of the Plan. During the year ended December 31, 2024, the Plan had investments of \$375,992 held by Standard Insurance Company. Standard Insurance Company holds the Plan's investment assets and executes investment transactions. Since Standard Insurance Company serves as the custodian of the Plan's assets, Standard Insurance Company is by definition a party-in-interest and, as a result, the investments and transactions pertaining to the investments are with a party-in-interest.

All of these transactions are exempt from being prohibited transactions by ERISA.


