## **INDEPENDENT AUDITORS' REPORT**

**The Plan Administrator**  
**McNaughton-McKay Electric Company**  
**401(k) and Profit-Sharing Plan**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of the McNaughton-McKay Electric Company 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the McNaughton-McKay Electric Company 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 2(b) to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the McNaughton-McKay Electric Company 401(k) and Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about McNaughton-McKay Electric Company 401(k) and Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of McNaughton-McKay Electric Company 401(k) and Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about McNaughton-McKay Electric Company 401(k) and Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### 1. DESCRIPTION OF THE PLAN

The following description of the McNaughton-McKay Electric Company 401(k) and Profit-Sharing Plan (the Plan) is provided for general information purposes only. Reference should be made to the plan agreement for a more complete description of the Plan's provisions.

#### (a) GENERAL

The Plan is a defined contribution plan covering eligible employees of the Company. Employees who are 18 years old, become eligible to participate in the 401(k) plan on the first day on the month following the completion of 1/12 of a year of service. Employees are generally eligible for employer profit-sharing contributions after one year of service, providing they worked at least 1,000 hours during such plan year, including the last day of the plan year, and have reached age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### (b) PARTICIPANT CONTRIBUTIONS

The Plan is a defined contribution plan intended to qualify as a profit-sharing plan under Section 401(k) of the Internal Revenue Code. The Plan allows eligible employees to contribute up to 70% of their annual compensation, not to exceed limitations established by the Internal Revenue Service. Salary deferral contributions are contributed to the Plan through regular payroll deductions. The participants may elect the percentage of his or her contribution to be allocated into various investment options offered by the Plan.

#### (c) EMPLOYER CONTRIBUTIONS

The Company may make a discretionary contribution to the Plan in such amount as determined by the Company's board of directors. The participant may elect the percentage of the employer's contribution to be allocated into various investment options offered by the Plan.

Employer contributions for 2024 and 2023 were \$10,369,529, and \$9,913,412, respectively

#### (d) PARTICIPANT ACCOUNTS

Each participant's account is credited with his or her contributions, an allocation of Company contributions, plan earnings, and forfeitures. Allocations are based on participant compensation or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(e) VESTING**

Vesting of Company contributions is based on the following table:

A participant is credited with one vesting year for each plan year in which 1,000 or more hours of service have been accrued.

**(f) PAYMENTS OF BENEFITS**

Distributions to participants or their beneficiaries are allowed upon attainment of age 59-1/2, disability, death, termination of service or hardship. Distributions are made in the form of a lump-sum payment. Fees for expedited distributions, if any, are incurred by the participant.

**(g) HARDSHIP WITHDRAWALS**

Participants are permitted to make hardship withdrawals from the vested portion of their account if the Plan's Investment Committee determines that such withdrawals are permitted under the provisions of the Plan. Employees taking a hardship withdrawal may not make salary deferral contributions to the Plan for a period of six months following the receipt of the hardship distribution. Any withdrawals are subject to taxation and federal withholding requirements. Fees for expedited withdrawals, if any, are incurred by the participant.

**(h) ADMINISTRATIVE EXPENSES**

All costs of plan administration, such as investment fees and expenses, and other administrative expenses, are paid by the Company.

**(i) FORFEITURES**

Any balance in the account of a participant who has separated from service to which he or she has no vested interest, pursuant to the application of the vesting schedule, will be held in a forfeiture suspense account and reallocated to the eligible participants in the ratio in which their compensation for the plan year bears to all participants' compensation for the plan year. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$248,061 and \$154,724, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**(a) BASIS OF PRESENTATION**

The accompanying financial statements are presented on the accrual basis of accounting, such that all income, benefits, and expenses are recognized in the period to which they relate.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**(b) INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by Erisa Section 103(a)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A. (the "Trustee") has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Investment activity, as shown in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year), as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**(c) VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**(d) USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**(e) PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**3. MANAGEMENT OF TRUST FUND**

Under the terms of a trust agreement between Bank of America, N.A. and the Plan, Bank of America, N.A. is the trustee of the Plan. The investments and changes therein have been reported to the Plan by the trustee as having been determined through the use of fair values for all assets and liabilities of the trust fund.

**4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company may amend or terminate the Plan upon written notice to the trustee and the plan administrator. Amounts credited to participants' accounts become 100% vested upon termination of the Plan.

**5. RELATED PARTY TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by Bank of America, N.A. Bank of America, N.A. is the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

### 6. TAX STATUS

The Internal Revenue Service has determined and informed the company in a letter dated September 7, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The determination letter is applicable for all plan amendments through December 6, 2016. The plan administrator and the Plan's tax counsel do not anticipate that changes in the Plan since the December 6, 2016 amendment will affect the qualified and tax-exempt status of the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for Plan benefits.

### 8. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

  - **inputs that are derived principally from or corroborated by observable market data by correlation or other means.**

**If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.**

- Level 3**            **Inputs to the valuation methodology are unobservable and significant to the fair value measurement.**

**The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.**

**The following is a description of the valuation methodologies used for assets measured at fair value:**

**Mutual funds are valued at the net asset value (NAV) of shares held by the plan at year end.**

**Common collective trusts are valued based on the closing market price report on the active market on which the underlying investments are traded.**

**Money market funds approximate their fair values based on their short-term nature.**

**The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.**
