Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

## 1. Description of the Plan

The following description of Imperial Electronic Assembly, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

### **General**

The Plan is a defined contribution plan covering all employees of Imperial Electronic Assembly, Inc. (the "Company" or "Employer") who have reached the age of twenty-one, completed 90 days of service and are not covered by a collective bargaining agreement. Non-resident aliens who receive no compensation from the Employer which constitutes U.S. source income are also not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### **Contributions**

Participants may contribute a specific portion (up to 100%) of their annual eligible compensation, as defined in the Plan document, on a pre-tax or Roth basis, up to the maximum allowed by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions to the Plan as defined under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is required to return excess contributions received during the Plan year in excess of IRC limits.

Participants are eligible for Company contributions beginning on either January 1 or July 1 upon the completion of one year of service.

The Company contributes a safe harbor employer contribution equal to 3% of eligible compensation for each active eligible participant. Participants are 100% vested in these contributions.

The Company may, at the discretion of management, contribute additional profit-sharing amounts to the Plan. Participants will be eligible to receive profit-sharing contributions regardless of how many hours they worked during the year or whether they were terminated during the year. All investments are self-directed by individual participants. The Company elected to make a \$184,660 profit sharing contribution in 2024.

The Company may, at the discretion of management, contribute additional matching contributions to the Plan. If elected, a discretionary amount determined by the Company will be applied in a uniform manner for all eligible participants for the Plan. Participants will be eligible to receive matching contributions regardless of how many hours they worked during the year or whether they were terminated during the year. The Company elected not to make any matching contributions in 2024.

## 1. Description of the Plan *(continued)*

### ***Participants' Accounts***

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and plan earnings or losses and administrative expenses. Allocations are based on a participant's earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the vested portion of their account.

### ***Vesting***

Participants are immediately vested in their contributions, including rollovers, as well as the Company's safe harbor contributions plus earnings thereon. Vesting in the Company's matching and profit-sharing contributions are based on years of continuing service as follows:

4	60%

6 or more	100%

### ***Notes Receivable from Participants***

The Plan allows participants to borrow money from their vested account balances. Only one loan may be outstanding at any given time. The minimum loan amount is \$1,000 and the maximum loan amount may not exceed the lesser of (a) one half of the participant's vested interest in the Plan or (b) \$50,000. The loans are secured by the vested balance in the participant's account and bear interest at a rate that is one percentage point above the prime rate. Principal and interest are repaid ratable through payroll deductions. The loan repayment period shall not exceed five years except for loans to acquire a principal residence which the loan repayment period shall not exceed 30 years.

### ***Investment Options***

Upon enrollment in the Plan, a participant may direct their contributions to any of the various investment options available under the Plan. Participants may change their investment options at their discretion.

### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest or a partial lump sum. Participants whose account balances are \$5,000 or less may receive a lump sum payment or have their account balance rolled over to an Individual Retirement Account. Participants may withdraw funds from their accounts who have demonstrated hardship (as defined under Internal Revenue Service Regulations). A participant may also request a withdrawal upon attainment of age 59 ½.

### 1. Description of the Plan (*continued*)

#### ***Forfeited Accounts***

Forfeitures of the non-vested portion of terminated participants' accounts are maintained in a separate account and may be used to pay administrative expenses or to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$15,898 and \$9,830. During 2024, \$1,466 was used to reduce employer contributions. No forfeitures were used to reduce administrative expenses during 2024.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Administrative expenses related to the operation of the Plan are paid by the Plan unless paid by the Company and excluded from these financial statements. The primary expenses relate to recordkeeping, third-party administration, trust and audit services. Expenses relating to specific participant transactions (i.e. loan set up, distributions, etc.) are charged directly against the appropriate participant's account. Investment related expenses are included in net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 9, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Capital Bank and Trust Company, a qualified institution.

### 4. Tax Status

The Internal Revenue Service has determined and informed the prototype document preparer by a letter dated June 7, 2021, that the Plan is designed in accordance with the IRC. The Plan has been amended since the letter was issued by the Internal Revenue Service ("IRS"), however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company may at any time terminate the Plan and discontinue all contributions, subject to the applicable provisions of ERISA. In the event the Plan is terminated, all participants shall become fully vested in their account balances.

### 6. Party-in-Interest Transactions

Certain investments of the Plan are managed by American Funds which is related to Capital Bank and Trust Company, and, therefore, these transactions qualify as exempt parties-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the employer perform administrative services to the Plan at no cost to the Plan.

### 7. Risks and Uncertainties

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 8. Prohibited Transactions

During the 2023 plan year, the Company failed to remit to the Plan certain participants' contributions within the period prescribed by Department of Labor regulations. The Company is in the process of making necessary contributions to compensate participants for lost investment earnings related to the late remittance.
