1. Plan Description

The following description of Scott Edwards Architecture 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established January 1, 2017, is a defined contribution plan covering substantially all employees of Scott Edwards Architecture, LLP (the Employer). There are no age and service requirements for eligibility. Certain employees are not eligible to participate which includes union employees, part-time employees with regularly scheduled service of less than 1,000 hours, temporary employees, seasonal employees, and nonresident aliens who do not receive any earned income from the Employer which constitutes United States source income. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible participants enter the Plan on the day in which they meet the requirements. The Plan's most recent restatement was effective January 1, 2022.

Contributions

Participants may elect annually to contribute pre-tax or after-tax (Roth) contributions up to the maximum percentage allowable by law, limited to the amounts provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified plans. These contributions are fully vested at all times. The Plan automatically enrolls new participants into the Plan with a 5 percent deferral rate with no automatic escalation clause.

The Employer makes a Safe Harbor nonelective contribution of 3 percent of eligible compensation each payroll period. The Employer may also make discretionary employer matching or employer nonelective contributions as elected by the Employer allocated to participants based upon each participant's separate classification.

The Employer made a Safe Harbor nonelective contribution of \$267,186 and \$300,809 for the years ended December 31, 2024 and 2023, respectively. The Employer made no discretionary employer contributions for the years ended December 31, 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, and earnings or losses on the participant's account balances. Participant accounts are charged with certain administrative expenses that are not covered by the Employer. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

1. Plan Description, continued

Vesting

Participants are 100 percent vested in their elective contributions, rollover contributions, Safe Harbor matching employer contributions, and discretionary employer contributions, plus actual earnings thereon, at all times.

Notes Receivable from Participants

Participants may borrow from their accounts a maximum of \$50,000 reduced by the excess of the participant's highest outstanding participant loan balance during the one-year period ending on the day before the loan is made or 50 percent of the participant's vested interest in their account. Minimum loan amount will be \$1,000. The loans are secured by the balance in the participant's account and will bear interest of 1 percent above prime interest rate. The loan may have a term of no more than five years unless for primary residence purchase. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, disability, death, or termination, participants (or their beneficiaries) may elect to receive part or all of the vested interest in their accounts by lump-sum, or substantially equal installment payments, in accordance with the appropriate provisions of the Internal Revenue Code (IRC) and applicable state laws. In addition, participants may elect to receive withdrawals of part or all of the interest in their accounts related to prior rollover contributions at any time. In-service withdrawals are allowed at age 59½ from all accounts. Hardship distributions are permitted from all accounts in accordance with plan provisions.

Forfeited Accounts

Certain adjustments to participant accounts may result in forfeitures. These accounts are used to reduce the Plan's future employer contributions. During the years ended December 31, 2024 and 2023, adjustments related to Safe Harbor employer contributions totaling \$1,161 and \$1,565 were used to offset employer contributions, respectively. The forfeiture account balance was \$-0- at December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan investments are reported at fair value, except for fully benefit-responsive insurance contracts, which are reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional information on fair value measurements. Purchases or sales of securities are recorded on a trade-date basis. Investment and dividend income are recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administration Expenses and Fees

Certain administrative expenses are paid directly by the Employer and are therefore excluded from these financial statements. Certain participant transaction fees are paid from participant accounts. Custodial and other administrative fees are paid from participant accounts. Investment related expenses are included in net change in fair value of investments.

Revenue Sharing

The Plan contains a revenue sharing expense offset arrangement where the Plan is credited an amount as a percentage of assets on a monthly basis which is used to pay investment advisory expenses. \$28,410 and \$23,567 were credited to the account and used to pay investment advisory expenses for the years ended December 31, 2024 and 2023. There was no ending balance in the Plan's revenue sharing account as of December 31, 2024 and 2023.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments ((Accounting Standards Codification (ASC) 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology.

Recent Accounting Standard Adopted, continued

CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are the employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, America United Life Insurance Company, acting as the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Recorded at fair value based on the stated net asset value (NAV) of the separate account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to ASU 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan within a group annuity contract and have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO FINANCIAL STATEMENTS

5. Insurance Contracts

The Plan's investments include a benefit-responsive insurance contract with American United Life Insurance Company (AUL). AUL maintains the contributions in a pooled account (Stable Value Account), which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. All assets in the Stable Value Account are credited with interest using a declared quarterly rate determined by AUL and stated in advance of the coming quarter. There is no specific portfolio of assets in which the stable value fund invests. The credited interest rate is backed by the income received from assets held in AUL's general account. The average interest rate being credited to assets in the Stable Value Account as of December 31, 2024 and 2023, was 1.50 percent and 0.75 percent, respectively. It is not considered a guaranteed interest contract, nor a common/collective trust. Certain events, such as the premature termination of the contract by the Plan, or the termination of the Plan would limit the Plan's ability to transact at contract value with AUL. The Plan Administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with the Plan participants is not probable.

6. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA. Pension Plan Specialists PC, the sponsor of the volume submitter plan, has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, that the adoption agreement and basic Plan document satisfy Internal Revenue Code (IRC) Section 401. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

9. Party-in-Interest Transactions

American United Life Insurance Company was the Plan investment custodian for the years ended December 31, 2024 and 2023; therefore, these investment transactions and related fees qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, \$1,117 and \$669 of recordkeeping fees were paid directly to American United Life Insurance Company from the Plan, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

10. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.

In March 2025, the Plan transitioned to The Standard, the new custodian of the Plan.
