## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Newly Weds Foods, LLC Cash Accumulation Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Notes to Financial Statements

#### Note 1. Plan Description

The following brief description of Newly Weds Foods, LLC (the Company) Cash Accumulation Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information of the Plan's provisions.

**General:** The Plan is a defined contribution plan for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** Employees who have completed 90 days of service are eligible to participate in the Plan. Eligible participants may enter the Plan on their respective 91st day of service.

**Contributions:** Eligible participants may elect to contribute up to 75% of pretax annual compensation, subject to limitations by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to also make catch-up contributions. Participants are allowed rollover contributions from other qualified retirement plans (rollovers). Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

**Participant accounts:** Each participant's account is credited with the participant's contribution and an allocation of investment earnings and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** Upon enrollment in the Plan, participants may direct their contributions into several investment options as more fully described in the Plan's literature. Participants may change their investment allocation at any time.

**Vesting:** Participants are fully vested immediately in their contributions plus actual earnings thereon.

**Notes receivable from participants:** A participant may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their total account balance. A participant may only have one note outstanding at any given time. The loan repayment period is up to five years or up to 15 years for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear an interest rate at the prime rate plus 1% on the first business day of the month in which the loan is originated. Principal and interest are paid ratably through weekly or semimonthly payroll deductions.

**Payment of benefits:** Benefit payments are made to participants or their beneficiaries upon death, retirement, disability or termination of employment. Benefits are payable in a lump sum, partial withdrawals or in installments. In-service withdrawals are permitted by the Plan upon attainment of age 55, completion of 15 years of service, or by determination that a financial hardship, as defined, has been incurred. Benefit payments are to be made to participants from their vested account balances.

**Other income:** Pursuant to service agreements with T. Rowe Price Trust Company (T. Rowe Price or Trustee), T. Rowe Price agreed to make revenue sharing payments to the Plan to pay administrative expenses that the Plan incurs. For the year ended December 31, 2024, \$215,162 was earned by the Plan under this agreement. Of the amount earned from T. Rowe Price, \$40,683 and \$27,552 was received in January 2025 and 2024, respectively, and is included in other income receivable as of December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the balance in the ERISA Budget Account which holds these revenue sharing payments totaled \$115,886 and \$93,963, respectively, which are invested in a money market fund, included in shares of registered investment companies in the statements of net assets available for benefits.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's losses and gains on investments purchased and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Accounting estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) require the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** Administrative expenses of the Plan are charged against earnings, except to the extent expenses are paid by the Company.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 6, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified by T. Rowe Price Trust Company (the Trustee)

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** Shares of registered investment companies are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

**Shares of common/collective trust:** Shares of common/collective trust are valued based on the NAV of shares of the common/collective trust held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Related-Party and Party-in-Interest Transactions

T. Rowe Price provides trustee and record-keeping services to the Plan. These transactions qualify as party-in-interest transactions. Total administrative expenses paid by the Plan to service providers totaled approximately \$77,674 for the year ended December 31, 2024.

Certain employees of the Company provide administrative services to the Plan. These employees do not receive compensation from the Plan for their services. Certain other administrative expenses of the Plan are paid by the Company.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

#### Note 7. Tax Status

Effective August 19, 2020, the Plan adopted a volume submitter plan sponsored by T. Rowe Price. The volume submitter plan has received an opinion letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by the Plan. The Plan has been amended since the adoption date. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
