We have performed audits of the financial statements of the Synergy55 LLC Profit Sharing and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Description of Plan

The following description of the Synergy55 LLC Profit Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established effective April 1, 1999, as restated September 1, 2021, for nonunion employees of Composites One LLC and Aerovac LLC (the Company) and Synergy55 LLC (the plan sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan. Non-union employees become eligible to participate in the Plan immediately following their date of hire and attainment of age 19. The Plan's assets are administered under a contract with Fidelity Management Trust Company, the Trustee of the Plan (Trustee). The Trustee invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants. Synergy55 LLC, is responsible for oversight of the Plan. The Plan's administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to Synergy55 LLC.

### Contributions

Participants may contribute up to 100% of pretax annual compensation (salary reduction contributions) and after-tax contributions, as defined in the plan document, subject to Internal Revenue Code (IRC) limitations. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who are age 50 before the end of the plan year were eligible to make catch-up contributions. Participants aged 60-63 are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants of the Company will have their deferral rate set at 4% of eligible compensation. Automatically enrolled participants of Aerovac LLC will have their deferral rate set at 6% of eligible compensation. Automatically enrolled participants' contributions are invested in a designed balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% on the anniversary of their enrollment date until their deferral rate reaches 10%. Composites One LLC and Synergy55 LLC's discretionary matching contributions were equal to 75% of the first 4% of base compensation that a participant contributes to the Plan for the year ended December 31, 2024. Aerovac LLC's discretionary matching contribution was equal to 100% of the first 6% of base compensation that a participant contributes to the Plan for the year ended December 31, 2024. A true-up of the Company's discretionary matching contribution of \$132,821 was contributed in 2025 for the year ended December 31, 2024. In addition, the Company elected to make a discretionary profit-sharing contribution of \$5,827,518 for the year ended December 31, 2024, which was funded in 2025, and reflected in the statements of net assets available for benefits as employer contributions receivable as of December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contribution, Company's matching and profit sharing contributions as applicable, allocation of the Plan's earnings, forfeitures of terminated participants' nonvested accounts and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are immediately vested in their contributions, Company discretionary matching contributions and actual earnings thereon. A participant becomes fully vested upon death or disability. Participants vest ratably in the Company discretionary profit sharing contributions over six years. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

## Notes Receivable From Participants

Participants may borrow a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested portion of their account balance. Loan terms range from one to five years unless it is for the purchase of a primary residence. The loans are secured by the vested balance in the participant's accounts and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Each participant's account is charged with administrative fees on any loans the participant has taken.

## Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement and termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or installments. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account, depending on the balance. Participants experiencing financial hardship may withdraw a portion of their account balance if certain criteria are met, as defined by the plan document.

## Forfeited Accounts

Forfeited nonvested accounts totaled approximately \$441,600 and \$201,400 as of December 31, 2024 and 2023, respectively. These forfeitures are used to fund the discretionary profit sharing contributions, additional discretionary contributions or are used to pay administrative expenses. Forfeitures in the amount of \$76,215 were used to pay administrative expenses for the year ended December 31, 2024. Forfeitures in the amount of \$747 were used to offset discretionary profit sharing contributions for the year ended December 31, 2024.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as benefits paid to participants based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

## Subsequent Events

Subsequent events were evaluated through October 8, 2025, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments measured at NAV:* Consisting of common-collective trusts, valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

## 4. Concentrations

The Plan holds certain investments that represent 10% or more of the Plan's net assets available for benefits. The Plan held four and three such investments totaling \$96,465,371 and \$64,478,338 as of December 31, 2024 and 2023, respectively.

## 5. Related-Party and Party in Interest Transactions

Certain plan investments are managed by the Trustee, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management and recordkeeping services are considered party in interest transactions and are netted against investment income. Additionally, the Plan issues loans to participants, which are secured by the participant's vested account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

## 7. Tax Status

The Plan has adopted a pre-approved plan sponsored by FRM LLC. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan letter, dated June 30, 2020, has been relied upon by the Plan. The Plan has been amended since its adoption. The plan administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the IRS or other tax authorities; however, there are currently no audits for any tax periods in progress.

## 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

## 9. Information Certified by Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustee has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

## 10. Delinquent Participant Contributions

For the year ended December 31, 2024, the Company remitted all participant contributions to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

For the years ended December 31, 2023 and 2020, the Company did not remit certain participant contributions to the Plan on a timely basis. Untimely remittances identified on the supplemental schedule, Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions, which totaled \$25,807 and \$236, for the years ended December 31, 2023 and 2020, respectively. Additionally, the Company will compensate participants for lost earnings resulting from the delay in contributions remaining to be corrected.
