## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Churchill Downs Incorporated 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the Churchill Downs Incorporated 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established under Section 401(a) of the Internal Revenue Code (IRC). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective January 1, 1987, and covers all eligible employees of Churchill Downs Incorporated and its wholly-owned subsidiaries and certain managed properties. Churchill Downs Incorporated (the Company, Sponsor and Plan Administrator) has been creating extraordinary entertainment experiences for over 150 years, beginning with the Company's most iconic and enduring asset, the Kentucky Derby. Headquartered in Louisville, Kentucky, the Company has expanded through the development of live and historical racing entertainment venues, the growth of the online wagering businesses, and the acquisition, operation and development of regional casino gaming properties.

During 2024, the Sponsor formed or acquired certain entities, including Owensboro Racing & Gaming, LLC and United Tote Gaming Services. The Plan has been amended to allow the employees of these entities to become participants in the Plan. The Plan credits prior service to these participants.

#### Eligibility

All employees that have worked a minimum of one hour and completed three months of employment are eligible to participate in the Plan. Union employees are not eligible to participate in the Plan unless the collective bargaining agreement which defines the terms of their employment specifically authorizes participation in the Plan.

#### Contributions

Participating employees may elect to contribute up to 75% of their pre-tax annual compensation as defined in the Plan document. The Sponsor has elected to make safe harbor matching contributions of 100% of employee contributions up to 3% of the employee's eligible compensation and 50% of employee contributions greater than 3%, up to 5%, of the employee's eligible compensation. In addition, for each Plan year, the Sponsor may contribute to the Plan a discretionary amount not to exceed 4% of the employee's Plan compensation and as may be determined by the Board of Directors. For the years ended December 31, 2024 and 2023, the Sponsor made no discretionary contributions to the Plan. The total contribution to a participant's account may not exceed the maximum limit determined by Internal Revenue Service (IRS) regulations. Rollover contributions are permitted only by employees who have satisfied the conditions for participation.

## Notes to the Financial Statements, continued

### 1. Description of the Plan, continued

#### Participant Accounts

Each participant's account is credited with the participant's and the Sponsor's contributions and allocations of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Participants may, upon enrollment in the Plan, elect to invest their contributions and the Sponsor's contributions in 1% increments in any of the various investment options currently offered by the Plan. Periodic transfers among funds of certain accumulated account balances and directions of future employee deferral and Sponsor contributions are permitted.

#### Vesting

Participants are immediately vested in their contributions and any Sponsor's safe harbor matching contributions, plus actual earnings (losses) thereon. Vesting in the Sponsor's discretionary contribution portion of their accounts, plus actual earnings (losses) thereon, is based on years of continuous service. A participant vests 20% per year after the first year of service, and is 100% vested after five years of credited service. If a participant dies or becomes disabled, he or she is automatically 100% vested in all accounts.

#### Participant Loans

Participants may borrow from their fund accounts for hardship reasons (as defined by the Plan document) and are limited to the lesser of \$50,000 or 50% of the vested portion of the participant's account balance. The maximum loan duration is five years, or fifteen years if for the purchase of a primary residence, and the minimum loan amount allowed is \$1,000. The loans are secured by the balance of the participant's account and bear interest at a rate equal to the prime rate plus one percent which range from 4.25% to 9.50%. Principal and interest are paid through monthly payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's fully vested interest in his or her account. Participants may also request distributions at any time upon attainment of normal retirement age of 65 or due to the occurrence of hardships (as defined by the Plan document).

#### Forfeited Accounts

All forfeitures are applied to Plan Sponsor contributions and Plan expenses. At December 31, 2024 and 2023, there were \$5,236 and \$165,858 of forfeited nonvested accounts, respectively. During 2024, forfeitures totaling \$172,334 were used to reduce contributions and \$13,750 of forfeited balances were used to reduce Plan expenses. Forfeited balances had earnings totaling \$25,462 during 2024.

## 1. Description of the Plan, continued

### Risks and Uncertainties

The Plan provides for participant-directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### Administrative Expenses

The Plan is responsible for its administrative expenses unless paid by the Sponsor.

## 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value with the exception of fully benefit-responsive insurance contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 4 for disclosures related to the fair value of investments. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company.

Contract value is the relevant measurement for fully benefit-responsive insurance contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which participant compensation is earned.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

### 2. Summary of Significant Accounting Policies, continued

#### Payment of Benefits

Benefit payments to participants are recorded when paid. As of December 31, 2024 and 2023, there were no outstanding payments to persons electing to withdraw from the Plan.

#### Subsequent Events

The Plan's management has evaluated subsequent events for recognition or disclosure in the financial statements through October 7, 2025, which was the date at which the financial statements were available to be issued.

### 3. Information Certified or Provided by the Custodian

The Plan's asset information included in this note and throughout the Plan's financial statements and the supplemental schedules was prepared by or derived from information provided by Fidelity Investments (Fidelity), the custodian of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that asset information provided to the Plan Administrator by the custodian is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedules.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trusts:* Valued based on the NAV of units of the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Money market funds:* Valued at cost which approximates fair value.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

The collective trusts invest in a stable value fund which includes investment contracts issued by insurance companies, cash equivalents, and separate account investment contracts. Investments in this category can be redeemed immediately upon request. The fair value of investments in this category has been estimated using the NAV of the units of participation in the fund.

### 5. Investment Contracts with Insurance Company

The Plan has a fully benefit-responsive insurance contract with Standard Insurance Company (Standard). Standard maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value, as reported to the Plan by Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor event (e.g., divestures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rates were 3.02% and 3.45% as of December 31, 2024 and 2023, respectively. Such interest rates are reviewed on a quarterly basis for resetting. The average yield for the year ended December 31, 2024 was 2.94%.

### 6. Related Party Transactions, Including Party-In-Interest Transactions

Certain Plan investments are managed by the custodian of the Plan, Fidelity. Investments in these accounts qualify as party-in-interest transactions. Administrative expenses of \$198,226 for the year ended December 31, 2024 are comprised of fees paid by the Plan to Fidelity for recordkeeping services, investment management services and withdrawal charges. The Plan pays additional direct fees to other third parties which are also included in administrative expenses on the statement of changes in net assets available for benefits.

Additionally, indirect fees are paid to Fidelity based on investment account values. These fees range from 0.015% to 0.680% of the investment account value. The fees decrease net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

### 7. Tax Status

The Plan uses a prototype Plan document sponsored by Fidelity. Fidelity received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would receive benefits under the Plan based on their account balances accumulated to the date of Plan termination and would become 100% vested in their accounts.

### 9. Prohibited Transactions

During the year ended December 31, 2023, certain participant withholdings in the amount of \$1,584,104 were not remitted within the appropriate time period by the Plan Sponsor. These transactions constitute a prohibited transaction as defined by ERISA. The Plan Sponsor is aware of the occurrence and has taken the appropriate steps to correct the situation by implementing procedures to ensure all future remittances are completed within the prescribed time period. These transactions were fully corrected during the year ended December 31, 2024.
