Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Strategies 360, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN:

The following description of the Strategies 360, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants and others should refer to the Plan document for a more complete description of the Plan’s provisions.

The Strategies 360, Inc. 401(k) Profit Sharing Plan is a contributory, defined contribution plan for the benefit of the employees of Strategies 360, Inc. (“the Company”). The Plan was established January 1, 2002, and has since been amended. The following description reflects the provisions of the most recent plan document dated January 1, 2022, and amendments thereto. The Plan is administered by the Company and the Plan assets are held in a trust by Empower Trust Company LLC (“Empower”). The funds must be used for the exclusive benefit of Plan participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In October 2023, the Company filed for Chapter 11 bankruptcy protection. The filing did not impact the Plan or the Company’s intentions with regard to continuing the Plan as a going concern. The Company has completed its reorganization process and continues as a going concern.

The Plan includes a 401(k) feature whereby employees may contribute up to 100% of their compensation, as defined in the Plan and subject to statutory limitations. The contributions may be pre-tax or Roth deferrals. To participate, an employee must be at least 21 years of age and have completed 1,000 hours in the first 6 months of employment, or after one year of eligibility service, defined as 1,000 hours of service in the year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, and if the participant is at least age 50, catch-up contributions may be made.

Employer matching contributions are discretionary. For 2024 and 2023, a match at 50% of deferrals up to 6% of the employee eligible compensation was declared. The eligibility requirements to receive a matching contribution are the same as eligibility for deferrals. Contributions to the Plan of employee deferrals and the related match are made with each payroll.

The Plan also contains provisions allowing the Company to make non-elective contributions and profit-sharing contributions. To be eligible for a profit-sharing contribution, an employee must complete 1,000 hours of service in the Plan year and be employed by the Company on the last day of the Plan year. No such contributions were made in respect of 2024 and 2023.

NOTE 1 - continued:

Each participant's account is credited with the participant's contribution, and allocations of the related matching contribution and net plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Employee contributions, employer matching contributions, and earnings thereon are invested as directed by the participants. The investment options include a variety of mutual funds, including blended investment risk funds and a guaranteed interest account. The blended investment risk funds are managed portfolios, composition of which is based on the participant's desired risk level. Participants may change their investment options at will.

Participants are immediately and fully vested in their deferrals. Discretionary employer contributions and allocated earnings thereon vest with individual participants based upon years of service with the Company with 100% vesting after 6 years of service.

Distributions may be taken upon termination of employment or attainment of normal retirement age (age 65 and after 5 years of service). If the vested account balance is less than \$1,000, the former employee will receive a cash distribution. If the vested account balance is greater than \$1,000, but less than \$5,000, the amount will be distributed in cash or in a roll over to an IRA or other qualified retirement plan. If the vested account balance exceeds \$5,000, and the participant is no longer employed by the Company, the Plan Administrator will distribute the vested account balance after the later of attainment of normal retirement date or age 62.

In limited circumstances, in-service withdrawals of employee deferrals may be made. The limited circumstances include hardship and attainment of age 59-1/2.

Unvested benefits of terminated participants are forfeited and used to reduce employer matching contributions or to pay administrative expenses. Unallocated forfeitures at December 31, 2024 and 2023 were \$1,796 and \$25,248, respectively. Forfeitures used to fund the employer match totaled \$65,657 for the year ended December 31, 2024. In addition, forfeitures totaling \$6,501 were used to offset plan expenses for the year ended December 31, 2024.

Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance, with a minimum loan of \$1,000. The loans bear interest at a reasonable rate, are secured by the participants' vested account balances and are repaid ratably through monthly payroll deductions. Outstanding loans are generally due within five years, or upon termination of employment of a participant.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:

Use of estimates-

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets and net assets available for benefits at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Valuation of investments-

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Recognition of income and expenses-

The Plan records income and expenses on the accrual basis of accounting. In accordance with generally accepted accounting principles, benefits are recorded in the period paid. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments represents the net increase (decrease) in the fair value of investments sold during the year or held at year-end over (1) the fair value of investments held at the prior year-end, or (2) the cost of investments acquired during the current year.

Certain administrative costs of the Plan are borne by the Company. In addition, the Company may provide services to the Plan for which the Company receives no compensation. The costs borne by the Plan include recordkeeping and mutual fund expenses.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Principal and interest are paid with each pay period. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Due to adequate collateral, no allowance for credit losses is needed.

NOTE 3 - FAIR VALUE MEASUREMENTS:

Fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability. There are three levels, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within level 1 of the valuation hierarchy. There has been no change in valuation methodologies used for fair value in 2024 and 2023.

NOTE 4 - GROUP ANNUITY CONTRACT:

The Plan has a group annuity contract with an insurance company, that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly, and cannot be less than 0%. The average yield earned by the fund was 1.41% in 2024. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

NOTE 4 - continued:

The contract meets the fully-benefit responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events may include the following: (1) premature termination of the contract by the Plan; (2) complete or partial Plan termination or merger with another plan; (3) bankruptcy of the Plan sponsor; or, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Plan management does not believe that any events that would limit the Plan's ability to transact at contract value are probable of occurring.

NOTE 5 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN:

The Plan's management elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, certain information certified by a qualified trustee or custodian need not be subject to independent audit.

The Plan's custodian is Empower Trust Company LLC. Plan's management has obtained certifications from the custodian that the following information included in the Plan's financial statements and supplemental schedule of Assets (Held at End of Year) is complete and accurate:

1. Fair value and contract value of investments as of December 31, 2024 and 2023,
2. The balance of notes receivable from participants as of December 31, 2024 and 2023,
3. Investment income and interest income on notes receivable from participants earned for the year ended December 31, 2024,
4. Investment transactions for the year ended December 31, 2024.

NOTE 6 - FEDERAL INCOME TAXES:

Effective January 1, 2022, the Plan adopted a volume submitter plan. The Internal Revenue Service has determined and informed the sponsor of the volume submitter plan by a letter dated June 30, 2020, that the form of the volume submitter plan is acceptable under Section 401 of the Internal Revenue Code (IRC). The Plan's administrator believes that the Plan is designed and being operated in compliance with the applicable IRC requirements. Therefore, the administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

NOTE 6 - continued:

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has concluded that as of December 31, 2024, the Plan has not taken any uncertain positions that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress and years prior to 2021 are no longer subject to audit. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS:

Empower acts as custodian for investments of the Plan. Therefore, transactions with Empower and its affiliates qualify as party-in-interest transactions. In addition, the Plan pays fees to its third-party administrator, which is also a party-in-interest.

NOTE 9 - RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS:

Management has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.
