## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements**

We have performed audits of the accompanying financial statements of Amurcon Corporation of Virginia 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Notes to Financial Statements

**1. Description of Plan:**

The following description of the Amurcon Corporation of Virginia 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or summary plan description for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Amurcon Corporation of Virginia and its affiliates (collectively, the "Company"). Employees become eligible to participate after completing six months of service and attaining age 21. Employees are eligible for entry on the first day of the first month and of the seventh month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participant contributions of pre-tax annual compensation, as defined in the Plan. The Company may make matching contributions as determined annually by the Company. The Company may contribute additional amounts at the option of the Board of Directors. Participants of qualifying age may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an automatic deferral feature whereby newly eligible employees are automatically enrolled in the Plan at a set deferral rate of 1% of compensation unless they affirmatively elect not to participate or make a contrary election. The 1% deferral rate will increase 1% each Plan year until the amount reaches 6% of the participant's compensation. Contributions are subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants may direct Transamerica Life Insurance Company and Reliance Trust Company as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their elections at any time.

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. Participants are fully vested in Company contributions after attaining six years of credited service.

**Notes Receivable from Participants:** Notes receivable from participants are not permitted under the Plan.

**1. Description of Plan, Continued:**

**Plan Administration:** Participant accounts are administered by Transamerica Life Insurance Company. Overall responsibility for administering the Plan rests with the Company. Certain administrative functions are performed by Company employees. No such employees receive compensation from the Plan.

**Payment of Benefits:** Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment in an amount equal to the vested value of his or her account.

**Forfeitures:** Forfeited balances of terminated participants' non-vested accounts are used to offset Company contributions. Total forfeitures were \$70,261 and \$5,815 in 2024 and 2023, respectively. Company contributions and expenses were reduced by \$4,932 and \$6,903 in 2024 and 2023, respectively. There were \$66,596 and \$1,171 forfeited balances available to be applied toward future Company contributions at December 31, 2024 and 2023, respectively.

**2. Summary of Significant Accounting Policies:**

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

**Payment of Benefits:** Benefits are recorded when paid.

**Group Annuity Contract:** Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**2. Summary of Significant Accounting Policies, Continued:**

**Use of Estimates:** The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events to be reported in the accompanying financial statements.

**3. Fair Value Measurements:**

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Mutual funds:** Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Group Annuity Contract:**

During 2022, the Plan entered into a group annuity contract with Transamerica Life Insurance Company ("TLIC"), the Transamerica Stable Value Core Option. The contract is a traditional investment contract. Under the contract, the participant principal and interest are fully guaranteed by the general account assets of TLIC. The investment strategy employed seeks to achieve consistent returns to support a competitive credited rate.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive contract because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

**4. Group Annuity Contract, Continued:**

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. Every six months, TLIC establishes a guaranteed interest rate. The new rate is announced not less than 45 days before the next six-month period and is guaranteed for six months. The contract does not have a maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent upon the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) the plan is changed so significant to affect TLIC's obligations under the contract, (2) the Plan is terminated, (3) the Plan Sponsor fails to comply with the requirements under the contract, (4) the Plan Sponsor fails to give us the information needed under the contract (except by unintentional omission), or (5) the Plan Sponsor fails to furnish TLIC with a copy of any amendments to the Plan or annual report records (except by unintentional omission). No event are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer or that would limit the ability of the Plan to transaction at contract value with the participants.

**5. Administrative Expenses:**

Although not required by the Plan, a portion of the costs of the plan administration is absorbed by the Company.

**6. Related Party Transactions:**

The Plan invests in a group annuity contract sponsored by an affiliate of the trustee, Transamerica Life Insurance Company. These are related party transactions. The Plan paid administrative and advisory expenses to the trustee and its affiliates totaling \$20,755 during 2024 and \$17,508 during 2023.

**7. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**8. Tax Status:**

The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020, that the adopted prototype plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax authority.

**9. Risks and Uncertainties:**

The Plan provides for various investments in mutual funds, a common/collective trust, and a guaranteed annuity contract. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

The Transamerica Life Insurance Company and the Reliance Trust Company, the trustees of the Plan, has certified that the following information is complete and accurate:
