**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Brown & Haley 401(k) Retirement Plan for Bargaining Unit Employees (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan established on January 1, 2007, which covers all collective bargaining employees of Brown & Haley (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees have adopted a qualified prototype plan provided by Standard Retirement Services, Inc.

***Eligibility***

Employees are eligible on the first day of the next payroll period after reaching age 18 and completing six months of employment (at least 500 hours).

***Contributions***

Participants may elect to defer a percentage or a dollar amount of compensation to the Plan, as defined in the Plan and limited to the maximum allowed under the Internal Revenue Code section 402(g). Pursuant to the collective bargaining agreement, each participant will receive an employer contribution based on years of service earned at the end of each Plan year. The Company will also make a "make-up contribution" based on years of service earned as of December 31, 2006. Make-up contributions will cease when an employee has earned 25 years of service.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

***Vesting***

Participants are immediately vested in their salary deferral contributions and the Company's contributions plus actual earnings thereon.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. Loan repayments are made ratably through payroll deductions over a period not to exceed five years. Participants must qualify for financial hardship to obtain a loan. Generally, the loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates (4.25% to 9.5% at December 31, 2024 and 2023), as determined by the Plan administrator.

**NOTE 1 - DESCRIPTION OF PLAN (Continued)**

***Payment of Benefits***

Benefits are paid upon death, disability, retirement, separation from service or hardship. If an account balance is less than \$1,000, a mandatory distribution will be made in the form of a lump-sum distribution.

***Plan Expenses***

Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are paid by the Plan and included in net appreciation in fair value of investments.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Investment Valuation and Income Recognition***

The Plan's investments, except the guaranteed insurance contract, are stated at fair value, which is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 5 for the disclosure of the Plan's fair value measurements. The guaranteed insurance contract is valued at contract value (see Note 3). The Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Evaluation of Subsequent Events***

Management has reviewed subsequent events through October 8, 2025, which is the date that the financial statements were available to be issued.

**NOTE 3 - GUARANTEED INSURANCE CONTRACT**

The Standard Stable Asset A Fund is a group annuity contract that offers a full guarantee on principal and interest by the Standard Insurance Company (Standard). The contract is fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed insurance contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed insurance contract. The guaranteed insurance contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$360,786 and \$309,844, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1% (3.07% and 2.78% at December 31, 2024 and 2023, respectively). Management approval is required for all crediting rates.

Certain events limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that the participants' contract values are not affected. If the Plan sponsor views the occurrence of any of these events as probable as of the measurement date, details about market value adjustments or other withdrawal restrictions can be obtained through the Plan's account manager. The plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time. Upon termination by Standard, a market value adjustment or other withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that the participants' contract values are not affected.

**NOTE 4 - INFORMATION CERTIFIED BY CHARLES SCHWAB BANK**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the auditors not to perform any auditing procedures with respect to information which was certified as complete and accurate by Charles Schwab Bank, the trustee of the Plan. The information certified by Charles Schwab Bank includes investments and the related investment activity.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

The Fair Value Measurements Topic 820 of the FASB Accounting Standards Codification (ASC) establishes a fair value hierarchy for reporting that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable units other than quoted prices for identical assets; and Level 3 inputs have the lowest priority.

**NOTE 5 - FAIR VALUE MEASUREMENTS** (Continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

The investments in mutual funds are valued utilizing a market approach wherein the Plan uses the quoted prices in the active market for identical assets. All of these investments are traded in active markets.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE 7 - TAX STATUS**

The Plan obtained its opinion letter on a volume submitter plan document on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as originally designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Company has filed its Form 5500 returns timely with the Department of Labor. The Plan administrator believes it is no longer subject to income tax examinations for tax years prior to 2021.

**NOTE 8 - RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in various investment options issued by Charles Schwab Bank, who serves as a trustee of the Plan, and the Standard Insurance Company, who serves as the third-party administrator of the Plan, for the years ended December 31, 2024 and 2023. Therefore, these transactions are recognized as party-in-interest transactions. In addition, the Plan paid certain expenses to various service providers. These expenses are exempt party-in-interest transactions under ERISA.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Plan Benefits.
