Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Art's-Way Manufacturing Co., Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of the Art's-Way Manufacturing Co., Inc. 401(k) Savings Plan (the Plan) provides only general information of the Plan. Participants should refer to the Plan documents for a more complete description of the Plan's provision.

General

The Plan is a defined contribution plan covering the employees of Art's-Way Manufacturing Co., Inc. and its subsidiary (the Company) who have completed 60 days of service. Eligible employees may begin making contributions to the Plan the first of the month after sixty days of employment. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA).

Contributions

Under the provisions of the Plan, participants may contribute the maximum allowed under the Internal Revenue Code (IRC) of their pretax annual compensation subject to certain limitations. The Plan allows participants to make pretax or Roth contributions. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The investment options currently include 20 pooled separate accounts and a stable value guaranteed investment contract (Stable Value) with Transamerica Life Insurance Company (Transamerica).

The Plan document allows the Company to make discretionary matching contributions and discretionary, non-elective contributions. Participants are required to be contributing to the Plan to be eligible for the discretionary matching contribution. All eligible participants are eligible for the discretionary, non-elective contribution. The Company is currently making a matching contribution of 50% of the first 6% contributed for a maximum of 3%.

The Company did not make any discretionary, non-elective contributions in 2024. All contributions are subject to certain limitations.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's contributions, and an allocation of the Plan's earnings or losses, and is charged with an allocation of administrative expenses. Income and loss is allocated to the participants' accounts based on the ratio of the account balance of the individual participant to the aggregate of all account balances of all participants in the fund within the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of the participant's account plus actual earnings thereon is based on years of credited service. The Company's discretionary contributions are 20% vested after the second year of service plus 20% a year thereafter, plus actual earnings thereon. A participant becomes 100% vested upon completing six years of credited service. Participants have been credited with past services with acquired entities for vesting purposes.

1. DESCRIPTION OF THE PLAN - Continued

Payment of Benefits

On termination of service for all causes, a participant receives the value of the vested interest in their account as a lump sum distribution.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1 month to 5 years. The administrator may permit longer terms if the loan proceeds are used to purchase a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through periodic payroll deductions with payments made at least quarterly.

Forfeited Accounts

Forfeited nonvested accounts remain in the Plan and are first used to restore eligible participants' previously forfeited amounts, then used to offset Plan expenses, and finally used to reduce the Company's matching contributions. Forfeited nonvested accounts available for use at December 31, 2024 and 2023 totaled \$8,246 and \$3,368, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed in the preparation of the financial statements.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires plan management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued

Investment Valuation and Income Recognition

The Plan's pooled separate accounts are stated at fair value based on quoted market prices which represent the net asset value of shares held by the Plan at year-end. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the trustee. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation in fair value of investments includes gains and losses in investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Investment management fees charged to the Plan are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

The Plan's Stable Value investment is reported at contract value because Transamerica considers the account to be a fully benefit-responsive contract. Contract value, as reported to the Plan by Transamerica, is the relevant measure for a fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under terms of the Plan.

Excess Contributions Payable

Amounts payable to participants totaling \$6,592 and \$15,767 for 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions in the following year. The Plan distributed the 2024 excess contributions after March 15, 2025. As a result, the Plan may be subject to excise taxes. Management has taken corrective actions and believes all necessary steps are being taken to correct the compliance failure. The Plan distributed the 2023 excess contributions prior to March 15, 2024.

Administration of Plan Assets

The Plan's assets were held by Transamerica and Reliance Trust Company (Reliance), passive trustee. The contributions are held and managed by Reliance who invests the Plan's assets and pays benefits to the participants. All direct administrative expenses, including trustee, investment management, and Plan audit fees are paid from the assets of the Plan.

Participant Notes Receivable

Participant notes receivable are stated at their unpaid principal balance plus accrued interest. Interest income on the notes is recorded upon receipt of the payments. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Distributions to participants are recorded in the year paid.

Date of Management Review

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE OF INVESTMENTS

The Plan's pooled separate accounts are reported at fair value. GAAP has established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The hierarchy consists of three broad levels:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 inputs consist of observable inputs other than quoted prices for identical assets.
- Level 3 inputs consist of unobservable inputs where there is little or no market data, which requires the reporting entity to develop its own assumptions.

Following is a description of the valuation methodologies used for assets that are measured at Net Asset Value (NAV) as the practical expedient to estimate fair value and are aggregated in the fair value hierarchy are as follows:

Pooled Separate Accounts: Valued at the net asset value per unit based on either the observable net asset value of the underlying investment or the net asset value of the underlying pool of securities. Net asset value is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the period ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

4. INVESTMENTS AT CONTRACT VALUE

Guaranteed Investment Contract with Insurance Company

The Plan holds a fully benefit-responsive guaranteed investment contract with Transamerica for the Stable Value investment which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is set by the issuer and reviewed on a semi-annual basis for resetting. The minimum and actual fixed rate was 1.50% for 2024.

Certain events limit the Plan's ability to transact at contract value with Transamerica. Such events include the following:

- a. amendments to the plan documents (including complete or partial plan termination or merger with another plan),
- b. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- c. bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the plan, or
- d. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include:

- a. an uncured breach of the Plan's investment guidelines
- b. a material amendment to the contract without the issuer's consent,
- c. a violation of a material obligation under the contract, or
- d. a material misrepresentation.

The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of pooled separate accounts or stable value funds managed by Transamerica, the recordkeeper of the Plan, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment.

6. PLAN TERMINATION

Although the Company has expressed no intention to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the net assets of the Plan must be allocated among the participants and beneficiaries of the Plan in the order provided for by ERISA.

7. INCOME TAX STATUS

The Plan has adopted a non-standardized prototype plan document and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype and related trust are designed in accordance with applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. Although the prototype plan has been amended since receiving the opinion letter, the prototype sponsor and the plan administrator believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Future qualification of the Plan will depend on operation of the Plan in compliance with the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and has concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

8. INFORMATION CERTIFIED BY THE CUSTODIAN AND TRUSTEE (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, Transamerica and Reliance, as passive trustees, have certified the completeness and accuracy of all of the investments and the participant notes receivable in the accompanying statements of assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets held at year end as of December 31, 2024, and the net investment income in the statement of changes in assets available for benefits for the year ended December 31, 2024. Accordingly, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures on these accounts.

9. RISKS AND UNCERTAINTIES

Investment Risks

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
