Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AWS 401(k) Profit Sharing Plan, (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

The following description of the AWS 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan's provisions.

General

The Plan, which was established effective July 1, 2007, and restated effective January 1, 2015 and December 1, 2023, is a defined contribution plan sponsored by A.W. Holdings, LLC d/b/a Benchmark Human Services (Company). The Plan covers substantially all full time eligible employees of the Company who have attained the age of 18 and have completed one year of service. The entry date for this Plan is the earlier of the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Charles Schwab Trust Bank is the trustee of the Plan. Alerus Financial, N.A., was the custodian of the Plan through December 1, 2023, at which time Charles Schwab Trust Bank became the custodian for the Plan.

Contributions

Participants may defer and contribute a percentage or dollar amount of their pre-tax or after tax (Roth) compensation, as defined by the Plan, not to exceed certain dollar limitations that are set by law. Participants age 50 or older may elect to defer and contribute additional amounts to the Plan up to a maximum that is set by law. Participants may also make rollover contributions of amounts representing distributions from other plans and certain Individual Retirement Accounts (IRA). Additionally, the Plan allows participants to change the amount of their contribution in accordance with the procedures the Company provides.

The Company may make a discretionary matching contribution equal to a uniform percentage of the amount of salary reduction each participant elects to defer, which percentage will be determined by the Company each year. For the years ended December 31, 2024 and 2023, the Company generally made a matching contribution to the Plan of 50% of the first 6% of compensation contributed by each participant, with the exception of certain employees who received 60% of the first 8% of compensation contributed by those participants. The Company may also make an additional nonelective contribution to the Plan. During the years ended December 31, 2024 and 2023, the Company made nonelective contributions of \$918,433 and \$573,665, respectively. Participants must complete a year of service and be employed at the end of the year to share in the nonelective contribution.

Participant Investment Account Options

The Plan allows participants to change their investment elections, with respect to the portion of their account subject to their investment direction, at any time. Currently, a participant may select from numerous diversified mutual funds and a money market fund.

Participant Accounts

Each participant's account is credited or charged with allocations of (a) the participant's contributions, (b) the Company's matching and nonelective contributions, (c) investment gains or losses, and (d) plan expense. Plan earnings (losses) are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant contributions, matching Company contributions, and Company nonelective contributions are invested at the direction of the participant in the investment options available to the Plan. A participant may change their investment options as permitted by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions and the contributions, including rollover contributions, and investment earnings or losses thereon. Participants become vested in the discretionary matching and nonelective contributions provided by the Company, plus investment earnings or losses thereon, based on years of service. A participant's discretionary matching and nonelective contribution account is 100% vested after three years of credited service.

Payment of Benefits

Participants that are entitled to a distribution of more than \$5,000 may elect to receive a lump-sum payment of cash or in property, rollover the distribution to another retirement plan willing to accept the transfer or an IRA, or annual installments at least equal to the required minimum distribution amount. Separated participants with vested account balances not exceeding \$5,000 will receive lump-sum distributions as soon as possible following the event that entitles a participant to a distribution. Separated participants with vested account balances in excess of \$1,000 and less than or equal to \$5,000 that have not made an election will have their account rolled into an IRA. Terminated participants with vested account balances exceeding \$5,000 must consent to the distribution and may delay timing of the distribution, subject to minimum distribution rules required by law. The Plan also provides for certain hardship withdrawals and participant loans as described above. Distributions of benefits are recorded as withdrawals from the Plan and reduction of assets available for plan benefits in the period paid to the participant.

Notes Receivable From Participants

Participants may borrow approved amounts, not less than \$1,000, from their vested account balance up to the lesser of (a) \$50,000 reduced by the excess, if any, of a participant's highest balance of loans from the Plan during the 12-month period prior to the date of the loan over their current outstanding balance of loans on the date of the loan or (b) 50% of the vested account balance. A participant may have no more than two loans outstanding at a time and the term of the loan may not exceed five years. If a loan is for the purchase of a primary residence, the term will be 15 years. The loans are secured by the balance in the participant's vested account and bears interest at the prime rate plus 1%. The loan must provide at least quarterly payments under a level amortization schedule. For participants currently employed by the Company, the Plan requires the participant receiving a loan from the Plan to enter into a payroll deduction or Automated Clearing House (ACH) agreement to repay the loan.

Forfeited Accounts

There were no material unallocated forfeitures at December 31, 2024 or December 31, 2023. Forfeitures may first be used to pay any administrative expenses, and any remaining forfeitures will be used to reduce Company contributions. Forfeitures used to pay administrative expenses and reduce Company contributions during 2024 and 2023 were \$20,317 and \$8,152, respectively.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Alerus Financial, N.A., formerly Alliance Benefit Group North Central States, Inc. This pre-approved plan document has been filed with the appropriate agency. The Plan has not been submitted to the Internal Revenue Service for an individual determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Contributions

Contributions from Plan participants and the Company are recorded in the year in which the participant compensation is earned.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The expenses of administering the Plan are paid from the Plan unless the Company elects to pay the expenses. The Company also provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Subsequent Events

Subsequent events have been evaluated through September 23, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification by Plan Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial, N.A. and Charles Schwab Trust Bank, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge and belief:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable on participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform procedures with respect to this certified investment information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Level 2 or Level 3 investments.

Mutual Funds

The fair values of mutual fund investments are determined by obtaining net asset value (NAV) of shares via quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Note 5. Transactions with Parties-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Fees paid by the Plan to Charles Schwab Trust Bank and Alerus Financial, N.A. for investment management and other services amounted to \$172,351 and \$182,794 for the years ended December 31, 2024 and 2023, respectively.
