### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of Aspen Surgical Products Holdings, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that was established on July 1, 1987, by Aspen Surgical Products Holdings, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration

The Plan Sponsor and named Plan Administrator is Aspen Surgical Products Holdings, Inc. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan’s investment offerings, monitors investment performance and fees, and reports to the Plan’s Trustee. The Plan’s Trustee and Investment Custodian is Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal Trust Company”). The Investment Custodian holds all of the Plan’s assets and executes all of the Plan’s transactions. The Company has also retained Principal Trust Company to provide participant recordkeeping and administrative services.

Eligibility

The Plan covers all employees of the Company, except those who are covered by a collective bargaining agreement that does not provide for participation in the Plan, non-resident aliens with no U.S. income, or independent contractors. All employees are eligible and automatically enrolled into the Plan upon hire, with the entry date being the first day of employment.

Contributions

Each year, participants may contribute up to 50 percent of pre-tax annual compensation, as defined by the Plan, through payroll earnings. The Plan also allows participants to make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The participants may direct their accounts into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other defined benefits or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled at a deferral rate of 6 percent unless they affirmatively elect not to participate. Auto-enrollment contributions are invested in a designated target-date fund until changed by the participant.

There are several types of contributions that can be added to a participant’s account: an employee salary deferral contribution, a Roth 401(k) contribution, an employer matching contribution, an employer discretionary contribution, and an employer qualified nonelective contribution.

The Plan contains a safe harbor non-elective contribution provision whereby the employer contributes an amount equal to 4 percent of eligible compensation.

Participants direct the investment of both their individual contributions plus their share of employer contributions into the various investment options offered by the Plan. The Company’s contributions are allocated in the same manner as that of participants’ elective contributions.

The Company may elect to make discretionary matching contributions equal to 50 percent of the first 6 percent of Plan compensation that a participant contributes to the Plan.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

In January 2024, the Plan received a transfer of \$13,072,975 representing the balances of participant accounts of the Symmetry Surgical, Inc. 401(k) Plan, which was merged with the Plan during 2023.

There were no employer discretionary or qualified nonelective contributions made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's contribution and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions (deferrals and rollovers), any safe harbor employer contributions plus actual earnings thereon, and in the Company's discretionary contribution to their accounts plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested balance, subject to DOL and Internal Revenue Service (IRS) requirements. The loans are secured by the balance in the participant's account. Loans are generally for a period not to exceed five years and bear interest at prevailing market rates, as defined in the Plan Document. Principal and interest is paid ratably through payroll deductions each pay period.

Payments of Benefits

Upon termination of service, a participant with vested balances greater than \$5,000 can elect to receive a lump-sum amount or roll over their account balance to another qualified account. Those participants whose balances exceed \$5,000 may also elect to defer the distribution of their balance. Participants who elect to have their benefit payments deferred continue to share in allocations of investment income and losses but do not share in subsequent allocations of employer contributions. Special rules apply to distributions due to death, disability, retirement, and hardship withdrawals. Participants should refer to the full Plan Documents for details.

On termination of service, participants with vested balances between \$1,000 and \$5,000 will automatically be rolled over into an individual retirement plan determined by the Company, unless the participant affirmatively elects otherwise. Participants with balances less than \$1,000 will receive a lump-sum distribution.

The Plan allows for in-service distribution upon attainment of age 59 1/2 for all deferral contributions, discretionary employer matching contributions, and rollover contributions for any reason. The Plan also allows for in-service distributions prior to the attainment of the Plan's normal retirement age due to financial hardship, as defined in the Plan Document, from vested account balances.

Forfeitures

Forfeitures can be used to offset plan administration expenses and reduce employer contributions. During the Plan year ended December 31, 2024, forfeitures of \$16,600 were used to reduce the Plan administrative expenses and forfeitures of \$50,041 were used to reduce the employer's contribution. Forfeiture account balances were \$0 and \$37,670 as of December 31, 2024 and 2023, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accounting principles followed by the Plan and the methods of applying these principles conform to U.S. generally accepted accounting principles. The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting Estimates

In preparing the financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ significantly from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information by the investment adviser, custodian, and insurance company. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the note receivable from the participant is reclassified to benefits paid to participants. There were no delinquent participant loans for the year ended December 31, 2024. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Expenses are recorded as incurred.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued, and no subsequent events have occurred requiring disclosure.

**NOTE 3 – INVESTMENTS**

The Plan investments are administered by Principal Trust Company. The following is a summary of the investment and loan information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedules, that was prepared by or derived from information provided by Principal Trust Company and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Principal Trust Company stating that information provided to the Plan Administrator by Principal Trust Company related to the following investments is complete and accurate. Accordingly, as permitted by CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator elected to have an ERISA Section 103(a)(3)(c) audit and instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedules, related to investments:

Principal Trust Company also certified to the accuracy of \$4,180,001 of net appreciation in fair value of investments, \$1,048,334 of interest and dividends, and \$67,700 of interest income on notes receivable from participants for the year ended December 31, 2024.

**NOTE 4 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their accounts.

**NOTE 5 – TAX STATUS**

The Plan is utilizing a volume submitter plan, which has been filed with the IRS and has received a favorable opinion dated June 30, 2020, from the IRS. The Plan Sponsor has not elected to apply for an individual IRS determination letter upon adoption of the Plan nor on any subsequent amendments. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, that the Plan is qualified under Section 401(a) and that the related Trust is tax-exempt as of December 31, 2024.

The Plan Document was most recently amended and restated effective February 1, 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. The Company may absorb certain costs incurred in relation to the plan administration of the Plan, such as legal and accounting issues. There were no such costs paid on behalf of the Plan during 2024. In addition, the Plan issues loans to participants that are secured by the balances in the participants' accounts. Therefore, related transactions qualify as party-in-interest transactions. All other transactions, which may be considered party-in-interest transactions, relate to normal Plan management and administrative services and the related payment of fees paid directly by the Plan. For 2024, these costs amounted to \$130,202.

**NOTE 7 – FAIR VALUE MEASUREMENTS**

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and lowest priority to unobservable inputs. The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

- *Level I:* Inputs to the valuation methodology are unadjusted quoted prices for assets or liabilities in active markets that the Plan has the ability to access.
- *Level II:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- *Level III:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

The Plan investments consist solely of mutual funds that are measured on a recurring basis using Level I inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. Mutual funds are valued at daily closing prices as reported by the fund and are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
