Note 1 - Plan Description

The following description of NSK Americas, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a voluntary savings plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and qualifies under Internal Revenue Code (IRC) Sections 401(a) and 401(k). The Plan is sponsored by NSK Americas, Inc. and is for the benefit of employees of NSK Corporation; NSK-AKS Precision Ball Company; NSK Precision America, Inc.; NSK Latin America, Inc.; NSK Steering Systems America, Inc.; Alliance Bearing Repair and Reclaim, LLC.; and BK Vibro America (collectively, the "Companies").

Participants

All full-time employees of the Companies are eligible to make contributions to the Plan in the second pay period succeeding their dates of hire. Part-time employees of the Companies are eligible to make contributions to the Plan after the 12-consecutive-month period commencing on the employee's date of employment or, thereafter, the plan year that includes the first anniversary of the employee's date of employment in which the employee is credited with 1,000 or more hours of service.

Contributions

Contributions to the Plan are invested as directed by the participants in any one or more investment alternatives offered by the Plan. Participants may make annual contributions to the Plan on a pretax or after-tax basis, up to the maximum percentage of compensation and dollar amount permissible under IRC Section 401(k).

The Plan provides for safe harbor matching contributions equal to 100 percent of employee deferrals, up to a maximum of 6.0 percent of eligible compensation.

In 2024, certain participant contributions totaling \$638 were remitted after the time frame required by the Department of Labor. The Companies plan to remit these contributions and lost earnings during 2025.

Vesting

Participants are immediately vested in their contributions, matching contributions made by the Companies, and actual earnings thereon.

The Companies' nonelective contributions vest according to the following schedule:

Forfeitures are used to reduce future employer contributions. As of December 31, 2024 and 2023, the Companies had approximately \$11,000 and \$20,000, respectively, of cumulative forfeitures available to reduce employer contributions.

Benefit Payments

Distributions are payable upon retirement, death, disability, attainment of age 59½, or termination of employment in either the form of a lump-sum amount or in various installment annuities.

Note 1 - Plan Description (Continued)

After all other withdrawal options have been exhausted, withdrawals are also available from their elective contributions to participants who experience a financial hardship to the extent necessary to relieve that financial hardship, including amounts necessary to pay any federal, state, or local income taxes resulting from the distribution.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participant Notes Receivable

Participants may borrow from their accounts subject to a maximum of \$50,000 or 50 percent of the vested portion of their account balances and a minimum of \$1,000 prescribed by the Plan and in the Internal Revenue Code. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Companies.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

Note 3 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 4 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

Note 5 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Fund

The money market fund held is valued at quoted prices reported in active markets.

Common/Collective Trust Fund

The common/collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on this investment.
