## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF PLAN

The following description of the Citizen Advocates, Inc. 401(k) Plan (the Plan) provides general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution retirement plan established to provide retirement benefits for employees of Citizen Advocates, Inc. (the Company). The Plan includes both profit-sharing and 401(k) components and, unless otherwise indicated, the provisions of the Plan are identical for both components. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The Company administers the Plan. Voya Retirement Insurance and Annuity Company (Voya) is the custodian and recordkeeper of the Plan's assets. Benefit Plans Administrative Services, Inc. (BPAS) is the Plan's third-party administrator. The Company pays all administrative expenses of the Plan, except investment management fees.

#### **Eligibility**

Employees of the Company become eligible to begin salary deferrals after completing ninety days of employment. Employees represented by collective bargaining agreements and nonresident aliens are not eligible to participate in the Plan. Employees are eligible to receive safe-harbor matching, discretionary matching and profit-sharing contributions after completing one year of service which is defined in the Plan as 1,000 hours.

#### **Contributions**

The Plan allows participants to contribute up to 100% of their annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC).

The Company provides a safe-harbor matching contribution for employees equal to 150% of participant contributions up to a maximum of 4% of participant compensation.

The Company may also make discretionary profit-sharing contributions to the Plan. There were no discretionary profit-sharing contributions made in 2024 and 2023.

#### **Participant Accounts**

Participants direct the investment of their accounts among the investment options in the Plan. Participant accounts are credited with the participant contributions, Company contributions, and actual earnings/losses thereon and charged with an allocation of administrative plan expenses. Allocations of earnings/losses and administrative expenses are based on account balances according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

## 1. DESCRIPTION OF PLAN (Continued)

### **Notes Receivable from Participants**

Participants are permitted to borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan allows for one loan to be outstanding at any given time. The loans are payable in their entirety upon the occurrence of a distributable event and bear interest at a rate comparable to local prevailing rates. The notes are secured by the balance in the participants' vested account. Principal and interest is paid ratably through monthly payroll deductions.

### **Vesting**

Participants are immediately vested in their contributions and actual earnings/losses thereon. Company contributions vest 20% per year beginning with the completion of one year of service, including one year of participation in the Plan. Participants are 100% vested after five years of service.

### **Benefits Paid to Participants**

Upon termination of service, participants receive lump-sum distributions of their vested account balances. Participants may be eligible to receive distributions in the form of annuity payments.

### **Forfeitures**

Forfeitures of non-vested account balances are used to offset employer contributions. There were no forfeitures utilized to reduce employer contributions for the years ended December 31, 2024 and 2023. The Plan has approximately \$8,140 and \$3,568 of forfeitures available offset employer contributions at December 31, 2024 and 2023, respectively.

### **Hardship Withdrawals**

Participants may request hardship withdrawals from the Plan under certain circumstances. Only that portion of a participant's account associated with participant contributions and actual earnings/losses thereon may be eligible for hardship withdrawals.

### **Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their account balances.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

### **Investments**

Investments are reported at fair value. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

All investments are participant directed.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value**

ASC 820 framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the valuation techniques used during 2024 and 2023.

*Non-benefit-responsive fixed annuity contracts:* Fair value is calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals and investment management fees.

*Mutual funds:* Fair value is based on quoted prices for identical assets in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Benefits Paid to Participants**

Benefit payments to participants are recorded when paid.

### **Notes Receivable**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance has been recorded as of December 31, 2024 and 2023. If the participant fails to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by the Company, except investment management fees.

### Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Fixed Annuity Contracts

The Plan's investment in fixed annuity contracts is comprised of guaranteed insurance contracts established between the Plan's participants and the Plan's custodian. These contracts guarantee the participants' principal and a minimum interest rate. In addition, participants have the opportunity to earn amounts in excess of the guaranteed rate.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Voya is the custodian and recordkeeper of the Plan's assets. BPAS is the Plan's third-party administrator. As such, transactions between these entities qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

#### 6. TAX STATUS

The Plan has adopted a prototype plan document offered by BPAS that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the prototype plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the prototype plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. No provision for income taxes has been included in the Plan's financial statements.
