Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the Patterson Companies, Inc. 401(k) Plan (the “Plan”) provides general information about the Plan’s provisions. Patterson Companies, Inc. (the “Company”) is the plan sponsor. Participants should refer to the plan document and summary plan description for a complete description of the Plan’s provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan covering substantially all U.S. employees of the Company and certain subsidiaries. The Plan is designed both as a stock bonus plan which meets the requirements of an employee stock ownership plan under the Internal Revenue Code (the “Code”) of 1986 Section 4975(e)(7) (the “ESOP Component”) and a profit sharing plan (the “Profit Sharing Component”) with a cash or deferral arrangement under Section 401(k).

Profit Sharing Component

Unless specifically excluded by the terms of the Plan, all full-time and part-time employees are eligible to become participants in the Plan on the next day following the date on which the employee has completed one hour of service. Prior to January 1, 2024, employees classified as temporary or casual are eligible to become participants after 1,000 hours of service during an eligibility computation period.

Notwithstanding these Plan requirements, an eligible employee classified as a casual part-time employee, defined as an employee who accrues less than twenty (20) hours of service per week, will satisfy the Plan’s requirements for purposes of being eligible to make elective deferrals upon the close of the first period of three consecutive 12-month eligibility computation periods or in which the Employee has completed at least 500 hours of service.

ESOP Component

With respect to participation in the ESOP Component of the Plan, an employee who was not a participant in the ESOP on June 30, 2021, shall be ineligible to participate in the Plan’s ESOP Component.

The Company has delegated the Plan Administrative Committee to be responsible for the general administration of the Plan. Fidelity Management Trust Company and Delaware Charter Guarantee and Trust Company (d/b/a “Principal Trust Company”) are the trustee and record-keeper for the Plan for 2024 and 2023, respectively. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

1. Description of Plan (continued)

Plan Merger

Effective December 31, 2023, the Company merged the Patterson Companies, Inc. Employee Stock Ownership Plan (the “ESOP”), another plan sponsored by the Company, into the Plan.

Contributions

Profit Sharing Component

Subject to certain limitations, participants may contribute between 1% and 50% of their total annual compensation, as defined in the Plan document. Any participant who has not made an election to contribute to the Plan will be automatically enrolled and the participant’s deferral will be set at 3% of eligible compensation until changed either by the participant or by means of the automatic escalation described in this section. Participants may modify deferral percentages at any time. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Plan provides for a qualified Safe Harbor matching contribution of up to 4% of the participant’s compensation. The Company may make profit sharing and/or additional matching contributions at the discretion of the Company’s board of directors. No such discretionary contributions have been made to the Plan for the 2024 and 2023 plan years. All contributions are subject to certain limitations of the Code.

The Plan provides for an automatic escalation feature. Under this provision, a participant shall be deemed to have increased the rate of his/her elective deferral contributions by 1% of the participant’s compensation effective on each July 1, but in no event shall the automatic increase cause the participant’s elective deferral contribution percentage to exceed 15% of their compensation.

The Plan allows a participant to contribute into the Plan any balances from another qualified benefit plan (“rollover contributions”).

Participants may direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. Participants that are automatically enrolled have their contributions initially invested in the Plan’s default investment option (Vanguard Target Retirement Funds) until changed by the participant. The Company’s contributions (if any) are invested in the same manner as that of the participant’s elective contributions.

ESOP Component

The Company does not anticipate making contributions to the ESOP Component; however if such contributions are made, the Company, in its sole discretion, will make contributions on behalf of each eligible participant who earned 1,000 hours of service during the Plan Year, and is employed

on the last day of the Plan year. However, a Participant who terminates employment with the Company during the Plan year due to normal retirement, disability or death does not have to complete a year of service or be employed on the last day of the Plan Year to be eligible to share in such contribution for the Plan year. Such contributions will be in the proportion that each eligible participant's compensation bears to the compensation of all eligible participants.

Participant Accounts

A separate account is maintained for each participant in the Plan. Each participant's account is credited with the participant's contributions, the Company's matching contributions and the Company's discretionary profit sharing and/or matching contributions (if any) and allocations of Plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Expenses incurred in the administration of the Plan are charged against the participant's account balance unless the Company elects to pay such expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company's qualified Safe Harbor matching contributions. Vesting in the Company's discretionary profit sharing or discretionary matching contributions (if any) are subject to a 5-year graded vesting schedule. A participant is 25% vested in Company discretionary profit sharing and matching contributions and related earnings after two years of service. The vesting percentage increases by 25% per year until participants become fully vested after completing five years of service.

Contributions made to a participant's stock account in the ESOP Component vest at a rate of 100% after three years of service; with the exception of that portion of the participant's stock account attributable to the Safe Harbor non-elective contribution which vests at a rate of 100% after two years of service.

For both the Profit Sharing Component and the ESOP Component, participants may become 100% vested upon attainment of age 65, if still employed by the Company, termination due to disability or death while employed, or upon termination of the Plan.

1. Description of Plan (continued)

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances of terminated participants' non-vested accounts are used to pay plan expenses or reduce future Company contributions; with any remaining balances allocated among eligible participants. The total amount of forfeitures credited to participants were \$0 and \$613,849 for the Plan years ending December 31, 2024 and 2023, respectively.

Participant Loans

Loans to participants are permitted under the Plan. Plan loans are limited to participant elective deferral contributions and may not exceed 50% of the Participant's vested balance; provided that in no event will such loans exceed \$50,000. Only one loan may be outstanding to a participant at one time.

Payment of Benefits

Upon separation from service with the Company due to death, disability, retirement or termination, a participant, or their beneficiary, whose vested account balance exceeds \$7,000 (\$5,000 in 2023) may elect to receive either a lump-sum or installment payments on a quarterly or annual basis. A participant whose vested account balance is \$7,000 (\$5,000 in 2023) or less and has not commenced receiving installment payments will automatically receive an immediate lump-sum distribution (in a manner consistent with Code § 401(a) (31)) equal to their vested account balance.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan document. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document. Hardship withdrawals are strictly regulated by the Internal Revenue Service (the "IRS") and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Additionally, participants who are age 59 1/2 or older may withdraw all or a portion of their vested account balance for any reason.

1. Description of Plan (continued)

Administrative Expenses

Participants pay a monthly administrative fee totaling \$39 (\$55 in 2023) annually. The Plan pays other administrative expenses relating to the Plan, which are reflected in the statement of changes in net assets available for benefits as administrative expenses. In addition, investment expenses are paid by the Plan and are netted with investment income.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions (if any) at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid. There are no participant withdrawals from the Plan that have been approved but not paid as of December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedules. Actual results could differ from those estimates. Notwithstanding as stated, the assets held by the Plan are stated at fair value determined by quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities. As such it is not likely reasonable that any change in the values will occur in the near term.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Funding and Contributions

Contributions from participants are deposited at least semi-monthly with the trustee.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023 and net appreciation in fair value, investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the trustee of the Plan, Fidelity Management Trust Company and Delaware Charter Guarantee and Trust Company (d/b/a "Principal Trust Company") for 2024 and 2023, respectively.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical

4. Fair Value Measurements (continued)

assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs to valuation other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs to valuation for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated July 27, 2017, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt. Notwithstanding the preceding, the plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-interest Transactions

Certain of the Plan's assets are invested in funds managed by the trustee of the Plan and the Company's common stock. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

8. Plan Amendments

During the Plan year, the Company duly amended the Plan effective January 1, 2025, to permit an in-service distribution for either a qualified birth or adoption, recovery from a qualified disaster or for a victim of domestic abuse. The Company further amended the Plan effective January 1, 2025, to extend by an additional amount that a participant between the age of 60 and 64 may defer as a catch-up contribution. The Plan was also duly amended to introduce, effective January 1, 2025, the ability for a participant to convert their current vested, pre-tax contributions into a Roth Conversion Account for the purposes of being treated as if originally contributed in the form of an after-tax Roth Contribution.

9. Subsequent Events

Management evaluated subsequent events for the Plan through October 10, 2025, the date the financial statements were available to be issued. On April 17, 2025, the Company was acquired by Patient Square Capital pursuant to the Agreement and Plan of Merger, dated December 10, 2024. As a result of this transaction, the Company's common stock was delisted from the NASDAQ stock exchange, and the Company was no longer a publicly-traded corporation. The Plan was respectively amended to discontinue investing in Company stock and making contributions to the ESOP Component of the Plan. Company stock in the ESOP Component of the Plan at the time of the acquisition was converted to cash and transferred to the Profit Sharing Component of the Plan.
