Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the TAK Broadband, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter-Plan Merger

As discussed in Note 2 to the financial statements, delegates from TAK Broadband, LLC, the plan sponsor, and the plan sponsor's majority owner, voted in June 2025 per the Delegation of Authority to merge the TAK Broadband CA, LLC 401(k) Plan into the Plan. Transfer of plan assets has not yet occurred. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

Note 1. Description of Plan

The following description of TAK Broadband, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General: The Plan was established on May 1, 2015, and is a defined contribution plan covering substantially all employees of TAK Broadband, LLC, TAK Communications WI LLC, TAK West Shore LLC, StarTAK Fiber, LLC, TGS Fiber, LLC, and BAU Oil Services Corp (collectively, the Company). Effective January 31, 2024, BAU Oil Services Corp is no longer a participating employer of the Plan. Employees are eligible to participate after completing three months of service. Full-time employees are eligible for Company discretionary matching contributions and discretionary profit sharing contributions after they have completed three months of service. Entrance dates are the first day of each month coinciding with or following the eligibility date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan name change: Effective August 12, 2024, the name of the Plan was changed from TAK Communications, Inc. 401(k) Plan to TAK Broadband, LLC 401(k) Plan.

Contributions: Participants may elect to contribute to the Plan, in the form of pretax or after-tax (Roth) deferrals, up to 100% of their eligible compensation, as defined in the plan documents, up to the maximum amount allowable by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company, in its sole discretion, may make discretionary matching contributions and discretionary profit sharing contributions. For the year ended December 31, 2024, the Company approved a 3% discretionary matching contribution for participants that contributed 6% or more of eligible compensation to the Plan. For the year ended December 31, 2024, no discretionary profit sharing contribution was made. Contributions are subject to certain IRS limitations.

Effective May 1, 2024, the Plan was amended to include an auto-enroll provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral set at 2% of eligible compensation which shall increase 1% per year on the first day of the plan year up to a maximum of 10%, unless otherwise elected by the participant. Automatically enrolled participants have their contributions invested in accordance with the default investment alternatives established under the Plan, unless otherwise elected by the participant.

Participant accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited or charged with the participant's salary deferral contributions, allocations of the Company's discretionary contributions, if any, investment results and administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. Participants direct the investment of their contributions into various investment options offered by the Plan, which are more fully described in the Plan's literature. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan (Continued)

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary employer matching and profit sharing contribution portions of their accounts is based on years of continuous service. Vesting is based on years of credited service as set forth in the following table:

Forfeited accounts: Forfeitures are used to fund future Company contributions or pay administrative expenses. During the year ended December 31, 2024, \$38,678 from forfeited nonvested accounts were used to fund Company contributions and \$4,991 were used to pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,573 and \$0, respectively.

Notes receivable from participants: Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note repayment terms generally may not exceed five years. Only one note per participant may be outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at the rate of one percentage point over prime interest rate as determined by the Plan document. Principal and interest are paid ratably through weekly payroll deductions. Notes receivable outstanding at December 31, 2024, bear interest rates ranging from 4.50% to 9.50% and are due through April 2029.

Payment of benefits: Withdrawals are allowed in the event of termination, death, retirement, military reservist called to active duty or attainment of age 59½. The Plan also allows hardship distributions, as defined, subject to certain restrictions. Payments are made in the form of a lump-sum distribution or installments. If a participant terminates employment and the individual's vested interest in the Plan does not exceed \$7,000 and is greater than \$1,000, the distribution will be automatically rolled over into an individual retirement account, unless the participant elects to receive a lump-sum distribution. If the vested interest is less than \$1,000, the distribution will be paid out in a lump sum. If the vested interest exceeds \$7,000, the participant must consent to any distribution of their account.

Note 2. Significant Accounting Policies

Basis of presentation: The accompanying financial statements have been prepared on the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of asset and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes to Financial Statements

Note 2. Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2024 and 2023. Delinquent participant notes are recorded as distributions based upon the terms of the Plan agreement.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Payments of benefits: Benefits are recorded when paid.

Excess contributions payable: Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Administrative expenses: Operating expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the individual participant's account. Investment-related expenses are included as an offset to net appreciation (depreciation) in the fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

Effective June 1, 2025, the Plan changed its third-party administrator from DWC—The 401(k) Experts to Blue Ridge Associates.

In June 2025, the merger of the TAK Broadband CA, LLC 401(k) Plan into the Plan was approved.

Principal Life Insurance Company also certified to the completeness and accuracy of \$696,613 of net appreciation in fair value of investments and \$3,397 of other income related to the aforementioned investments for the year ended December 31, 2024.

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. The following is a description of the valuation methodology used for assets measured at fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts are primarily valued at net asset value (NAV) per share used as a practical expedient, based on quoted market prices for the underlying securities or similar instruments. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Collective trust funds: Collective trust funds are valued using the unit value based on the NAV of the underlying pool of securities for each fund. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 4. Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, certain investments that were measured at NAV per share (or its equivalent), as a practical expedient, have not been classified in the fair value hierarchy.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 6. Tax Status

The Plan has adopted a nonstandardized preapproved plan sponsored by DWC—The 401(k) Experts. DWC—The 401(k) Experts has received an opinion letter from the IRS, dated September 6, 2023, as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has no uncertain tax positions that require adjustment to or disclosure in the financial statements. Therefore, no provision or liability for income taxes is included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party Transactions and Party-in-Interest Transactions

The Company provides certain administrative services to the Plan for which no fees are charged. DWC—The 401(k) Experts and Principal Life Insurance Company provides certain administrative and asset management services to the Plan. Certain Plan investments as of December 31, 2024, are pooled separate accounts and collective trust funds managed by Principal Life Insurance Company. These transactions qualify as party-in-interest transactions.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 9. Prohibited Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit \$696 of contributions within the required time frame as stated by the DOL's regulations. The Plan Sponsor has deposited lost earnings to correct this failure in 2025 and has filed Form 5330 and paid applicable excise tax to the IRS. The correction and excise taxes were made from the Plan Sponsor's assets and not from the assets of the Plan.
