Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the Cheyenne 401(k) Plan (the Plan) provides general information about the Plan's provisions. Cheyenne Petroleum Company is the plan sponsor. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution multiple employer plan covering employees of Cheyenne Petroleum Company as well as three participating employers, Summer Road, LLC, North Bay Associates, and Kokino, LLC (collectively, the Employers or the Companies). Employees who have attained age 18 are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Voya Retirement Insurance and Annuity Company serves as the custodian and record-keeper of the Plan.

Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined, subject to the maximum amount that would not cause the Plan to violate the provisions of the Actual Deferral Percentage Test or the Maximum Annual Additions as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Companies contribute a discretionary matching contribution equal to a uniform percentage of each participant's elective deferrals as determined by the Employers each year. For 2024, the Employers approved a discretionary matching contribution in an amount equal to 100% of the participant's salary deferrals provided that the aggregate match does not exceed 6% of the participant's eligible compensation. Additional discretionary matching contributions may be contributed at the discretion of the Employers. No such additional discretionary matching contributions were contributed for 2024. All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. The Companies' contributions are invested in the same manner as that of the participant's elective contributions.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and the Companies' contributions and allocations of plan earnings and is charged with an allocation of plan losses and administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' contributions is based on years of continuous service. A participant vests at 20% per year and is 100% vested after five years of credited service.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. If a participant is rehired within five consecutive one-year break in service periods, the forfeited contributions are reinstated. Forfeited balances of terminated participants' non-vested accounts are used to reduce future contributions of the Companies. The unallocated forfeited balances were \$15,293 as of December 31, 2024, and \$94,000 as of December 31, 2023. Forfeitures used to reduce the Companies' contributions for 2024 were approximately \$125,000.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their non-forfeitable account balance. Loan terms range from less than one year up to five years. The \$50,000 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at a rate equal to two percentage points above the prime rate at the date of issuance as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions over not more than five years, except for loans to purchase a principal residence. If a participant terminates employment with the Companies, the loan becomes due and payable. If the loan is not repaid, it will automatically be treated as a distribution to the participant after three months.

1. Description of Plan (continued)

Payment of Benefits

During employment, participants may not withdraw balances until attainment of age 59-1/2, except in the event of financial hardship as described below. Participants may request distribution of their vested accounts upon separation from service with any of the Companies due to death, disability, retirement, or termination.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting hardship withdrawal.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Companies, as provided by the Plan's provisions.

Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

During the plan year ended December 31, 2024, the Plan experienced a significant reduction in the number of participants due to an asset sale of the plan sponsor resulting in a company wide reduction in force. Based on the facts and circumstances, including a turnover rate exceeding 20%, management has determined that a partial plan termination occurred. As a result, all affected participants became fully vested in their account balances as of the date of the partial plan termination, in accordance with IRC Section 411(d)(3). The Plan Sponsor has ensured that the rights of all affected participants to their accrued benefits, to the extent funded, are non-forfeitable.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represents participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for a fully benefit-responsive investment contract) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

The Plan's investments in pooled separate accounts are valued at the last reported net asset value on the last business day of the year, as determined by the issuer of the investment.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value, fully benefit-responsive investment contract at contract value, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

4. Fair Value Measurements (continued)

- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest-level input that is significant to the fair value measurement in its entirety.

There are no restrictions on the pooled separate accounts.

5. Fully Benefit-Responsive Investment Contracts

The Plan holds a traditional investment contract (the Voya Fixed Account) with Voya Retirement Insurance and Annuity Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

5. Fully Benefit-Responsive Investment Contracts (continued)

The contract issuer of the Voya Fixed Account is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts depends on the third-party issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreement without the consent of the issuer

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

7. Related-Party and Party-in-Interest Transactions

The Plan holds units of pooled separate accounts managed by Voya Financial, an affiliate of Voya Retirement Insurance and Annuity Company, the custodian and record-keeper of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

The Plan trustees are key management members of the plan sponsor. They hold positions in the plan sponsor entities that result in them having control or significant influence over the financial or operating policies of the plan sponsor.

8. Tax Status

The underlying non-standardized pre-approved plan has received an advisory letter from the IRS dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS non-standardized pre-approved advisory letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

Effective January 1, 2025, the plan sponsor of the Plan changed to North Bay Associates LLC. An additional participating employer, Moxietec LLC, was added to the Plan effective January 1, 2025. Management evaluated subsequent events for the Plan through October 2, 2025, the date the accompanying financial statements were available to be issued.
