***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Hollingsworth Richards Automotive Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### **Note 1 - Description of Plan -**

The following description of the Hollingsworth Richards Automotive Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### Description of Plan

The Plan is a multiple employer defined contribution plan covering qualified employees of River City Ford, Inc. dba Hollingsworth Richards Ford; H&R Motors, Inc. dba Hollingsworth Richards Collision Center; J.W. Richards, Inc. dba Richards Honda; and Hollingsworth Richards, LLC dba Honda of Covington (collectively, the “Company”) who have reached age twenty-one and completed one year of service. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA). Management oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

#### Contributions

Participants may contribute a portion of their eligible compensation to the Plan subject to certain limitations of the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employees are automatically enrolled into the plan at a 3% deferral rate upon becoming eligible to participate in the Plan and may stop contributions at any time and re-start or change contributions at the beginning of each calendar quarter. All participants who had an automatic deferral will be subject to an automatic increase of 1% each year until they reach 6% unless they elect to change this amount. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary match and a discretionary profit-sharing contribution. During the year ended December 31, 2024, the Company matched 25% of the employees’ deferrals up to 1% of the employee’s pay. The employer contributions totaled \$134,019 for the year ended December 31, 2024. There were no discretionary profit-sharing contributions during 2024.

#### Participant Accounts

Each participant's account is credited or charged with the participant's contribution and their allocation of the respective adopting employer’s contribution, the Plan’s investment earnings or losses, and certain plan administration costs not covered by the respective adopting employers. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in their remaining accounts, plus earnings, is based on a graduated schedule beginning at 20% vesting after two years of continuous service and becoming fully vested after six years of credited service.

#### Payment of Benefits

Upon termination of service due to death, retirement or termination, participants are entitled to receive a lump sum payment equal to the value of their vested account balance or annual installments.

### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4 and \$5, respectively. These accounts can be used to reduce future employer contributions, to pay administrative expenses of the Plan not covered by the Plan sponsor or may be reallocated to participants' accounts. During 2024, forfeited nonvested accounts were used to reduce administrative expenses by \$11,885.

## **Note 2 - Summary of Accounting Policies -**

### Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting. Investments are valued at current fair value as quoted by the custodian of the Plan. All assets of the Plan are participant directed.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. As of December 31, 2024 and 2023, the Plan had no fully benefit-responsive investment contracts.

### Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, and such differences may be material.

### Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net investment income (loss) includes dividends, gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Benefits are recorded when paid.

### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### Risks and Uncertainties

The Plan provides for various investment options in any combination of selected funds held by the trustee. The funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of the funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees for certain transactions are charged directly to the account of the participant included in administrative expenses. Investment related expenses are included in net investment income (loss).

### Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 18, 2025, the date which the financial statements were available to be issued.

### **Note 3 - Plan Termination -**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

### **Note 4 - Tax Status -**

The Company has adopted a prototype plan which received a favorable determination from the Internal Revenue Service. The Plan itself has not separately applied for recognition of tax-exempt status. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2021.

### **Note 5 - Fair Value Measurements -**

The fair value measurement accounting literature provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Guaranteed Interest Contract:** The Plan holds a traditional guaranteed investment contract that is not fully benefit-responsive due to certain withdrawal restriction provisions of the contract and, accordingly, it is measured at fair value. Fair value is estimated on an annual basis for financial statement reporting purposes only, as participant transactions are typically executed at contract value. The fair value of the contract has been estimated to approximate contract value, based on the contract's

withdrawal and termination provisions, since the contract, by its terms, is not transferable (level 3 inputs). In addition, management has determined that no adjustment from contract values is required for credit quality considerations.

Pooled Separate Accounts - The fair values of participation units held in the pooled separate accounts are based on their net asset values as reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
