INDEPENDENT AUDITORS' REPORT

To the Trustees of
The Children's Clinic Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Children's Clinic Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Children's Clinic Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of The Children's Clinic Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a contributory 401(k) and profit sharing plan which was established for the benefit of substantially all eligible employees of The Children's Clinic Serving Children and Their Families (the "Organization"). The Plan meets all requirements for profit sharing plan qualification under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Eligibility

Employees who are at least 21 years of age are eligible to make deferral contributions immediately upon hiring, subject to the Plan's monthly entry dates. Employees are eligible to receive Organization contributions following the completion of one year of service (with at least 1,000 hours) and attainment of age 21, prior to monthly entry dates. Employees covered under a collective bargaining agreement, non-resident aliens, per diem employees, or leased employees are not eligible to participate in the Plan.

3. Contributions

Participants may elect to contribute on a tax-deferred basis and/or make Roth contributions, up to the maximum deferral limit per Section 402(g)(1) of the IRC. In addition, participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make "catch-up" contributions.

The Organization makes a safe harbor contribution of not less than 3% of a participant's eligible compensation. Additional discretionary non-elective contributions may be made by the Organization based upon the participant's classification within a service group. Safe harbor and discretionary non-elective contributions totaled \$700,262 and \$476,321, respectively, for the year ended December 31, 2024.

4. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Organization contributions as desired, in any of a variety of investment options held by John Hancock Life Insurance Company (USA) ("John Hancock"), as chosen by the Organization. Participants may change their investment options daily.

5. Participant Accounts

Each participant's account is credited with employee contributions, safe harbor contributions, discretionary non-elective contributions, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. The discretionary non-elective contributions are based on a percentage of compensation for each employee classification group. Plan earnings and administrative expenses are allocated based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

6. Vesting

Participant contributions, rollovers, Organization contributions, and actual earnings on all such contributions are fully vested at all times.

7. Notes Receivable from Participants

The Plan permits participants to borrow from their account a minimum of \$1,000 up to 50% of their vested account balance not to exceed \$50,000, reduced by the participant's highest outstanding loan balance during the prior twelve-month period. The loans are secured by the balance in the participant's account. Loans must be repaid within five years with interest at prime plus 2% per annum. A maximum of two loans is allowed to be outstanding at any time.

8. Benefit Payments

Upon termination of service, retirement, permanent disability, or death, a participant or a participant's beneficiary is entitled to the total value of the participant's account balance in the form of a lump sum payment. Installment payments are not permitted except for required minimum distributions. Hardship distributions from participants' elective deferral accounts are permitted if certain criteria are met.

9. Administrative Expenses

Administrative expenses incurred by John Hancock and other service providers have been paid directly out of plan assets. Audit fees are paid directly by the Organization as a benefit to the employees. Investment related expenses are included in net appreciation/depreciation in fair value of investments. Expenses paid by the Organization are excluded from these financial statements.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Plan Administration

The Organization is the plan sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

4. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note D for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

5. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

6. Payment of Benefits

Benefits are recorded when paid.

7. Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation and Employer contributions are based on this same compensation.

NOTE C - CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock (the custodian of the Plan), a qualified institution.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE D - FAIR VALUE MEASUREMENTS (Continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: The net asset value (NAV) of these accounts is based on the market value of its underlying investments and is used as a practical expedient to estimate fair value. The NAV is not a publicly quoted price in an active market. The practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Guaranteed interest accounts: Valued at contract value, which approximates fair value. Contract value represents contributions made under the contract plus compound interest earned less participant withdrawals and administrative expenses. Interest is earned over a defined term of 3, 5 or 10 years, provided all contributions remain in the account until maturity. Interest rates are established on the first day of the month and apply to all contributions made in the account during the period. Withdrawals taken prior to the end of the guarantee period may be subject to a market value adjustment. For guaranteed interest accounts held at December 31, 2024, the average crediting rate was 2.02%.

The primary investment objective of the guaranteed interest accounts is to seek to achieve investment income consistent with the preservation of principal, primarily through investments in federal and other government bonds, corporate bonds and commercial mortgages. Transfers between guaranteed interest accounts are not permitted. The guaranteed interest accounts do not have unfunded commitments relating to their investments, or any significant restrictions on participant-directed withdrawals. Participant-directed transfers between a guaranteed interest account and other investment options may be subject to a market value adjustment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held by John Hancock. John Hancock is the custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

NOTE F - PLAN TERMINATION

Although it has not expressed such intent, the Organization reserves the right, at any time, to terminate the Plan by action of its Board of Directors, subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan would cease and the assets of the Plan would be distributed to the participants based on each individual participant's interest in the Plan.

NOTE G - TAX STATUS

The Organization adopted a non-standardized pre-approved profit sharing plan with CODA ("pre-approved plan") which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the pre-approved plan is designed and in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator and the Plan's advisors believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE I - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 2, 2025 the date the financial statements were available to be issued.
