## Independent Auditors' Report

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Runtal North America, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Description of the Plan

The following description of Runtal North America, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Runtal North America, Inc., Zehnder America, Inc., and Zehnder Corporate Americas, Inc. (collectively, the "Company") who have completed at least one hour of service during the first two months of service or completed a year of service, if earlier and are age 21 years or older. Management of the Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Voya International Trust Company became the Plan's trustee and custodian on July 18, 2024, and Voya Financial became the recordkeeper. Empower Trust Company was the Plan's trustee and custodian prior to July 18, 2024 and Empower Retirement was the recordkeeper.

**Contributions:** Each year, participants may defer up to 100% of eligible compensation, as defined by the Plan, on a pretax basis or as a Roth deferral. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified plans, as defined in the Plan. In order to receive employer discretionary matching contributions or employer contributions under the Plan, a participant must complete at least 500 hours of service during the first 6 months of employment and be employed on the last day of the Plan year. During 2024, the Company matched the first 2% of base compensation that a participant contributed to the Plan and 100% of employee shipping bonus compensation that the participant contributed to the Plan.

**Investment options:** Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan, which include mutual funds and a fully benefit-responsive investment contract.

**Participant accounts:** Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary contributions and Plan earnings (losses). Participant accounts are charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions as well as the actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after four years of credited service. In the event of retirement, disability, or death, the participant shall be 100% vested in their employer matching contribution account.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan transactions are treated as a transfer from (to) the investment fund to (from) the loan fund. Loans must be repaid within five years unless such loan is for the purchase of a participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at 2% over the prime interest rate. The interest charged on notes receivable from participants ranges from 6.00% to 10.50% for 2024. Principal and interest are paid ratably through payroll deductions.

#### Note 1. Description of the Plan (Continued)

**Payment of benefits:** On attainment of age 59 ½, a participant shall be entitled to receive a distribution of all or any portion of the participant's vested account balance. On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or a partial lump sum of less than the entire vested interest over a reasonable period if the participant's vested account balance exceeds \$5,000. In addition, hardship distributions are permitted if certain criteria are met.

**Forfeitures:** Upon participant termination, the non-vested portion of the participant's account, as defined by the Plan, is forfeited. Forfeitures may be used to offset Company contributions or to pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,350 and \$26,598, respectively. During 2024, employer contributions were reduced by \$4,099 from forfeited, non-vested accounts.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. The modified cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the Department of Labor. The carrying values of the Plan's investments have been adjusted to fair value. In 2023, the Plan changed to the modified cash basis of accounting to report contributions when received.

**Use of estimates:** The preparation of financial statements in conformity with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying disclosures. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when paid. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the plan document.

**Payment of benefits:** Benefits are recorded when paid.

**Note 2. Summary of Significant Accounting Policies (Continued)**

**Administrative expenses:** The Company pays certain administrative expenses of the Plan. Any expenses not paid by the Company are the responsibility of the Plan. The Company also provides certain administrative services at no cost to the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Note 3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4. Summary of Financial Information Certified by the Plan's Trustee (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company and Voya Retirement Insurance and Annuity Company (the trustees of the Plan).

Certain information related to notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including notes receivable from participants held at December 31, 2023, and interest income on notes receivable from participants from January 1, 2024, through July 18, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

#### Note 5. Fully Benefit-Responsive Investment Contract

In 2024, the Plan entered into a group annuity contract with Voya International Trust Company ("Voya"), the Voya Fixed Account. In 2023, the Plan entered into a group annuity contract with Empower Annuity Insurance Company of America ("EAICA"), the Empower Investments Fixed Account – Series Class VI. These contracts are traditional investment contracts. Under the contracts, the participant's principal and interest are fully guaranteed by the general account assets of Voya and EAICA, respectively. These contracts meet the fully benefit-responsive investment contract criteria and are reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contracts because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

**Note 5. Fully Benefit-Responsive Investment Contract (Continued)**

The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent for the Empower Investments Fixed Account – Series Class VI and one percent for the Voya Fixed Account. Each quarter an interest rate is established for new deposits received in that quarter and that interest rate is guaranteed for the remainder of the current calendar year. A renewal interest rate is then established each subsequent calendar year and is guaranteed for one calendar year. The contract does not have a maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (a) the complete or partial termination of the Plan; (b) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of a sale or liquidation of a subsidiary or a division or as a result of group layoffs or early retirement programs. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 7. Party in Interest Transactions**

Certain Plan investment options are investments offered by Voya International Trust Company, the current trustee of the Plan. Certain Plan investment options are investments offered by Empower Financial Services, Inc., an affiliate of Empower Trust Company, the trustee of the Plan through July 18, 2024. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

**Note 8. Delinquent Participant Contributions**

During the years ended December 31, 2024 and 2023, the Company inadvertently failed to remit participant deferrals totaling \$33,222 and \$1,391, respectively, to the Plan within the timeframe required by the Department of Labor. Although the deferred amounts were subsequently credited to participant accounts during 2024, the accounts were not credited with the investment income that would have been earned had the contributions been deposited timely.

The Company is currently calculating the lost earnings associated with the late remittance. Once determined, these earnings will be contributed to the affected participant accounts. The Company intends to complete the correction in accordance with applicable regulatory guidance.

#### **Note 9. Tax Status**

The Plan has adopted the Epic Advisor, Inc. Non-standardized Pre-approved 401(k) Profit Sharing Plan (“Epic Plan”). The non-standardized pre-approved plan received a favorable advisory letter dated June 30, 2020, from the Internal Revenue Service, which determined that the prototype was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **Note 11. Reconciliation of Financial Statements to Form 5500**

There were no reconciling items between the financial statements and Schedule H of the Form 5500.

#### **Note 12. Subsequent Events**

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued.
