As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from Fidelity Management Trust Company, a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

#### *General*

Propelled Brands 401(k) Plan (the Plan) is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on June 1, 1992, and amended and restated October 29, 2021, covering substantially all employees of Propelled Brands Franchising, LLC (the Company or Plan Administrator). Effective January 22, 2024, the Plan was amended and renamed as the Propelled Brands 401(k) Plan, formerly the FASTSIGNS International, Inc. 401(k) Plan, and the Plan Administrator is now Propelled Brands Franchising, LLC, formerly FASTSIGNS International, Inc.

#### *Administration*

The Company is responsible for the administration and operation of the Plan. The Plan's Trustee is Fidelity Management Trust Company (the Trustee or Fidelity). Fidelity Workplace Services, LLC serves as the record-keeper of the Plan. The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### *Eligibility*

Employees become eligible for participation immediately upon hire and upon attaining the age of 18, as defined by the plan document. Effective January 1, 2025, the Plan was amended to allow employees attaining the age of 21 to be eligible for participation in the Plan. Employees covered by a collective bargaining agreement, leased employees, and nonresident aliens are excluded from participating. Effective January 1, 2025, the Plan was amended to also exclude interns. Employees become eligible for employer non-elective contributions upon completion of six months of service.

#### *Contributions*

The Plan is funded through participant elective deferrals and Company discretionary matching contributions. Participants may elect to contribute up to 60% of annual pre-tax compensation, subject to maximum limitations imposed by the Internal Revenue Code (IRC). The Plan allows for after-tax Roth contributions, subject to the same limitations. Employees who are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are also eligible to make catch-up contributions up to 100% of eligible compensation, subject to the maximum limitation imposed by the IRC. Rollover contributions representing distributions from other qualified defined benefit or defined contribution plans are permitted.

The Plan has an automatic enrollment feature. Unless otherwise elected, eligible employees will be automatically enrolled in the Plan and will have a contribution of 3% of pretax compensation. Contributions will be mapped into a target date retirement fund based on the participant's age, unless elected otherwise by the participant. All participants who are automatically enrolled into the Plan will have their contributions increased by 1% per year each July up to a 6% maximum increase.

The Plan also allows for Company discretionary matching contributions to be determined by the Company. The Company made discretionary matching contributions on 50% of the first 6% of deferred participant contributions for the year ended December 31, 2024.

### *Payment of Benefits*

Upon normal retirement age, death, disability, or termination, a participant's benefits are payable in a lump-sum amount or installment payments equal to 100% of the participant's vested account balance as of the valuation date of such event. In addition, distributions may be made based on financial hardship. Account balances of \$1,000 or less at the time of the distribution will be "cashed out" as an involuntary lump sum payment.

### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of net Plan earnings or losses. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### *Vesting*

Participants are immediately vested in employee pre-tax and after-tax contributions, rollover contributions, and any earnings thereon. Vesting of Company discretionary matching contributions and earnings thereon is based on years of continuous service. Participants vest 20% per year and are 100% vested after five years or upon occurrence of the participant's retirement, death, or disability, as defined by the plan document. Effective January 1, 2025, the Plan was amended to have participants 100% vested in discretionary matching contributions.

### *Notes Receivable from Participants*

Borrowings are available for all participants. Notes receivable from participants are limited to a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, subject to certain restrictions as defined by the Internal Revenue Service (IRS). A participant may only have two notes outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at a rate determined reasonable by the Plan Administrator. Any note must be repaid within five years unless for the purchase of a primary residence, in which case the repayment period may not exceed ten years. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and fees paid related to

benefits paid to participants are charged directly to the participant's account and are included in administrative expenses.

### ***Forfeitures***

Forfeitures are available to reduce future Company contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts available for future use totaled \$37,232 and \$12,419, respectively, and are reported as a component of net assets available for benefits. For the year ended December 31, 2024, \$26,555 and \$2,477 of forfeitures were used to reduce Company contributions and pay plan expenses, respectively.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participants' accounts shall become 100% vested, including Company contributions, subject to payment of liquidation costs and expenses.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Contributions and Contribution Receivables***

Contributions are recorded on the accrual method of accounting. Contribution receivables are obligations arising from amounts owed to the Plan from participants or the Company that have not been included in the Plan's investments at year end.

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Risks and Uncertainties***

Plan assets are invested in funds and securities as directed by plan participants. These investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Accordingly, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

## **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Level 2* - Significant observable inputs other than quoted prices in active markets for which inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

*Money Market Fund* - Money market funds are valued at the daily closing price as reported by the fund.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent with other market participants; even so, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

### 5. Related Party and Party-in-Interest Transactions

Certain of the Plan's investments are managed by the Trustee or an affiliate of the Trustee; therefore, these transactions qualify as party-in-interest transactions. A portion of fees paid by the Plan for the investment management services are included in net appreciation or depreciation in fair value of investments. The Plan issues notes receivable to participants, which are secured by the participant's account balances. These transactions also qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

Certain administrative functions of the Plan are performed by an officer or employees of the Company. No such officer or employee receives compensation from the Plan.

### 6. Tax Status

The Plan is based on a nonstandardized pre-approved profit sharing plan with cash or deferred arrangement (CODA) developed by FMR LLC, which received a favorable advisory letter dated June 30, 2020 from the IRS stating that the nonstandardized pre-approved profit sharing plan with CODA constitutes a qualified plan under Section 401 of the IRC. The Plan Administrator believes the Plan, as adopted and amended, is operating within the guidelines of the IRC, and continues to be tax exempt. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

Effective January 1, 2025, the Plan was amended to allow employees attaining the age of 21 to be eligible for participation in the Plan. Employees covered by a collective bargaining agreement, leased employees, interns, and nonresident aliens are excluded from participating. Employees become eligible for employer non-elective contributions upon completion of six months of service. Discretionary employer matching contributions are 100% vested immediately.

We have evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.
