**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of EDC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the EDC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan and trust agreements for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution (participant directed) plan under the applicable provisions of the Internal Revenue Code (“IRC”) 401(a), covering eligible employees (“participants”) of Education Development Center, Inc. (the “Organization”). There are no minimum requirements for employees to make contributions to the Plan to receive an employer contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Organization is the Plan Sponsor, with a designated employee carrying out the fiduciary responsibilities of the Plan, as outlined by the Plan document.

***Eligibility***

All employees, except for non-resident aliens, leased employees, students, interns, fellow and casual employees, as defined in the Plan document, are eligible to participate in the Plan on the first day of the month following six months of active employment.

***Contributions***

The Organization generally contributes non-discretionary contributions annually in an amount equal to 10% of the base salary of the participants, subject to limits defined in the IRC. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans. Participants are not required or permitted to make contributions to the Plan (other than in the case of rollovers).

***Participant Accounts***

Each participant’s account is credited with an allocation of the Organization’s contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings and eligibility, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their account balance into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. Plan earnings are credited to a participant’s account according to the type of funding vehicle in which balances are invested.

Fund managers’ fees are charged to participants’ accounts as a reduction of the return earned on each investment option.

***Vesting Provisions***

A participant is fully vested in the contributions and accumulations in their annuity contracts and investment accounts at all times.

***Payment of Benefits***

Upon termination of service, retirement, death or total permanent disability, a participant may elect to receive a distribution of their entire accumulated plan balance, subject to the terms of the funding vehicles.

Distribution options include lump-sum payments, partial payments, annuities or installments. Minimum required distributions for participants who have reached required age, per Internal Revenue Service (“IRS”) regulations. In case of a participant’s death before the annuity starting date, payment of the current value of the annuity accumulations will be made to a beneficiary as designated by the participant.

#### ***Administrative Expenses***

Administrative expenses incurred by the Plan are paid by the Plan or the Organization. The Organization provides certain accounting and management services to the Plan at no charge. A portion of the administrative expenses is returned to the Plan on a revenue sharing arrangement. The revenue sharing amounts received are recorded as other income on the statement of changes in net assets available for benefits. Revenue sharing amounts received of \$35,244 are included in other income of in the statement of changes in net assets available for benefits. Revenue sharing amounts used to pay Plan expenses were \$48,846 in 2024. There was \$74,193 and \$69,693 in the revenue sharing account at December 31, 2024 and 2023, respectively.

#### ***Participant-Directed Contributions, Withdrawals and Transfers***

Under the Plan, participants can elect to contribute to Teacher’s Insurance Annuity Association of America (“TIAA”) investment options, College Retirement Equity Fund (“CREF”) investment options, or other mutual fund investment options. The manner of electing to allocate contributions between these investments and any decision to change such allocation is made by the participant in such manner as permitted by TIAA and CREF as administrator. Withdrawals and transfers are recorded at the time of transaction. Participants are also provided with the option to invest employer contributions in TIAA Traditional Annuities, which are un-allocated insurance contracts and are included in plan assets.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES BASIS OF PRESENTATION**

#### ***Basis of Presentation***

The Plan’s financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### ***Investments, Investment Valuation and Income Recognition***

Participant investment alternatives include pooled separate accounts, unallocated annuity contracts, and mutual funds.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Realized gains and losses are accounted for on the average cost basis.

The Plan’s investments are stated at fair value.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As discussed below, certain TIAA Traditional Annuity contract types are considered not fully benefit responsive and as such are presented at fair value. TIAA, in its capacity as record keeper and administrator, provides plan management with periodic financial information regarding the Plan’s assets. In determining reasonableness of the valuation methodology, plan management reviews the accounting and

valuation methodology of the TIAA Traditional Annuity to determine the appropriateness of fair value considering historical credit rates and treasury yields.

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (“RA”), Supplemental Retirement Annuities (“SRA”), Group Supplemental Retirement Annuities (“GSRA”), Retirement Choice Plus (“RCP”) and Transfer Payout Annuities (“TPA”). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant’s principal, plus a specified minimum rate of interest, are guaranteed by TIAA’s claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA’s Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years.

The RA contract does not allow lump-sum cash withdrawals and transfers must be spread over 10 annual installments. All other withdrawals and transfers from RA contracts must be spread over 10 annual installments. The SRA, GSRA, and RCP contracts provide for full participant-directed liquidity. When a participant’s accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

A portion of the assets of the Plan are included in CREF, which is registered under the Investment Company Act of 1940 as an open-end diversified management investment company. CREF consists of several investment portfolios. The account is valued at net asset value (“NAV”) as reported to NASDAQ by the advisor. The TIAA Real Estate Account is a pooled separate account stated at fair value based on the fund’s NAV as determined by TIAA. The account is valued at NAV as reported to NASDAQ by the advisor.

#### ***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Payment of Benefits***

Benefits paid to participants are recorded when paid.

**NOTE 3 - SUMMARY OF FINANCIAL DATA CERTIFIED BY THE CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, an insurance company, and as record keeper and custodian of the Plan, have certified that the following data included in the financial statements and supplemental schedule is complete and accurate. This certification extends to those investments which TIAA, FSB, a federal savings association, held as a directed trustee or custodian that were record kept by TIAA:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, part IV, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

U.S. GAAP establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the NAV of shares held by the Plan at year end. TIAA and CREF actively traded mutual funds are registered mutual funds whose fair values are based on quoted prices and are, therefore, classified in Level 1 of the fair value hierarchy.

#### ***CREF Variable Annuities***

TIAA offers several CREF variable annuities. Unlike TIAA Traditional, the variable accounts do not provide guaranteed returns. Participant returns depend entirely on the investment performance of each account. The accounts invest principally in equity securities, fixed income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources, which may employ various pricing methods to value the investments including matrix pricing.

#### ***Pooled Separate Account***

In addition, TIAA offers the Real Estate Account, which is a separate account of TIAA. This account is a variable account, and as such its returns are not guaranteed and its accumulations and returns fluctuate based on the performance of the underlying investments. The account generally invests in real estate properties and real estate-related investments. The account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally utilizing external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. The account is valued at NAV as reported by the advisor.

#### ***TIAA Traditional Annuity Account***

The TIAA Traditional Annuity Account is one of the investment options that represents insurance contracts issued by TIAA, which guarantees principal and a contractually specified interest rate to account participants. TIAA invests amounts that back contracts in individual bonds, commercial mortgages, real estate, stocks and other assets selected by specialized teams that target different sectors of the marketplace. The portfolio follows specific guidelines with respect to major asset classes, sectors, industries, property types, geographic regions, individual issuers/borrowers, foreign holdings, liquidity, quality and derivatives.

TIAA Traditional Annuity account balances are reported at fair value which approximates contract value. Contract value is the aggregation of contributions, plus interest, less withdrawals, if any. The fair value is derived from a discounted cash flow analysis and other factors. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period. Contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate, which correlates closely with TIAA Traditional Annuity's historical crediting rates.

The guaranteed annual interest rate for the TIAA Traditional Annuity Accounts is between 1.00% and 3.00% for all premiums remitted since 1979 under all TIAA Traditional Annuity accumulating contracts plus additional amounts established by TIAA on a year-by-year basis. The average yield and crediting interest rate for the major types of TIAA annuity contracts are disclosed in the table below for Level 3 investments

for plan years 2024 and 2023. Both the one-year total return and the yield credited to participants for 2024 and 2023 are net of annual fees. The crediting interest rate is calculated on a daily basis.

While plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of Level 3 investments were \$2,171,990 for the Plan year ended December 31, 2024. There were no transfers into or out of Level 3 investments for the Plan year ended December 31, 2024.

Transfers out of the TIAA Real Estate Account to a TIAA or CREF account or into another investment option can be executed at any time but are limited to once per calendar quarter. Transfers out of the TIAA Traditional Annuity contracts can only be affected over a period of time (up to 10 years) and may be subject to other limitations. Transfers out of CREF funds and TIAA-CREF mutual funds into another investment option may be executed on a daily basis.

TIAA Traditional Annuity account balances are reported at fair value, which is the aggregation of contributions, plus interest, and less withdrawals, if any. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period.

Fair value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate, which correlates closely with TIAA Traditional Annuity's historical crediting rates.

The Plan administrator sets the valuation policies for Plan assets and is responsible for the determination of fair value. The Plan administrator compares price changes between periods to current market conditions, compares trade prices of securities to fair value estimates and performs ongoing due diligence. Valuation approaches are reviewed on an ongoing basis and revised as necessary based upon changing market conditions to ensure values present a reasonable price.

**NOTE 5 - TAX STATUS**

The Plan obtained its latest determination letter on April 2, 2014, in which the IRS stated that the Plan was designed in accordance with the applicable sections of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions that would require recognition of a liability or disclosure in the financial statements.

#### NOTE 6 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF are also custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Transactions within the revenue sharing account also qualify as party-in-interest transactions.

#### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts.

#### NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.
