Note A - Description of the Plan

The following description of the Schimenti Construction Company, LLC (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a salary deferral defined contribution plan established effective January 1, 1998 and subsequently amended effective July 1, 2014. For the years ended December 31, 2024 and 2023, all employees of the Company were eligible to participate once they had attained age 18. All eligible employees who were hired on or after July 1, 2014 will be automatically enrolled in the Plan. If the automatic enrollment provision applies to an employee, the Plan will automatically defer 4% of their compensation. The automatic enrollment percentage will increase annually in 1% increments, up to 10%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the Plan’s named fiduciary and plan administrator. Fidelity Management Trust Company (“Fidelity”) is the Plan’s TPA, recordkeeper and custodian. Fidelity holds the Plan’s investments and executes investment transactions as well as prepares statements for participants, which include amounts of contributions, investment income, disbursements and fair value of investments, along with calculating distributions in the event of a participant’s termination of employment.

Contributions

Participant’s salary reduction election:

The Plan allows each participant to defer up to 100% of their annual qualified compensation as defined in the Plan document and is subject to Internal Revenue Code (“IRC”) restrictions. In accordance with the IRC, participant contributions were limited to \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, and remain subject to periodic adjustments by the Internal Revenue Service. Participants have the option of making either 401(k) elective deferral contributions or designating some or all as Roth elective deferral contributions. Participants who reached age 50 by the end of the tax year were eligible to make additional catch-up contributions of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer matching contribution:

The Company may make a qualified matching contribution of 50% up to the first 6% contributed. Any participant actively employed during the Plan year shall be eligible to share in the matching contribution for the plan year. The Company’s matching contributions to the Plan for the years ended December 31, 2024 and 2023 were \$679,837 and \$640,888, respectively.

Employer discretionary contribution:

The Company may make a discretionary contribution. Participants are eligible if they are actively employed on the date of the contribution and any participants who were actively employed at any time during the plan year and had retired, died or became totally disabled. The Company did not make a discretionary contribution to the Plan for the years ended December 31, 2024 and 2023.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after two (2) years of service, 40% after three (3) years, 60% after four (4), 80% after five (5) and 100% vested after six (6) years of service.

Participant accounts

Each participant's account is credited with the participant's deferrals and the Company's matching contribution and Plan earnings. Plan contributions are participant directed and are invested in one or more investment vehicles available to participants under the Plan. Earnings and losses are determined by individual investment vehicle performance.

Investment options

Upon enrollment in the Plan, a participant may direct employee contributions and employer discretionary contributions in any whole percent increments in any of the various investment options available by the Plan. Participants may change their investment options on a daily basis.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the non-forfeitable accrued benefit of the participant under the Plan. Loan terms range for 1-5 years, unless the proceeds are used for the purchase of a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Hardship withdrawals

Participants may elect, subject to specific circumstances as defined in the Plan, to receive all or part of elective deferral contributions (not earnings) for immediate and severe financial need.

Forfeitures

If a participant terminates employment before becoming fully vested in his/her Company matching contributions, the non-vested Company matching contributions (and earnings thereon) are forfeited at the earlier of the date the participant receives a distribution or incurs a five-year break-in-service. Forfeited balances are restored if the participant returns to an eligible status within five years of termination and repays any amount previously distributed. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company matching contributions, restore previously forfeited balances, or pay eligible Plan expenses, or for any other permitted use.

Unallocated forfeitures of \$153,300 and \$108,730 were used to reduce Company matching contributions and pay Plan expenses for 2024 and 2023, respectively. As of December 31, 2024 and 2023, the balance of unallocated forfeitures totaled \$424 and \$8,931, respectively.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments in accordance with IRS regulations. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Note B - Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Employee and employer contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings.

Payment of benefits

Benefits are recorded when paid.

Plan expenses

The Company has elected to charge administrative fees to the Plan's trust and all other expenses are paid by the Company.

Investment valuation and income recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Participant loans are classified as notes receivable, and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. No allowance for loan losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. During the years ended December 31, 2024 and 2023 there were delinquent participant loans totaling \$76,581 and \$35,837, respectively, reclassified to distributions.

Note C - Fair Value Measurements

Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

Level 1 Inputs: Valuation based on quoted prices in active markets for identical assets or liabilities that a reporting entity has the ability to access at the measurement date, and where transactions occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 Inputs: Valuation based on inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, that is markets in which there are few transactions, prices are not current, or prices vary substantially over time.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs: Valuation based on inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Shares of Registered Investment Companies

The fair value of these investments are determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2024 and 2023.

Note E - Related Party Transactions

Certain Plan investments are managed by affiliates of Fidelity, who is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Participant loans are also considered party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note F - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full termination, partial termination, or the complete discontinuance of contributions by the Company, all amounts credited to the affected participants' combined accounts shall become 100% vested.

Note G - Tax Status

The Internal Revenue Service has determined and informed Fidelity by a letter dated March 31, 2008 that Fidelity's Volume Submitter Profit Sharing Plan, which has been adopted by the Company, is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the advisory letter. However, the Plan administrator and the plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note H - Risk and Uncertainties

The Plan provides the participant with options of investing in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

Note I - Subsequent Events

Management has evaluated subsequent events through October 7, 2025 the date on which the financial statements were available to be issued.
