**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Vernon E. Faulconer, Inc. 401(K) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**GENERAL**

The Plan is a defined contribution plan available to employees of the Plan Sponsor, Vernon E. Faulconer, Inc. (the “Company” or “Employer”) regardless of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, (“ERISA”), as amended.

**PLAN ADMINISTRATION**

The trustee of the Plan, Vanguard Fiduciary Trust Company, is responsible for managing the Plan’s investment assets. The Vanguard Group, Inc. serves as the Plan’s third-party administrator (TPA), and they perform the Plan’s administrative duties such as preparation of the Form 5500, participant recordkeeping, compliance testing, and enrollment and transaction processing. Employees of the Company may perform certain other administrative functions; however, such employees receive no compensation from the Plan.

**PLAN ELIGIBILITY**

All full-time employees are eligible to participate in the Plan upon hire date. Participants will then enter the Plan on the first day of the month coinciding with or next following the date the eligibility requirements are satisfied except that former Riviera Employees hired on January 16, 2020, entered the Plan immediately.

**CONTRIBUTIONS**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes discretionary matching contribution to those participants who make salary deferrals, regardless of the participant’s hours worked during the year or whether the participant terminates during the year. Any discretionary matching contribution is determined as a percentage of participant’s salary deferrals made during the plan year and years of service. The Company may choose to make an additional discretionary contribution called a Qualified Matching Contribution (QMAC) to non-highly compensated employees, as defined by the Plan. To receive a QMAC, participants must satisfy minimum age only. Any QMAC made is allocated uniformly to all eligible participants and participants are 100% vested in QMAC. The company may choose to make a discretionary employer contribution to eligible participants who must be employed on the last day of the plan year regardless of service completed during the Plan Year or employment status on the last day of the Plan Year. The discretionary employer contribution is determined as a percentage. The Company also may choose to make a Profit-Sharing Contribution, this is discretionary, and it is to be determined by employer and will be made in the same ratio as each Participant’s Compensation bears to the total of such Compensation of all Participants.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contributions, the company’s matching contribution, as well as allocations of the company’s profit-sharing contribution, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**VESTING**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contributions is based on covered years of service as defined. A participant is fully vested after four years of completed covered years of service. A participant is also fully vested upon reaching normal retirement age, upon death, or upon becoming totally and permanently disabled.

Vesting in the Company’s discretionary matching contribution or discretionary profit-sharing contributions portion of their accounts is based on years of service. A participant is vested as follows:

**PAYMENT OF BENEFITS**

Participants are entitled to the benefits that can provided from their individual account balances, subject to vesting, upon retirement, death, or termination. Payment is required to be made as soon as administratively feasible after one of these events occurs. The participant may elect to defer distribution until April 1 of the calendar following the calendar year in which such a participant reaches age 70 ½ years of age.

The Plan sponsor makes mandatory distributions to separated participants with balances less than \$1,000 if the participant does not make an alternative election. These amounts are distributed to an Individual Retirement Account (“IRA”) on behalf of the participant.

Participants may withdraw vested amounts from the Plan while the participant is still employed with the Company if the participant satisfies the Plan’s requirements for in-service distributions. When a participant reaches the age of 59½, the participant may withdraw salary deferrals, matching contributions, employer contributions, non-elective profit-sharing contribution, and rollover contributions. Hardship distributions are permitted, subject to certain limits.

If a participant’s employment is terminated due to disability, the participant will be eligible to receive a distribution of the vested account balance under the Plan’s normal distribution rules. If the participant dies before taking a distribution of the entire vested account balance, the remaining benefit will be distributed to the designated beneficiary or beneficiaries.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of the participant’s vested account balance or \$50,000, whichever is less. Participant loans are secured by the balance in the participant’s accounts and bear interest at the prime rate plus 2%. Interest rates range from 5.25% to 10.50% for loans outstanding at December 31, 2024 and 2023. Principal and interest is paid automatically from bank accounts designated by participants. Loan payments are not deducted from payroll.

**FORFEITED ACCOUNTS**

Benefit payments to terminated employees partially vested in the Plan include their vested portion of employer contributions. Forfeitures may be used to reduce employer contributions or to pay administrative expenses of the Plan, as determined by the Company at its sole discretion. Unallocated forfeiture balances as of December 31, 2024 are approximately \$45,068, and no forfeitures were used to reduce employer matching contributions for 2024.

**NOTE 2: SUMMARY OF ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The Plan's financial statements are prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**INVESTMENT VALUATIONS AND INCOME RECOGNITION**

Plan investments are stated at fair value except for fully benefit-responsive investment contracts ("FBRIC"), which are reported at contract value. The Vanguard Retirement Savings Trust is a FBRIC and stated at contract value, which is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE RECEIVABLES FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**CONTRIBUTIONS**

Employee and discretionary employer matching contributions are recorded in the period during which the Company makes payroll deductions from the Plan participants' earnings.

**EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees paid to the trustee and recordkeeper. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan, and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions, and Qualified Domestic Relation Orders are charged directly to the participant's account and are included in administrative expenses.

**BENEFIT PAYMENTS**

Benefits are recorded when paid for financial statement purposes.

**SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued. Subsequent to December 31, 2024, the Plan was amended to change vesting for the Employer Match and Employer Profit Sharing sources of the Vernon E. Faulconer, Inc. 401(K) Profit Sharing Plan & Trust. The current vesting schedule of 4-year graded will be replaced with a 100% vested schedule.

(UNAUDITED)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Vanguard Fiduciary Trust Company (the trustee of the Plan).

**NOTE 4: PLAN TERMINATION AND AMENDMENTS**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. The Company also has the right to amend the Plan at any time.

**NOTE 5: TRANSACTIONS WITH PARTIES IN INTEREST**

The Plan's investments and the Plan's collective investment trust fund are handled by Vanguard Fiduciary Trust Company. This institution serves as the trustee of the Plan, and, therefore, the investments qualify as party-in-interest transaction. Fees paid by the Plan for investment management services were included as a reduction of the return earned on the fund. The Plan also utilizes The Vanguard Group recordkeeping retirement service provider as recordkeeper for the Plan; these services qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping services amount to \$600 for the year ended December 31, 2024.

**NOTE 6: TAX STATUS**

On June 30, 2020, the IRS stated that the volume submitter profit sharing plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7: RISKS AND UNCERTAINTIES**

The Plan invests in various instrument securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Investments Excluded From The Fair Value Hierarchy*

Common and collective trust funds: Comprise funds that have daily quoted net asset values for identical assets in markets that are not active. The net asset values are primarily derived based on the fair values of the underlying investments in the fund, some of which are not actively traded.

**NOTE 9- FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

Vanguard Fiduciary Trust Company Retirement Savings Trust (also known as Vanguard Retirement Savings Trust) (the "Trust") is a collective investment trust established on January 1, 1989, under Section 404 of the Pennsylvania Banking Code. Vanguard Fiduciary Trust Company serves as Trustee to the Trust. The Trust provides for the collective investment of assets of tax-exempt pension and profit-sharing plans. The Trust invests solely in Vanguard Retirement Savings Master Trust (VRST Master Trust). VRST Master Trust allocates daily its net investment income among its investor trusts based on their proportionate ownership. In 2024, the trust totaled \$3,169,285 and \$2,998,242 for 2023.

The Stable Value Fund holdings include investment contracts called synthetic guaranteed investment contracts comprised of investments in the collective trusts plus a wrapper contract. The wrapper contract is issued by a financial institution and the contract guarantees to provide a specific interest rate to be credited to the contract plus provide for participant liquidity at contract value in certain situations. The trust invests in a combination of synthetic contracts (backed primarily by Vanguard bond funds), traditional investment contracts backed by major insurance providers, and bank contracts. The trust will maintain an average maturity between 2-3 years.

The Stable Value Fund's wrapper contracts are benefit-responsive and are thus eligible for contract-value reporting. Funds may be withdrawn pro-rata from all the Stable Value Fund's investment contracts at contract value determined by the respective issuing companies to pay benefits and to make participant directed transfers to other investment options pursuant to the terms of the Plan after the amounts in the Stable Value Fund's Short-Term Investment Fund reserve are depleted.

The wrapper contracts wrap underlying assets which are held in the trust and owned by the Stable Value Fund. The underlying assets are comprised of collective trusts which may include a variety of high-quality fixed income investments selected by the fund manager consistent with the Stable Value Fund's investment guidelines. High quality, as defined by the Stable Value Fund's investment guidelines, means the average credit quality of all of the investments backing the Stable Value Fund contracts. The investments in the collective trusts are used to generate the investment returns that are utilized to provide for interest rates credited through the wrapper contracts. The trust maintains a strict credit policy, investing with issuers rated A- and higher, and investing in funds that are rated investment grade or higher. A dedicated team of analysts regularly assesses the financial health of each contract issuer. Credit-quality ratings for each issue are obtained from Barclays using ratings derived from Moody's Investors Service (Moody's), Fitch Ratings (Fitch), and Standard & Poor's (S&P). When ratings from all three agencies are available, the median rating is used. When ratings are available from two of the agencies, the lower rating is used. When one rating is available, that rating is used.

The wrapper contracts are benefit-responsive in that they provide that participants may execute transactions from the Stable Value Fund according to Plan provisions at contract value. Contract value represents contributions made to the Stable Value Fund, plus earnings, less participant withdrawals. The interest rates in wrapper contracts are reset monthly, based on market rates of other similar investments, the current yield of the underlying investments, the spread between the market value and contract value of the investments held by the contract, and the financial duration of the contract investments. Certain events, such as plan termination, or a plan merger initiated by the plan sponsor, or changes to Plan provisions not approved by the issuers of the Stable Value Fund's wrapper contracts, may limit the ability of the Stable Value Fund to transact at contract value or may allow for the termination of the wrapper contracts at less than contract value. Plan Management does not believe that any events that may limit the ability of the Stable Value Fund to transact at contract value are probable.

**NOTE 9- FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS - CONTINUED**

Changes in market interest rates affect the yield to maturity and the market value of the investments in the collective trusts, and thus can have a material impact on the interest crediting rate. In addition, participant withdrawals and transfers from the Stable Value Fund are paid at contract value but funded through the market value liquidation of the investments in the collective trusts, which also may affect future interest crediting rates. If market interest rates rise and fair values of investments in the collective trusts fall, the fair value may be less than the corresponding contract value. This shortfall in fair value will be reflected in future crediting rates by amortizing the effect into the future through an adjustment to interest crediting rates of the wrapper contracts. Similarly, if market interest rates fall and fair values of investments in the collective trusts rise, the fair values of investments held by the wrapper contract may be greater than the corresponding contract value. This excess in fair value will also be reflected in future crediting rates through an amortization process similar to that when there is a fair value shortfall.

**NOTE 11 - SECURE ACT 2.0**

On December 23, 2022 Congress passed the Consolidated Appropriation Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend in the Plan Document accordingly. Most of the significant provisions will become effective on January 1, 2024. There is no material impact to the Plan's 2024 financial statements.
