Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following description of Rochester Metal Products Corp. Profit Sharing Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Rochester Metal Products Corp. for the benefit of its full-time employees who have completed at least six months of service and are age nineteen or older, including all collective bargained employees. ALM Services, Inc. is a participating employer of the Plan, (collectively with Rochester Metal Products Corp., the Company). Principal Life Insurance Company (Principal) is the recordkeeper of the Plan and Principal Trust Company (Principal Trust) is the trustee of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

The Plan permits eligible employees to defer a portion of their wages to the Plan as contributions. The Plan limits the maximum deferral amount to the maximum allowable by the Internal Revenue Code. Employee rollover and nondeductible after-tax contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Company's matching and profit-sharing contributions are discretionary as determined by the Company's Boards of Directors. During the years ended December 31, 2024 and 2023, the Company's matching contribution was 50% of participants' salary deferral amount up to the first 4% of the participants' eligible compensation. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of the Company's contributions, Plan earnings and forfeitures of terminated participants' nonvested accounts and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employers' contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested in the employer matching and profit-sharing contribution portion of their account after six years of credited service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to offset administrative expenses or employers' contributions.

Forfeited Accounts

As of December 31, 2024 and 2023, there were no unallocated forfeitures. During the years ended December 31, 2024 and 2023, \$27,224 and \$22,778, respectively, in forfeitures were used to pay Plan administrative expenses.

Payment of Benefits

Upon termination of service, participants may elect to receive a lump-sum amount or installments equal to the value of their accounts. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a primary residence) through payroll withholdings. Interest on the loans is based on market rates, which for the years ended December 31, 2024 and 2023 was prime plus 1%.

Notes receivable from participants are reported at the amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Transfers from Rochester Metal Products Corp. Employee Stock Ownership Plan (Rochester ESOP)

The Plan received funds from the Rochester ESOP on an annual basis, which represents diversification of investment risk from that Plan. The Rochester ESOP participants have the option to rollover their Rochester ESOP balances into the Plan.

Plan Termination

Although they have not expressed any intent to do so, the employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in the collective investment trust fund (KeyBank EB MaGIC Fund) is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. The fund is designed to be a stable value fund geared towards principal preservation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan obtained its latest determination letter on August 9, 2013, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the employers or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

- (A) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. The Level 1 investments held by the Plan include the mutual funds and the money market fund. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows and would be classified within Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3. There are no Level 2 or Level 3 securities held by the Plan.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The Plan invests in the KeyBank EB MaGIC Fund, for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. If a participant is invested in the KeyBank EB MaGIC Fund, the participant benefit payment withdrawal will be processed as soon as administratively practical subject to available liquidity of the KeyBank EB MaGIC Fund. Redemption is allowed daily. All other withdrawals of assets, other than termination benefits to participants, from the fund may be delayed, generally not to exceed 12 months at the sole discretion of the trustee of the fund. The fund had no unfunded commitments at December 31, 2024 and 2023.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan (if any), any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid fees to Principal totaling \$43,749 and \$37,219 during the years ended December 31, 2024 and 2023, respectively, for contract administrator fees.

The Plan maintains an ERISA Budget account separate from the Plan. Credits to this account of \$6,243 and \$5,482 were used to pay investment advisory fees to LPL Financial, LLC during 2024 and 2023, respectively. There were unused credits \$2,215 and \$1,832 at December 31, 2024 and 2023, respectively.

The Company provides certain administrative services at no cost to the Plan.

Note 6. Reconciliation of Financial Statements to Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the Internal Revenue Service and the accompanying financial statements are the common collective trust in Form 5500 has not adopted ASU 2015-12 and the Form 5500 reflects an adjustment to the fair value of that investment and loans deemed distributed are excluded from the Form 5500 participant loans balance.

Note 7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

Effective January 1, 2025, the Company's matching contribution increased from 50% of participants' salary deferral amount up to the first 4% of the participants' eligible compensation to 50% of participants' salary deferral amount up to the first 6% of the participants' eligible compensation.

Effective February 1, 2025, the Plan was amended to include an automatic deferral feature whereby a new participant is treated as electing to defer 6% of eligible compensation unless the participant makes an affirmative election otherwise.

Effective January 1, 2026, the Plan was amended to allow Roth contributions.

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
