Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Crews & Associates, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audits opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audits does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Notes to Financial Statements**December 31, 2024 and 2023****1. Summary of Significant Plan Provisions**

The following description of the Crews & Associates, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of the employees of Crews & Associates, Inc. (the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective January 1, 2024, the Plan was amended to merge the Financial Management, Incorporated 401(k) Plan (“FMI”) into the Plan. FMI is a participating employer in the Plan. Employees of FMI received predecessor service credit for eligibility service, contributions, and vesting service in the Plan.

- b. **Eligibility** – All employees are eligible as to all contribution types upon date of hire.
- c. **Contributions** – Participants may make rollover contributions and deferral contributions (on a pre-tax or after-tax basis) through payroll deductions. Automatic enrollment contributions will begin as soon as administratively feasible on or after the participant’s entry date. On the employee’s entry date, unless the eligible employee affirmatively elects otherwise, their compensation will be reduced by 3% each payroll period for salary deferrals. The Employer may, at its discretion, make matching contributions for the benefit of each participant making deferral contributions. During the years ended December 31, 2024 and 2023, the Employer matched 100% of each participant’s salary deferrals up to 3% of eligible compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation. The maximum Employer contribution was \$4,000. The Employer may also make a discretionary nonelective contribution. A participant will receive an allocation of this contribution if the participant is employed on the last day of the Plan year and has completed at least 1,000 hours of service during the Plan year, unless these requirements are not met due to retirement, death, or disability. There were no discretionary nonelective contributions made during 2024 or 2023. The Internal Revenue Service (“IRS”) has restrictions on the amount a participant may contribute annually and the amount of annual additions that may be made to a participant’s account.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – A participant is 100% vested at all times in their deferral and rollover contribution accounts. A participant will automatically become 100% vested in their Employer matching and nonelective contribution accounts if, while employed by the Employer, the participant attains normal retirement age (65), dies, or becomes disabled. If a participant terminates employment for any reason other than death, retirement, or disability, their interest in their Employer matching and nonelective contribution accounts will be limited to the vested portion.

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct contributions to any of the investment options offered under the Plan. Participants may also change their investment selections at any time.
- g. **Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or for an extended period of time for the purchase of a primary residence. The notes are secured by the participant’s account and bear interest at a rate commensurate with local prevailing borrowing rates. Principal and interest are paid through payroll deductions.
- h. **Forfeitures** – The portion of a participant’s account to which they are not entitled upon termination is deemed a forfeiture. Forfeitures may be used to pay the administrative expenses of the Plan or to reduce the Employer matching contribution. Forfeitures of approximately \$25,700 and \$20,700 were utilized to pay administrative expenses during the years ended December 31, 2024 and 2023, respectively. Forfeitures of approximately \$41,900 and \$21,500 were available for use as of December 31, 2024 and 2023, respectively.
- i. **Payment of benefits** – Upon termination of service with the Employer, the participant will receive their vested benefit in a lump sum payment. In-service withdrawals are available to participants who meet certain hardship requirements. In addition, in-service withdrawals are available to participants who have attained age 59½. Participants may elect, upon termination of employment, to defer payment of their account balance if it exceeds \$7,000. If a participant’s account balance is equal to or less than \$7,000, the account will be automatically distributed.
- j. **Termination of the Plan** – Although the Employer has not indicated an intent to terminate the Plan, it may do so at any time. In the event of termination, all participants would become 100% vested in their Employer contribution accounts.

Notes to Financial Statements**December 31, 2024 and 2023****2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Fees related to loans and distributions are charged directly to the participant’s account. Record keeping and trustee fees are paid by the Plan and allocated pro rata based on each participant’s account balance. Certain other administrative expenses paid by the Employer are not included in the Plan’s financial statements.

3. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Newport Trust Company, LLC (“Newport”), the trustee of the Plan from January 1, 2023 to April 17, 2024, and Ascensus, LLC (“Ascensus”) as agent for Ascensus Trust Company, the trustee of the Plan from April 18, 2024 to December 31, 2024, and was not subjected to any audit procedures except for comparing the information with the related information included in the financial statements and supplemental schedules:

- a. Cash as shown of the accompanying statement of net assets available for benefits of \$503 and \$0 as of December 31, 2024 and 2023, respectively.
- b. Investments at fair value as shown on the accompanying statement of net assets available for benefits of \$47,425,160 and \$41,793,839 as of December 31, 2024 and 2023, respectively.

Notes to Financial Statements**December 31, 2024 and 2023****3. Investments (cont.)**

- c. Dividends and interest as shown on the accompanying statement of changes in net assets available for benefits of \$1,000,619 and \$1,491,798 (excluding interest of \$28,370 and \$20,766 on notes receivable from participants) for the years ended December 31, 2024 and 2023, respectively.
- d. Net change in fair value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$5,128,127 and \$4,406,110 for the years ended December 31, 2024 and 2023, respectively.
- e. All investment transactions that occurred during the years ended December 31, 2024 and 2023.
- f. All the information included in the supplemental schedule, excluding participant loans.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Notes to Financial Statements

December 31, 2024 and 2023

4. Fair Value Measurements (cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Money market fund: This investment is valued at the fair value of the underlying investments, which are valued based on quoted market prices on the last business day of the Plan year.

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

Self-directed brokerage accounts: Accounts primarily consist of cash equivalents, money market funds, exchange traded funds, and common stock. Cash equivalents are valued at amortized cost, which approximates fair value. Money market funds are valued at the fair value of the underlying investments, which are valued based on quoted market prices on the last business day of the Plan year. Exchange traded funds and common stock are valued at quoted market prices on the last business day of the Plan year.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies, or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. **Tax Status**

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

6. **Parties-in-Interest Transactions**

Newport was the trustee and recordkeeper of the Plan through April 17, 2024. The Plan paid Newport for its services. FORVIS Wealth Advisors, LLC (“FORVIS”) served as third-party administrator and investment advisor of the Plan through June 30, 2024. The Plan paid FORVIS for its services. Effective April 18, 2024, Ascensus serves as trustee and recordkeeper of the Plan. The Plan pays Ascensus for its services. Effective July 1, 2024, FMI serves as the investment advisor of the Plan. The Plan pays FMI for its services. Transactions with Newport, FORVIS, Ascensus, and FMI qualify as parties-in-interest transactions. The Plan also holds notes receivable from participants. As a result, these notes receivable and related transactions were with parties-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

Notes to Financial Statements**December 31, 2024 and 2023****7. Delinquent Participant Contributions**

The Plan sponsor determined that during the 2024 Plan year, certain participant contributions and loan repayments were not remitted within the required time frame specified by the DOL's regulations, which have been reported on the accompanying Schedule H, line 4a – Schedule of Delinquent Participant Contributions in the amount of \$121,127. The Plan sponsor is in the process of calculating lost earnings.

8. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through October 9, 2025, which is the financial statement issuance date.
