### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the financial statements of Public Broadcasting Service Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and TIAA and CREF did not provide, sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.



### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

### ***Other Matter – Supplemental Schedules Required by ERISA***

The supplemental schedules (Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024) are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

### 1. Description of the Plan

The following description of the Public Broadcasting Service Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all employees of the Public Broadcasting Service (PBS). On March 9, 1970, PBS established two separate employee benefit plans—one provided employer contributions to eligible participants based upon their base salaries; the other provided participants the opportunity to make contributions to a plan on a pre-tax basis via salary reduction agreements with PBS. Both plans were defined contribution plans that operated under Section 403(b) of the Internal Revenue Code (the Code). Effective December 31, 2008, PBS restated the plan documents to combine the two plans. The restated Plan is called the Public Broadcasting Service Defined Contribution Retirement Plan. Employees are eligible to contribute to the Plan via salary deferral immediately upon employment and are eligible to receive employer contributions upon the attainment of age 21 and one year of service to PBS. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 30, 2023, the Plan entered into a custodial agreement with Fidelity Management Trust Company (Fidelity). Relating to the change, approximately \$134 million in Plan assets were transferred from Transamerica Financial Life Insurance Company, Inc. (TFLIC) to Fidelity on June 30, 2023. From that date forward, all new contributions made by eligible employees and PBS were to investments offered by Fidelity. At that time, the Transamerica investment accounts were closed.

#### *Contributions*

Employer contributions are made for eligible employees at the rate of 8% of their base salary. The Plan allows for automatic enrollment for employees who were not contributing to the Plan through salary deductions as of that date with an initial deferral percentage of 3%. For those employees that are enrolled automatically and do not elect to make any changes to that enrollment, the deferral percentage is automatically escalated each year by 1% to defer up to 8% of the enrolled employee's salary. The Plan allows for rollover Roth conversions effective January 1, 2015. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions.

Effective January 1, 2024, the Plan's automatic enrollment default percentage was increased from 3% to 6% for new participants and previously automatically deferring participants. The automatic deferral percentage was also modified to increase 1% per year up to a maximum of 11%, previously 1% up to a maximum of 8%. All participants who were previously making automatic deferrals under the Plan as of April 5, 2024, with a current deferral rate greater than zero and less than 6%, were increased to a deferral percentage of 6% as of May 10, 2024.

#### *Forfeitures*

As of December 31, 2024 and 2023, forfeited non-vested accounts and suspense accounts totaled approximately \$0 and \$27,250, respectively. In 2024, \$27,250 of forfeited funds were used to pay administrative expenses and fund employer contributions.

### *Participant Accounts*

Each participant's account is credited with participant deferrals and the employer contributions following each pay period and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Plan contributions are participant directed and are invested in one or more funding vehicles available to participants under this Plan. Earnings and losses are determined by individual funding vehicle performance. The benefit to which a participant is entitled is equal to the vested balance of the participant's account.

### *Investment Options*

The Plan provides participants with options to invest in interest and non-interest-bearing cash accounts, shares of registered investment funds including mutual funds and CREF registered investments, pooled separate accounts, and fixed annuity contracts offered by TIAA and Fidelity.

### *Notes Receivable from Participants*

Participants may borrow from their balance at Fidelity a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the value of the vested interest in the participant's Fidelity account in the Plan. Employer contributions made to a participant's account are not included in the vested interest calculation. Notes are secured by an equivalent lien on the participant's accounts. Outstanding notes receivable as of December 31, 2024 are payable through January 8, 2034 at interest rates ranging from 4.25% and 9.50%. Participants make note payments through semi-monthly payroll deductions. Defaulted loans in the amount of \$47,778 for the year ended December 31, 2024 are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

### *TIAA Plan Loans*

The loans outstanding with TIAA are not presented in the Plan's statements of net assets available for benefits as the loans are not made from Plan assets and are therefore not considered assets of the Plan. Loan interest rates are variable based on prevailing interest rates and can be increased or decreased once a year by TIAA. Principal and interest is paid ratably by the participant directly to TIAA. No loan to any participant can be made to the extent that such loan when added to the outstanding balance of all other loans to the participant would exceed the lesser of 1) \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans during the one year period ending on the day before the loan is made, over the outstanding balance of loans on the date the loan is made, or 2) 50% of the present value of the individual account of the participant.

A portion of the TIAA Traditional Annuity balance is held as collateral against these loans. When defaulted loans from participants are deemed distributed, the amount held as collateral is distributed from the Plan and recorded as benefits paid to participants in the statement of changes in net assets. A default charge will be assessed against the portion of the loan collateral used to foreclose on all or part of any loan. As of December 31, 2024 and 2023, the balance of collateral held against loans from participants amounted to \$6,273 and \$5,958, respectively.

### ***Vesting***

Participants are 100% vested upon becoming eligible to receive employer contributions. Participants are immediately 100% vested in contributions made via rollover or salary deferral.

### ***Payment of Benefits***

Participants may not make withdrawals from their accounts prior to termination of employment, death, disability, or retirement. Benefits are provided through the accumulation of a participant's contributions and a participant's share of employer contributions and allocation of Plan earnings. The Plan allows participants who have attained age 59½ the opportunity to receive benefit payments while remaining employed with the Plan sponsor. The Plan provides for various benefit election options.

The Plan allows for withdrawals for hardship, which is defined as "immediate and heavy financial need". The amount of the hardship withdrawal cannot exceed the amount needed to cover the financial need, plus any income taxes or penalties reasonably anticipated to result from the hardship withdrawal.

Effective January 1, 2024, the Plan was amended to permit mandatory distributions following termination from employment for participants with an account balance of \$7,000 or less.

### ***Administrative Expenses***

Certain administrative expenses of the Plan, including compensation of Plan administration personnel within PBS and audit and accounting fees, are paid by PBS and excluded from these financial statements. Certain custodian administrative fees and investment fees are paid by the Plan. Loan setup fees and distribution processing fees are paid by the participant. During the Plan year 2024, Plan expenses totaled \$66,317, which are reported in the statement of changes in net assets available for benefits as administrative expenses.

## **2. Annual Reporting Requirements**

Neither the Plan sponsor nor TIAA and CREF, as custodian, have sufficient historical accounting records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. TIAA and CREF records were maintained on an individual participant basis and not on a plan basis. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to the Plan, could not be determined.

Since August 1, 2010, no new investments have been made to the TIAA and CREF annuity and custodial accounts under the Plan.

## **3. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) and are presented in accordance with the accrual method of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make certain estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value, except for the Plan's direct investments in fully benefit-responsive (FBR) investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). See Note 5 for further information related to fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Contributions Receivable*

Contributions and the related receivable are recognized in the period during which PBS makes respective payroll deductions from the participant's compensation.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Payment of Benefits*

Benefits are recorded when paid.

## **4. Information Certified by TIAA and CREF and Fidelity**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, a qualified institution.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and

dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

### 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies and inputs used for assets and liabilities measured at fair value:

#### ***Registered Investments***

##### *Mutual Funds*

Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### *CREF Registered Investments*

These investment accounts are registered investments that invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments and fund holdings are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing. Money market account holdings are generally valued at amortized cost. On a daily basis, units in these investments are revalued to reflect performance of the underlying investments minus any fees and charges. Units may not be transferred out of the same account unless 90 days have passed. These investments' NAV is published on the NASDAQ daily.

### *Pooled Separate Accounts*

#### *TIAA Real Estate Fund*

The TIAA Real Estate Fund invests in real estate properties and related estate-related investments. As such the value of this account is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisers and include significant judgment. The values of the TIAA real estate pooled separate accounts are published daily on NASDAQ. These securities are generally priced using values obtained from independent pricing sources.

The pooled separate account provides participants with a liquidity guarantee enabling the account to have funds available to meet participant redemption, transfers, or cash withdrawals. TIAA guarantees that participants can redeem their accumulated unit value determined after their transfer or cash withdrawal request is received in good order. There are no unfunded commitments from participants who invest in this account.

### *Fixed Annuity Contracts*

#### *TIAA Traditional Annuity Contracts*

The non-fully benefit-responsive (non-FBR) fixed annuity contracts, composed entirely of TIAA Traditional Annuity Contracts, are reported at fair value, as approximated by contract value. Fair value is determined based on a discounted cash flow model by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer or the theoretical exit price. Contract value equals accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange and is subject to various restrictions - see Note 6. The Plan's direct investments in fully benefit-responsive investment contracts are reported at contract value, as reported by TIAA.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **6. Investments at Contract Value**

### ***Fixed Annuity Contracts with TIAA***

Fixed annuity contracts amounting to \$2,802,093 and \$3,506,272 as of December 31, 2024 and 2023, respectively, consist of an investment option available to participants known as the TIAA Traditional Annuity (TIAA Annuity). TIAA Annuity contracts are established between the participants and TIAA, an insurance company registered in the state of New York. This investment option is offered in a variety of formats, including Retirement Annuities (RA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The return of Annuity contributions plus interest to participants is subject to TIAA's claims-paying ability.

Generally, no events can limit the ability of the Plan to transact at contract value with TIAA or limit the ability of the Plan to transact at contract value with the participants. In addition, there are no events that allow TIAA to terminate the contract with the Plan and settle at an amount different from contract value.

TIAA Annuity accounts are credited with a guaranteed minimum rate of interest that is determined annually. Participants may also earn interest in addition to the guaranteed rate at the discretion of TIAA. Such discretionary interest, if any, is declared by TIAA on a year-by-year basis and remains in effect for the subsequent twelve-month "declaration year."

Contributions to the annuity accounts are grouped by TIAA into "vintages" comprised of premiums received over defined time periods of one or more contiguous calendar months. The interest crediting rate for each vintage is determined, in part, by the net investment earnings rate of the TIAA assets supporting that vintage, minus a charge for administrative expenses and an amount set

aside for contingency reserves. Crediting rates are also determined by the performance of investments contained in TIAA's general account.

During 2024, the crediting rates of the annuity contracts range as follows:

RA account balances may only be withdrawn via periodic payments over several years. Because this provision is considered to restrict participants' "reasonable access" to their contract balances, RAs are not considered to be fully benefit-responsive investment contracts as defined by ASC 962, *Plan Accounting - Defined Contribution Pension Plans*.

SRAs and GSRA are considered fully benefit-responsive investment contracts, because they are fully liquid and immediately cashable once a participant terminates employment with PBS (unless they are pledged as collateral on a Plan Loan). Since the TIAA Annuity is fully benefit-responsive, contract value is the relevant measurement. Contract value, as reported by TIAA, represents deposits made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative fees.

### ***Guaranteed Investment Contract***

The Empower Guaranteed Income Fund (GIF), amounting to \$2,488,822 and \$2,687,977 as of December 31, 2024 and 2023, respectively, is a group annuity insurance contract issued by Empower Annuity Insurance Company (EAIC) and is backed by the full faith and creditworthiness of the issuer. The GIF is a stable value fund, where the portfolio is primarily invested in public bonds, commercial mortgages and private placement bonds.

The GIF is a traditional GIC and deemed to be fully benefit-responsive. Since the GIF is fully benefit-responsive, contract value is the relevant measurement. Contract value, as reported by EAIC, represents deposits made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative fees.

Generally, no events can limit the ability of the Plan to transact at contract value with EAIC or limit the ability of the Plan to transact at contract value with the participants. In addition, there are no events that allow EAIC to terminate the contract with the Plan and settle at an amount different from contract value.

Interest is credited on contract balances using a single "portfolio rate" approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. Interest crediting rates are reviewed on a semi-annual basis for resetting. The minimum credit rate under the contract will not be less than 1.00% or greater than 3.00%.

### 7. Related Party and Party-in-Interest Transactions

PBS is the administrator of the Plan, and as such, executes the normal duties associated therewith. Costs incurred for audit, legal, and other administrative functions are paid by PBS on behalf of the Plan. There were no financial transactions recorded between PBS and the Plan other than contributions made. The Plan invests in shares of funds managed by TIAA and CREF and Fidelity. TIAA and CREF and Fidelity act as custodians for those investments as defined by the Plan, and TIAA and CREF offers fixed annuity contracts as investments for the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Notes receivable from participants also qualify as exempt party-in-interest transactions.

### 8. Plan Termination

Although it has not expressed any intent to do so, PBS has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of each affected participant remain fully vested.

### 9. Tax Status

Effective June 30, 2023, the Plan adopted the Fidelity Workplace Services LLC 403(b) Volume Submitter Plan (Pre-Approved Plan). The IRS ruled on August 7, 2017 that the Pre-Approved Plan, including related amendments, as designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since the adoption of the Pre-Approved Plan. The Plan Administrator believes the Plan is currently designed and is being operated in accordance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

### 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 11. Delinquent Participant Contributions

During the Plan year ended December 31, 2022, a participant contribution of \$43 was not remitted to the Plan within the period prescribed by DOL regulations. This transaction constitutes a non-exempt party-in-interest or prohibited transaction as defined by ERISA. The contribution and the related lost earnings were remitted to the Plan during 2024.
