Notes to Financial Statements

Note 1: Description of Plan

The following description of the Nordic Group of Companies, Ltd. Employees' 401(k) Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Nordic Group of Companies, Ltd. covering employees other than nonresident aliens, interns and collectively bargained, part-time, temporary, seasonal or leased employees of the participating employers, Flambeau Corporation and Nordic Management Company (collectively the "Employer"), who have satisfied the eligibility requirements. An employee who is 19 years of age is eligible to make elective employee contributions after 90 days of service. For the purposes of becoming eligible for Employer matching contributions and Employer profit sharing contributions an employee must complete six months of service and one year of service, respectively, with the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 100% of pretax or after-tax annual compensation as defined by the Plan. Participants who have attained age 50 prior to the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investments offered by the Plan. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation. Each year participants who have an automatic deferral, and also those participants whose elective deferral is greater than 0% and less than 10%, will be subject to an automatic increase of 1% per year up to a maximum of 10% of compensation. Participants who defer less than 6% will be subject to auto-enrollment at 5% of eligible compensation each January 1, unless they affirmatively elect a lower rate or elect not to participate. The Employer has the option to make discretionary matching contributions and profit sharing contributions. For the year ended December 31, 2024, the Employer matched 100% of participant deferrals on the first 1% and 50% of the next 5% of compensation for non-union employees. For the year ended December 31, 2024, the Employer made matching contributions for union employees pursuant to their respective collective bargaining agreements. There were no discretionary profit sharing contributions during 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions, and allocations of (a) the Employer's profit sharing contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Effective January 1, 2023, the Employer's matching contributions and earnings thereon are 50% vested after one year of service and 100% vested after two years of service, and the Employer's profit sharing contributions and earnings thereon at a rate of 20% per year beginning with the first year of service. Prior to January 1, 2023, the Employer's matching and profit sharing contributions plus actual earnings thereon vested at a rate of 20% per year beginning with the first year of service completed. For vesting purposes, a year of service is defined as 1,000 hours of service.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.5%, which are commensurate with local prevailing rates as determined by the plan administrator at the time of loan origination. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service distributions are permitted in the event of financial hardship and for participants who have attained age 59 ½.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$841 and \$1,909. Forfeitures may be used to pay administrative expenses or reduce discretionary Employer and matching contributions. During 2024, Employer matching contributions were reduced by \$77,965.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to recordkeeping and investment related expenses are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Investments in common collective trusts are valued using a readily available fair value based on the fair value of the underlying securities in which the account is invested. The readily determinable fair value is used if the fair value per share is determined and published and is the basis for current transactions.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company, the Trustee of the Plan.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Fees incurred and paid by the Plan to Principal Trust Company, the Trustee, for recordkeeping and investment management services were \$66,772 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 7: Tax Status

The Plan has adopted a prototype plan, which the Internal Revenue Service has determined to be qualified under the Internal Revenue Code (IRC). The plan has been amended since adopting the prototype. The Plan has not requested a determination letter from the IRS; however, the plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes the Plan is qualified and the related trust was tax-exempt as of the financial statement date.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
