NOTE 1 - DESCRIPTION OF PLAN

The following description of the Western Integrated Technologies, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

General

The Plan is a defined contribution plan covering substantially all employees of Western Integrated Technologies, LLC. (the Company) for the benefit of its full-time employees who have six months of service and are age 21 or older, except those who are covered under a collective bargaining agreement or who are non-resident aliens with no earned income in the United States. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of eligible annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions to the Plan based on salary deferrals up to a certain percentage of the participant's compensation. The Company made matching contributions equal to 50% of the participant's salary reductions for the years ended December 31, 2024 and 2023. In determining matching contributions, only salary reductions up to 6% of the participant's compensation will be matched. The Company made matching contributions of \$217,567 and \$211,001 for the years ended December 31, 2024 and 2023, respectively. The Company may also make discretionary profit sharing contributions to the Plan. There were no discretionary profit sharing contributions for the years ended December 31, 2024 and 2023. Participants who have completed 1,000 hours of service in a twelve month period and are employed on the last day of the plan year are eligible for employer matching and profit sharing contributions.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers and the Company's contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions plus actual earnings are 100% vested immediately. Employer contributions are subject to the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms generally range from one to five years. If used to acquire a principal residence the Plan administrator can permit a longer repayment period up to 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions and can be repaid at any time.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant with a balance in excess of \$5,000 may elect to receive either a single lump-sum distribution equal to the value of the participant's vested interest in his or her account, or an annuity to be paid in equal installments over a period of not more than the participant's assumed life expectancy determined at the date of distribution. For termination of employment for reasons other than death, disability, or retirement, a participant with a balance in excess of \$5,000 may elect whether to receive a distribution. For termination of service with vested benefits of \$5,000 or less, a participant or beneficiary will automatically receive the value of the vested interest in his or her account as a lump-sum distributions or be rolled over into another qualified plan.

Hardship and In-Service Withdrawals

Participants are permitted to withdraw, in a single lump-sum, the vested portion of their account balance under certain conditions. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence the payment of post-secondary education tuition, the payment of funeral expense or casualty losses or to prevent eviction or foreclosure from the participant's principal residence.

Participants that have reached normal retirement age may elect to withdraw all or a portion of their entire vested account balance while they are still employed by the Company.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,973 and \$36,974, respectively. These accounts will be used to pay plan expenses and then to reduce future employer contributions.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Expenses related to investment advisory and recordkeeping services for the Plan are paid by the Plan and are included in administrative expenses. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investments related expenses are included in net appreciation of fair value of investments.

Evaluation of Subsequent Events

Management has reviewed subsequent events through October 9, 2025 which is the date that the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY JOHN HANCOCK LIFE INSURANCE COMPANY (U.S.A.)

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the auditors not to perform any auditing procedures with respect to information which was certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the trustee. The information certified by John Hancock Life Insurance Company (U.S.A.) includes investments, the related investment activity, and notes receivable from participants that are described in the accompanying financial statements.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Fair Value Measurements Topic 820 of the FASB Accounting Standards Codification (ASC) establishes a fair value hierarchy for reporting that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable units other than quoted prices for identical assets; and Level 3 inputs have the lowest priority.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts - Valued at the net asset value of units of a pooled separate account. The net asset value, as provided by the custodian, is based on the net asset value of the underlying investments which are required to publish their daily net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the custodian reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.
