Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BlazerWilkinsonGee, LLC 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of the BlazerWilkinsonGee, LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. A Plan description is available from the Plan Sponsor, which outlines all of the significant Plan provisions. Interested parties should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan originally effective June 5, 1996. The Plan has been amended throughout the years to comply with tax legislation and most recently restated effective January 1, 2022. The Plan covers substantially all employees who are employed by BlazerWilkinsonGee, LLC and Camarillo Harvesting, LLC (the Employers). Employees excluded from the Plan include nonresident aliens, those covered by unions, and leased employees. Employees may enroll in the Plan on January 1 or July 1 after attaining at least 21 years of age and completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and to certain sections of the Internal Revenue Code (IRC).

Contributions

Employees who elect to participate in the Plan may contribute (pre-tax or Roth) a portion (up to 100%) of their eligible compensation up to the limits imposed by Sections 401(k), 402(g), 404 and 415 of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The company elected to adopt safe-harbor provisions and matches 100% of the participant deferral contributions up to a maximum of 4% of compensation. For the years ended December 31, 2024 and 2023, the Employer safe-harbor contributions were \$270,331 and \$305,744, respectively. The company may also make a discretionary profit sharing contribution. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year to be eligible for the Employer profit sharing contribution. For the years ended December 31, 2024 and 2023, the Employer did not make a profit sharing contribution.

Participant Accounts

Each participant's account is credited or debited with (1) the participant's contributions by payroll deduction, (2) the participant's portion of Employer contributions, (3) an allocation of Plan earnings or losses, (4) rollovers from other qualified plans, (5) an allocation of Plan expenses and (6) any loans made to or repaid by the participant. Plan earnings or losses are allocated based upon each participant's account balance.

Certain fees are charged to the funds' investments and are offset against Plan investment income and loss as presented on the statements of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

Vesting

Participant contributions, safe harbor contributions, rollovers, and net earnings on these contributions, are fully vested when made or earned.

Employer profit sharing contributions (if any) as well as all earnings on these contributions vest according to the following schedule:

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures attributable to Employer contributions may be used to reduce administrative expenses of the Plan or reduce Employer contributions during the Plan years in which forfeitures occur. At December 31, 2024 and 2023, forfeited nonvested accounts were \$3 and \$2,471, respectively. There were \$5,407 and \$8,872 of forfeitures used to reduce Employer contributions in the years ended December 31, 2024 and 2023, respectively.

Payments of Benefits

On termination of service due to death, disability, retirement, or other reasons a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments. The Plan allows for in-service distributions if a participant reaches age 60. Participants may also elect to rollover their account to another tax deferred account or remain in the Plan until they are legally required to begin taking distributions. All vested account balances not exceeding \$1,000 may be immediately distributed in a lump-sum payment. All vested account balances exceeding \$1,000, but not exceeding \$5,000, may be rolled into an Individual Retirement Account.

Participant Investment Options

Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may apply to borrow from the Plan a minimum amount of \$1,000 and a maximum equal to the lesser of \$50,000, or, 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan fund. Loan funds may be repaid over any reasonable period, not to exceed the fifth anniversary of the date the funds were borrowed, with the exception of loans used for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus two percent. The interest rate in effect for the year ended December 31, 2024, based on the prevailing interest rates, was 5.25% - 10.50%. Principal and interest are paid ratably through payroll deductions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized as it is earned and dividends are recorded on the ex-dividend date.

Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Employee contributions and corresponding employer safe-harbor contributions are recorded in the year in which the employee compensation is paid and the deferrals are withheld. Employer discretionary profit sharing contributions are recorded in the year in which the related employee compensation is paid.

Payment of Benefits

Benefit payments are recorded when paid.

Plan Expenses

Expenses to administer the Plan, if not paid by the Plan Sponsor, may be paid by the Plan, and certain fees are allocated to the individual participant accounts.

Subsequent Events

The Plan administrator has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INFORMATION

The Voya Retirement Insurance and Annuity Company, the insurance company of the Plan, has certified to the accuracy and completeness of all investment information disclosed in the accompanying financial statements and supplemental schedule, except for the alternative investment fund and the interest bearing cash.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these accounting standards are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – Investments in the pooled separate accounts are valued using the net asset value (NAV) of units, as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

Alternative Investment Fund – Investments in the alternative investment fund are valued based on the net asset value per unit (or its equivalent) based upon the transaction price, plus accrued interest.

Interest-Bearing Cash – Investments in cash and cash equivalents are valued based on cost, which approximates fair value in a non-inflationary economy and is protected by the Federal Deposit Insurance Corporation (FDIC).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY

At December 31, 2024 and 2023, the Plan held an investment contract, the Fixed Account, with Voya Retirement Insurance and Annuity Company (VRIAC). This investment contract met the fully benefit-responsive criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully-benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate may change at any time and is based on a formula agreed upon with the issuer. Restrictions may apply to transfers of funds from the Fixed Account to other contract investment options. The contract cannot be terminated before the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the company or other company events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants are probable of occurring.

In addition, certain events allow the contract issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the contract issuer.

NOTE 6 INCOME TAX STATUS

The company adopted a Pre-approved Profit-Sharing Plan with a deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on November 30, 2020 which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since relying on the prototype opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RELATED-PARTY TRANSACTIONS AND PARTY-INTEREST-TRANSACTIONS

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, the qualified institution of the Plan, and by Morgan Stanley Smith Barney LLC; therefore, these investment transactions qualify as party-in-interest transactions. Fees paid to the third-party administrator also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the Plan document to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their company contributions.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that a change in value of investment securities will occur in the near term that could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 10 NONEXEMPT TRANSACTIONS

In 2023, the company failed to remit employee 401(k) deferral contributions for certain payroll periods within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. In 2024, the company corrected the prohibited transaction reported for the year ended December 31, 2023 by depositing the lost earnings, filing the required Form 5330 with the IRS and paying the appropriate excise tax.
