Opinion

We have audited the financial statements of the Quality Living, Inc. Health Care Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Note 1 - Description of Plan

The following description of the Quality Living, Inc. Health Care Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan provides health and other benefits to participants who are an eligible employee or covered dependent of an eligible employee of Quality Living, Inc. d/b/a QLI (Administrator or employer), and eligible retired members of the Administrator's Executive Leadership Team. The Plan was implemented July 1, 1990. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2023, the Plan wrapped the benefits of life insurance, accidental death and dismemberment, short-term disability, and long-term disability into the Plan.

Benefits and Eligibility

Under the Plan, active employees and their dependents are eligible for benefits in accordance with the medical, dental, vision, pharmacy, life insurance, accidental death and dismemberment, and long-term disability. The Plan provides benefits for the Administrator's participating full-time employees and on-call employees working 30 hours or more per week and their covered spouses and dependents. Employees are eligible to participate on the first day of the month following 30 days of continuous employment or one full calendar month, whichever occurs sooner, provided they satisfy the hour requirement and are actively employed at that time. The Plan provides continuation of benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Retired members of the Administrator's Executive Leadership Team are entitled to similar benefits under the Plan until they reach Medicare-eligible age, provided that they have attained at least age 55 and have completed ten or more years of service with the Administrator. At least five years must be completed in their qualifying position to be eligible for benefits. Retiree benefits are limited to the highest deductible plan offered. Retired members opting to continue coverage are required to contribute the current COBRA rate for each month of coverage. There are no members eligible for postretirement benefits as of December 31, 2024.

Stop Loss Coverage

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over \$70,000, as well as its aggregate exposure for all claims). Individual losses for paid claims for covered health care expenses in excess of the agreed-upon amounts will be paid by the insurance company.

Contributions

The Plan provides for employer contributions and participant contributions. Participants, in addition to deductible and coinsurance, contribute a specified amount each month based on applicable monthly premiums for their respective benefit elections, and the Administrator voluntarily contributes the remaining estimated amount necessary to fund Plan obligations on a pay-as-you-go basis. Contributions are based on estimated Plan obligations determined by the Administrator's review of the Plan's historical information.

Insured Benefits

The Plan fully insures the vision, life insurance benefits, accidental death and dismemberment benefits, and long-term disability benefits. The Employer purchases annual insurance contracts for these insured benefits. Premiums for the basic life coverage and long-term disability benefits are paid from the general assets of the Employer. Premiums for all other insured benefits are paid from contributions received from participants.

Plan Funding

Plan assets are held in the Quality Living Inc. Health Plan Trust (Trust), a voluntary employee's beneficiary association established on July 1, 1990. Plan disbursements are restricted to payment of premiums, administrative expenses, and Plan benefits.

Self-Insured Benefits

The claims for self-insured medical and dental benefits are processed by the Plan's independent claims processors under an administrative services only (ASO) arrangement. The processor pays claims directly to or on behalf of participants after being funded by the Trust. Despite the Plan's use of an independent claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Plan Termination

Although it has not expressed any intent to do so, the Administrator has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Administrator or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are reported on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Expenses

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include claims administration fees paid to an independent claims processor pursuant to an administrative services arrangement. These expenses are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are paid by the Administrator, if any, are excluded from these financial statements.

Benefits Payable

Benefits payable represents amounts due for eligible benefits incurred through the end of the respective Plan year, for which claims for reimbursement were submitted prior to December 31, 2024 and 2023, but were pending payment at December 31, 2024 and 2023, respectively. Such amounts are included in the accompanying statements of Plan's benefit obligations in amounts currently payable.

Claims Incurred But Not Reported

Claims incurred but not reported represents an estimate of amounts due for eligible benefits incurred during the respective Plan year, but not reported at the end of the Plan year. The Plan allows participants to submit claims up to 180 days after incurrence of the claim. Estimated claims incurred but not reported are based upon estimates and actual claims reports of the Plan received subsequent to the Plan year-end. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Stop-Loss

Premiums paid for stop-loss insurance are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds totaling \$1,115,381 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Refunds

Refunds from the Plan's PBM are recorded when earned. Refunds of \$133,162 due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$244,411 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Payments for Benefits

Claim payments are recorded when paid by the claims processor. Amounts due to the claims processor that have yet to be reimbursed by the Plan, if any, are recorded as payable to claims processor in the accompanying statements of net assets available for benefits. These payments, if any, are recorded as claims paid in the accompanying statement of changes in net assets available for benefits. Premiums paid by the Employer or Trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Receivables and Allowance for Credit Losses

The Plan has tracked historical loss information for its receivables and determined that all receivables are fully collectible and no allowance for credit losses is needed.

Management believes that the historical loss information it has compiled is a reasonable base on which to determine expected credit losses for receivables held at December 31, 2024 and 2023, because the composition of the receivables at those dates is consistent with that used in developing the historical credit expectations (i.e. the similar risk characteristics of its receivables). Additionally, management has determined that the current and reasonable and supportable forecasted economic conditions are consistent with the economic conditions included in the historical information. As a result, the historical loss rates have not been adjusted for differences in current conditions or forecasted changes. Accordingly, the allowance for credit losses at December 31, 2024 and 2023, is \$-0-

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market mutual funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market mutual funds held by the Plan are deemed to be actively traded.

Exchange traded funds – Valued at the closing price reported by the fund. Exchange traded funds (ETF) held by the Plan are open-ended management investment companies that are registered with the Securities and Exchange Commission. The shares are traded throughout the day at the market price.

Note 4 - Tax Status

The trust established to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and, accordingly, the trust's net investment income is exempt from income taxes. The trust has obtained an exemption letter, dated March 23, 1992, in which the Internal Revenue Service (IRS) stated that the trust, as then designed, was in compliance with the applicable requirements of the IRC. However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. All required income tax filings have been made to report unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Sponsor believes that the trust is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Related Party and Party-in-interest Transactions

The Administrator provides the Plan certain accounting and administrative services for which no fees are charged. Additionally, as described in Notes 1 and 2, the Plan has arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in this estimate in the near-term, would be material to the financial statements.

Note 7 - Concentration of Credit Risk

The Plan holds assets in various certificates of deposit and money market deposit accounts, the balances of which are periodically in excess of federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At December 31, 2024 and 2023, the Plan had approximately \$0, in excess of FDIC-insured limits to Form 5500.

Note 9 - Subsequent Events

Effective January 1, 2025, the Plan changed third-party administrator and signed an agreement with Blue Cross and Blue Shield of Nebraska, Inc (BCBSNE). BCBSNE will provide administrative and claims processing services to the Plan. As a result of this transaction, an updated Plan document was issued.

Effective January 1, 2025, the Trust document was updated to change one of the trustees of the Plan.

The Plan Sponsor has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued.
