NOTE A - DESCRIPTION OF THE PLAN

The following description of the Minco Tool & Mold, Inc. 401(K) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(K) profit sharing retirement plan sponsored by Minco Tool & Mold, Inc., (the Company and Plan Sponsor) and covers all eligible employees of the Company. The Plan is subject to the provisions of the ERISA.

Eligibility

Under the terms of the Plan, covered employees are eligible to become participants on the first day of the month following completion of six months of employment and attainment of age 21.

Contributions

- (a) *Participants' voluntary salary reductions.* Participants may elect to contribute up to 100% of their compensation, as defined in the Plan. Each participant's contribution may not exceed the federal maximum amount pursuant to Section 402(g) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, the Plan provides for catch-up contributions for participants age 50 or older. The Plan contains an automatic deferral feature (2% default rate) with an opt-out provision. The automatic deferral will increase by 1% annually up to a maximum of 10%.
- (b) *A discretionary employer-matching contribution.* The matching contribution, if any, is determined each year by the Board of Directors of the Company at its sole discretion. No matching contribution is to be made with respect to catch-up contributions. The matching contribution for 2024 and 2023 is 40% of employee deferrals, not to exceed 5% of eligible compensation. Matching contributions of \$209,019 and \$216,468 were contributed to the Plan for the years ended December 31, 2024 and 2023, respectively.
- (c) *A discretionary profit sharing contribution.* The profit sharing contribution, if any, is determined each year by the Board of Directors of the Company at its sole discretion. This amount is allocated based on compensation of all participants eligible to share in the discretionary amount. The Company made no discretionary profit sharing contributions for 2024 and 2023.
- (d) *A non-elective contribution.* The Company, at its sole discretion, could make a non-elective profit sharing contribution. The discretionary contribution is allocated on a per capita basis among qualified participants who were non-highly compensated employees. The Company made no non-elective profit sharing contributions for 2024 and 2023.

Participant's Accounts

Each participant's account is credited with the participant's own contributions, employer contributions, rollover contributions, and a share of the Plan's investment income and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee deferrals, employer contributions, and direct rollovers in any of several different mutual funds or a guaranteed investment contract.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of the participant's non-forfeitable account balance as of the date of the loan. Loan terms range from one to ten years. The loans are collateralized by the balance in the participants' accounts and bear interest at reasonable rates fixed by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Vesting

Participant vesting is based on service years. Participants are 100% vested in the voluntary salary deferral, rollover contributions, and non-elective contributions. The discretionary profit sharing contributions and discretionary employer-matching contributions vest according to the following schedule:

Forfeited Accounts

Forfeitures are reallocated following the date on which a terminated participant incurred five consecutive one-year breaks in service or following the date on which a terminated participant received payment of his vested account balance. The Plan provides that forfeitures may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. Forfeitures were \$15,413 and \$7,569 for the years ended December 31, 2024 and 2023, respectively. In 2024 and 2023, forfeitures of \$21,808 and \$13,905 were used to fund employer matching contributions, respectively. At December 31, 2024 and 2023, the available balance in the forfeiture account was \$1,640 and \$7,388, respectively.

Payment of Benefits

After attaining the normal retirement age (65), a participant is entitled to benefits that equal the value of his or her vested interest in their account. Benefits are also paid upon death, disability, or termination. Participants receive their benefits in a lump-sum distribution, equal installment payments, or through an annuity purchase. Benefit distributions are recorded when paid. For 2024, all persons who elected to withdrawal from the Plan had withdrawn their balance prior to December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan a distribution, the note balance is reduced and a withdrawal is recorded.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, results may differ from those estimates.

Administrative Fees

Administrative fees are paid for by both the Plan and the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and investments at contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company, the Trustee of the Plan.

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 - Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price of the shares held by the Plan at year-end reported on the active market on which the individual securities are traded.

Money market funds: Valued at the daily closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a benefit-responsive investment contract with Voya Institutional Trust Company (the Trustee). The contract is a guaranteed investment contract. The Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the Trustee. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rate was 1.5% for 2024. The crediting interest rate is based on a formula agreed upon with the contract issuer, but may not be less than 1.0%. Such interest rates are reviewed periodically for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendment to the Plan Document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs or a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The contract issuer has the option to payout 100% of the current value of the contract or convert the current value to another contract issued by the Trustee after completion of five contract years.

NOTE F - INCOME TAX STATUS

The prototype Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype Plan Document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the restated Prototype Plan. The Plan has been amended and restated since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with the IRC. Therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - PARTY-IN-INTEREST TRANSACTIONS

Certain administrative services are provided by the Plan Sponsor at no cost to the Plan, and certain administrative costs incurred by the Plan are paid by the Plan Sponsor.

The Plan's administrative expenses result from services rendered by parties-in-interest.

Certain Plan investments are shares of mutual funds and a money market fund managed by Voya. Voya Institutional Trust Company is the Plan Trustee; therefore, these transactions qualify as party-in-interest transactions.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE J - SUBSEQUENT EVENTS

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
