## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Thompson Thrift Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**NOTE 1 - PLAN DESCRIPTION**

The following is a brief description of the Thompson Thrift Retirement Plan (the "Plan"). Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of the participating employers who are 21 years old. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Participating Companies**

The following Companies, which are related parties, are participating employers in the Plan:

Thompson Thrift Construction, Inc.  
Thompson Thrift Development, Inc.  
John Thompson, a Sole Proprietor  
Paul Thrift, a Sole Proprietor

**Entrance Date**

An employee is eligible to enter the Plan on quarterly entrance dates (January 1, April 1, July 1, and October 1) immediately following completion of the age requirements.

**Contributions**

Each year, participants may contribute up to 50% of annual compensation, as defined by the Plan. The Plan allows for catchup contributions for participants who have reached age 50 by the end of the year.

The Plan automatically enrolls all newly eligible participants into the Plan at 5% and at the beginning of each Plan year auto enrolled participants deferrals are increased by 1% not to exceed 10%. Participants may also contribute rollover monies from other qualified plans.

The Companies' contributions consist of discretionary matching and profit-sharing contributions. The matching contributions are based upon a percentage of each participant's salary deferral that is contributed to the Plan. Contributions from the Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. For the year ended December 31, 2024, the Companies matched 30% of the contributions of each participant. No discretionary profit-sharing contributions were made for the year ended December 31, 2024.

Forfeitures from terminated participants' nonvested accounts are used to reduce future Company contributions or pay Plan expenses. For the year ended December 31, 2024, forfeitures amounting to \$225,508 were used to reduce employer contributions. Amounts available for future use as of December 31, 2024 and 2023, were \$51,540 and \$46,277, respectively.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Companies' contribution portion of their account plus actual earnings is based on years of service. A participant is 100% vested after three years of credited service.

**NOTE 1 - PLAN DESCRIPTION (CONTINUED)**

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to an amount that is equal to the lesser of \$50,000 or 50% of the present value of the participant's non-forfeitable accrued benefit. All loans are to be repaid over a period not to exceed five years, although an extension of the repayment period may be granted if the loan proceeds are used to purchase a participant's principal residence. Interest is charged at a rate commensurate with prevailing market rates as determined by the Plan administrator. Any loans shall reduce the participant's balance in the individual's account and will be restored as the principal balance when such loan is repaid. All interest paid by the participant shall be credited to his or her own individual account. Loans are valued at the unpaid principal balance plus accrued but not unpaid interest. The Plan permits a participant to have no more than one loan at any given time.

**Benefit Payments**

Upon attaining age 59 1/2, termination of employment, retirement, death, or disability, a participant (or beneficiary) may elect to receive vested benefits in a single lump-sum amount. Active participants may also elect to take a distribution for a qualifying hardship in accordance with the Plan's provisions. Benefits are recorded when paid.

**Plan Termination**

Although they have not expressed any intent to do so, the Companies reserve the right to terminate the Plan at any time. In the event of Plan termination, participants will become 100% vested in their account balances.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements are presented using the accrual method of accounting.

**Estimates**

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Fair Value Measurements**

ASC 820 defines fair value, establishes a framework for measuring fair value and enhances disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (or exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

**Fair Value Measurements (Continued)**

Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. Observable inputs are inputs that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the inputs that market participants would use in pricing the asset or liability and are developed based on the best information available in the circumstances.

The fair value hierarchy input levels are as follows:

- Level 1 - Quoted market prices in active markets for identical assets or liabilities that are accessible at the measurement date.
- Level 2 - Observable inputs other than quoted market prices included in Level 1, such as quoted prices for similar assets and liabilities in active markets, or quoted market prices for identical or similar assets or liabilities in markets that are not active.
- Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. This includes certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

**NOTE 4 - PARTICIPANT DIRECTED INVESTMENTS**

Participant contributions held in the Plan are participant-directed accounts. That is, individual participants decide how funds held in trust for them are allocated among various investment options.

**NOTE 5 - TAX STATUS**

The non-standardized prototype plan received an opinion letter dated June 30, 2020, stating the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment companies:* Valued at the daily closing price as reported by the underlying fund, which is traded on a national exchange.

*Money market funds:* Valued at the net asset value of shares held by the Plan at year-end.

*Common/collective trust:* Stated at fair value as determined by the issuers of the funds on the fair market value of the underlying investments, which is valued at net asset value (NAV) as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in valuation methodologies at December 31, 2024, compared to December 31, 2023. The Company's policy is to recognize transfers between levels at the end of each reporting period, if applicable. There were no transfers in or out of Level 3 assets or liabilities during the year ended December 31, 2023.

Administrative expenses paid from the Plan represent recordkeeping and professional fees which amounted to \$114,685 for the year ended December 31, 2024.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 36% and 34%, respectively of the Plan's investments were comprised of three funds.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 8, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
