1. Description of Plan

The following description of the Plastic Omnium Clean Energy Systems Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan and trust with a qualified cash or deferred 401(k) arrangement covering all eligible employees of OPmobility and Plastic Omnium New Energies USA (collectively referred to as the "Company") who have 30 days of service, excluding residents of Puerto Rico, those covered by a collective bargaining agreement, leased employees, nonresident aliens, and employees classified by the employer as cooperative (co-op) student employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Certain employees of the Company transfer to and from a related party, Plastic Omnium Auto Inergy (USA), LLC, from time to time. During 2024, \$213,307 of plan assets were transferred in from the Plastic Omnium Clean Energy Systems UAW Savings Plan that covers all eligible employees of Plastic Omnium Auto Inergy (USA), LLC.

Contributions

Each year, participants may contribute up to 85 percent of eligible compensation, as defined in the Plan, and designate those contributions as pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for the following employer contributions:

- Non-elective safe harbor contributions. The Company contributes 100 percent of the first 3 percent of eligible compensation for the Plan year.
- Non-discretionary matching contributions. The Company contributes 60 percent of the eligible contributions to all eligible participants up to 5 percent of the participants' eligible compensation.
- Discretionary non-elective "core contributions". These contributions are determined annually by the Company. The Company may make a discretionary non-elective "core contribution" using a graded allocation formula based on years of service starting at 2 percent and increasing in 1 percent increments, with a maximum contribution of 6 percent, to all eligible employees, as defined in the plan document. The Company may also make a discretionary non-elective "core contribution" of 4 percent of compensation (based on eligible compensation) to eligible plan participants, as defined in the plan document.

Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company non-elective safe harbor contributions, Company matching contributions, Company discretionary non-elective employer contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, collective investment trust funds, and a self-directed brokerage account as investment options for participants.

Vesting

Participants are vested immediately in their contributions, Company non-elective safe harbor contributions, Company matching contributions, and Company discretionary non-elective employer contribution portions of their accounts, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1 percent, which is commensurate with local prevailing rates as determined quarterly. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or other installment options. The Plan also permits in-service distributions for participants that have attained age 59 ½. Hardship distributions are permitted to active employees upon demonstration of a financial hardship, as defined by the Plan.

Forfeited Accounts

Forfeitures may be used to reduce Company contributions or plan expenses. As of December 31, 2024 and 2023, forfeited non-vested account balances amounted to \$1,982 and \$1,095, respectively. During 2024, \$110 in forfeitures was used to pay administrative expenses.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Reclassifications

Certain amounts presented in the prior year have been reclassified to conform to current year presentation.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. During 2024, \$24,148 in loans were deemed to be in default.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees charged for benefit payments are also charged directly to the participant's account. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust Funds: Valued at NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self Directed Brokerage Funds: The self directed brokerage funds primarily hold mutual funds, common stock, and money market funds. These investments are traded on an exchange and are primarily valued at their net asset values as their readily determinable fair values.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants are 100 percent vested in their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Company may determine.

7. Tax Status

The Plan has received an opinion letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan is amended periodically, and the Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

8. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments were managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, transactions with this party qualify as party-in-interest transactions. The Plan made direct payments to the third party administrators totaling \$103,099 which was net of \$51,997 in revenue sharing credits. The Company pays directly any other fees related to the Plan's operations.

10. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
