The following description of the WindRose Health Network Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a volume submitter defined contribution plan adopted by WindRose Health Network, Inc. (Plan Sponsor). The Plan is a defined contribution plan providing for retirement benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All employees who meet certain eligibility service requirements are participants in the Plan.

#### Contributions

Participants are eligible to participate in the Plan on the first day of the quarter (January 1, April 1, July 1, or October 1) following completion of ninety days of service to contribute to the Plan to be eligible for employer matching or discretionary contributions. The Plan Sponsor did not make a discretionary contribution to the Plan during 2024. In addition, the Plan Sponsor provided a safe harbor employer contribution of 3% of eligible participant compensation for 2024. The Plan permits participants, through a salary deferral election, to have deductions of any set dollar amount per payroll period or a percentage of their eligible compensation, up to the maximum allowed by law, contributed to their account. Rollover and catch-up contributions are also permitted.

#### Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, allocations of Plan Sponsor's contribution and plan earnings (net of certain fund management expenses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment account options available include various funds. Each participant has the option of directing contributions into any of the separate investment accounts and may change allocations daily.

#### Compensation

Participant compensation is defined by the Plan as wages, tips and other compensation reported on the Federal Form W-2, Wage and Tax Statement.

#### Retirement Benefits and Vesting

The Plan provides that non safe harbor employer contributions to a participant's account are fully vested at the end of three years of at least 1,000 hours of service or earlier upon attainment of normal retirement age, upon retirement due to disability, upon death or upon termination of the Plan. Upon termination of employment, the nonvested portion of the participant's account is called a forfeiture and remains in the Plan to reduce Plan Sponsor contribution for the year.

Employee deferrals, rollovers, and safe harbor employer contributions are always 100% vested. No forfeitures were available to offset contributions as of December 31, 2024 and 2023. No forfeitures were used during 2024 to offset employer contributions or expenses of the Plan.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that reflect the market rates at the time the loan is made, and which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Repayment terms are set to comply with regulatory standards. Principal and interest are paid ratably through payroll deductions. Loans must be repaid within five years. Loans outstanding upon termination may be considered default loans and are deemed a distribution to the participant.

### Payment of Benefits

In general, on termination of service a participant may elect to receive their vested interest in the form of a lump-sum amount, an account rollover, an annuity or leave the account in the Plan, subject to certain limitations and conditions as defined by the Plan. In-service distributions may be made from the Plan for certain participants based on the plan documents.

### Plan Termination

Although Plan Sponsor has not expressed intent to discontinue the Plan, it may do so at any time, upon resolution by Plan Sponsor's Board of Directors. The Plan provides that in the event of termination of the Plan, all amounts credited to the participant accounts will be fully vested and will be paid as directed in the Plan text and regulations.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Interest rates ranging from 4.25% to 10.25% were charged to notes receivable from participants during 2024. Loan amounts range from

approximately \$1,000 to \$31,000 and have dates of maturity through June 2028. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company. See Fair Value Measurements note for further information.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in Plan's investments. Management believes that the trustee maintains the Plan's investments with high quality institutions and attempts to limit the credit exposure to any particular investment.

### Payment of Benefits

The Plan records benefit payments to participants when paid.

### Expenses of the Plan

Certain administrative expenses incurred by the Plan are paid through amounts deducted from participant balances or netted against investment income. Accounting fees incurred by the Plan are paid by Plan Sponsor. These expenses qualify as party-in-interest transactions.

### Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 8, 2025.

## **3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Principal Trust Company (Principal), the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets at December 31, 2024, and the related investment activity and interest income on notes receivable from

participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies as of December 31, 2024 and 2023:

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Pooled separate accounts (PSA)*: Valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted.
- *Common/Collective trusts*: Fair values of shares of the common/collective trusts are based upon the net asset values of the funds reported by the fund managers as of the Plan's financial statement dates and recent transaction price. The fund invests in various stocks with a focus on large capitalization companies with an overall investment objective of replicating the investment performance of the S&P 500 Index. Generally, these investments are redeemable on a daily basis, with no advance redemption notification requirement.

## 5. INCOME TAX STATUS

The IRS has determined by an opinion letter dated June 30, 2020, that the non-standardized pre-approved plan adopted by the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The administrative expenses are paid to the plan trustee. Additionally, the Plan held party-in-interest investments with the trustee. Blue & Co., LLC is the independent auditor for the Plan and LPL Financial LLC is the investment advisor for the Plan. They receive payments for those services. The Plan Sponsor pays the expenses of the Plan, including administrative and accounting fees. These expenses qualify as party-in-interest transactions.

### **7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
