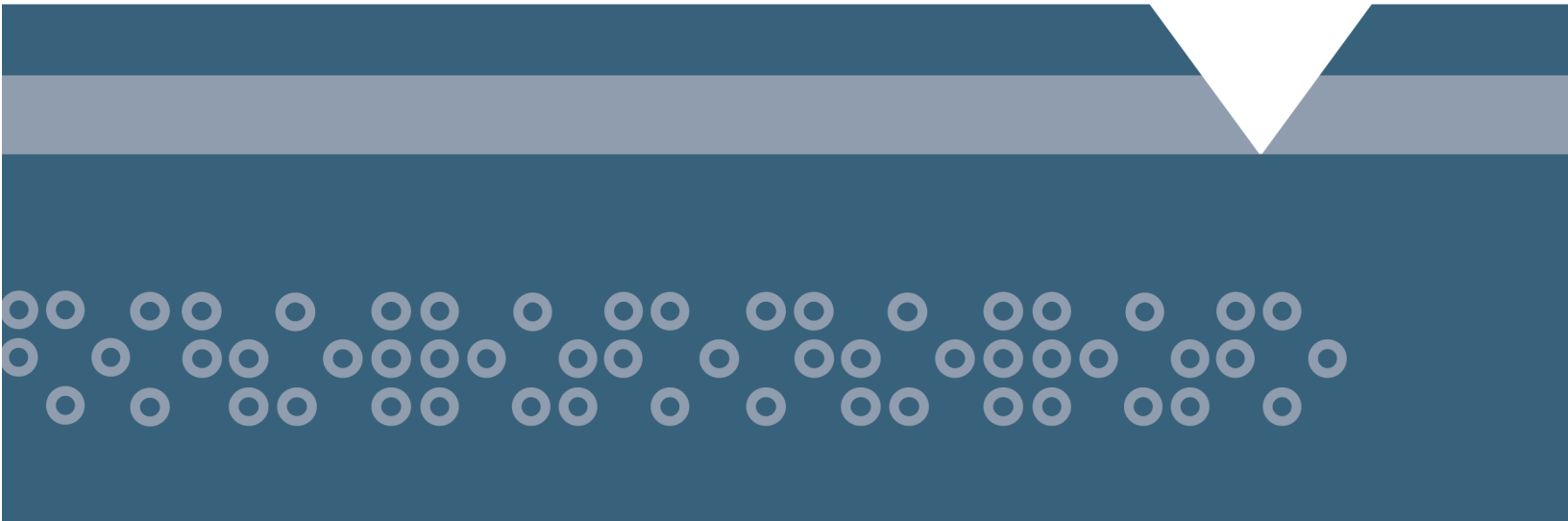

## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of United Built Homes, L.L.C. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. **Description of Plan**

The following description of United Built Homes, L.L.C. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**(a) General.** The Plan is a defined contribution plan covering all employees of United Built Homes, L.L.C. (the Company) and United Builders Construction Company (a related entity) who are age twenty-one (21) or older and who have completed one (1) year of eligible service (1,000 hours). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was adopted effective March 1, 1977. The Plan was restated on June 7, 2021 to include the provisions for regulatory changes and to allow hardship and other in-service distributions effective June 7, 2021. The Plan was restated on January 1, 2023 to be an automatic enrollment plan.

**(b) Contributions.** Each year, participants may defer between 1 and 15 percent of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may, at its sole discretion, and as determined from year to year, contribute a matching percent based on the Participants' elective deferrals. The Company may also, at its sole discretion, and as determined from year to year, make a profit-sharing contribution. To be eligible for the Company match or profit-sharing contribution, the participant must be employed as of the last day of the Plan year. Contributions are subject to certain limitations as defined in the Plan. All contributions are invested at the participant's discretion.

**(c) Participant's Accounts.** Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings or losses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is provided from the participant's vested account.

**(d) Vesting.** Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their account plus actual earnings thereon is based on years of continuous service and a minimum of 1,000 hours of service worked each plan year. Contributions made by the employer on behalf of the participant shall vest as follows:

- 20% vesting after 2 years of service
- 40% vesting after 3 years of service
- 60% vesting after 4 years of service
- 80% vesting after 5 years of service
- 100% vesting after 6 years of service

**(e) Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined periodically by the plan administrator. Principal and interest is paid ratably through regular payroll deductions.

**(f) Payment of Benefits.** At termination of service due to death, disability, or retirement, a participant may elect to receive either a single lump sum payment in cash equal to the value of the participant's vested account balance or installments over a period of not more than the assumed life expectancy of the individual. Hardship withdrawals are allowed under special circumstances.

**(g) Forfeited Accounts.** Forfeited nonvested accounts totaled \$37,208 and \$6,734 at December 31, 2024 and December 31, 2023, respectively. Per the plan document, forfeitures of employer discretionary contributions are used to offset the future discretionary contributions of the employer.

**2. Summary of Significant Accounting Policies**

**(a) Basis of Accounting.** The financial statements of the Plan are prepared under the accrual method of accounting, except for payment of benefits, which are recorded when paid.

**(b) Investment Valuation and Income Recognition.** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as those held during the year.

**(c) Notes Receivable from Participants.** Notes receivable from participants are valued at cost, which approximates fair value. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**(d) Use of Estimates.** The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**(e) Payment of Benefits.** Benefits are recorded when paid.

**(f) Operating Expenses.** A majority of the expenses associated with maintaining the Plan are paid by the Company.

**3. Information Certified by the Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company has certified that the following data included in the accompanying financial statements is complete and accurate.

**4. Fair Value Measurements**

FASB ASC #820, *Fair Value Measurements & Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC #820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered by the Securities Exchange Commission. These funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Party-In-Interest Transactions**

Capital Bank & Trust is the trustee of the Plan, and FASCore Recordkeeping Services is the record-keeper, and as such, both qualify as parties-in-interest.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**8. Tax Status**

The Company adopted a Prototype Standardized Profit Sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any taxing periods in progress.

**9. Risks and Uncertainties**

Substantially all of the Plan's assets are invested in mutual funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit.

**10. Subsequent Events**

In preparing the financial statements, management of the Plan has evaluated events and transactions for protentional recognition or disclosure through October 2, 2025, the date the financial statements were available to be issued, noting no significant subsequent events as of this date.
