## Independent Auditors' Report

To the Plans Administration Committee of Citigroup Inc:  
Citigroup Health Benefit Plan:

### *Opinion*

We have audited the financial statements of Citigroup Health Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with U.S. generally accepted accounting principles.

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of the Plan

The following brief description of the Citigroup Health Benefit Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### (a) General

The Plan was established as a contributory welfare benefit plan that provides health benefits to substantially all of the eligible employees of Citigroup Inc. (the Plan Sponsor or the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Certain plan assets are held in the Citigroup Staff Members' Association Welfare Benefit Trust, a qualified Voluntary Employees Beneficiary Association (VEBA) Trust established by the Plan Sponsor under Section 501(c)(9) of the Internal Revenue Code (IRC), in part to fund future health benefits for represented employees. Bank of New York Mellon is the Trustee of the VEBA Trust.

Effective January 1, 2011, the Company spun off the retiree medical plan to establish a stand-alone retiree plan, the Citigroup Retiree Medical Benefit Plan (the Retiree Medical Plan), to provide health benefits to certain eligible retirees. Eligible retirees who previously received benefits under the Plan were automatically enrolled on January 1, 2011 to receive benefits from the Retiree Medical Plan. Financial information relating to the Retiree Medical Plan is excluded from these financial statements.

#### (b) Benefits

The Plan offers health benefits (hospital, surgical, medical, prescription drug and mental health/chemical dependency) to all active benefits-eligible employees or employees on an approved leave of absence and eligible retirees, including their lawful spouse (regardless of gender) or domestic partner/civil union partner and eligible dependents. Eligible retirees are those enrolled, prior to September 1, 2011, in pre-65 fully insured Health Maintenance Organization plans who are not Medicare eligible. Participants are able to choose one of the following "coverage categories": (i) employee only; (ii) employee plus spouse/partner; (iii) employee plus children; or (iv) employee plus family.

The Plan consists of both self-insured and fully insured options.

Plan participants who are enrolled in a High-Deductible Health Plan option are generally eligible to set up a Health Savings Account held outside of the Plan and VEBA Trust.

#### (c) Contributions

Participant contributions are made to fund a portion of the cost of the Plan. Eligible participants enrolled in COBRA receive postemployment health benefits under the Plan. These participants pay 100% of the plan rate plus a 2% administration fee and their contributions are made on an after-tax basis through direct payments to the Plan Sponsor.

Certain eligible retirees receive postretirement health benefits under the Plan. The costs of the postretirement benefits are generally shared by the Plan Sponsor and the retirees. However, "access only" retirees pay the full cost of the plan. Retiree contributions are made through deductions from retiree pension checks or direct payments to the Plan Sponsor.

The remainder of the cost is borne by the Plan Sponsor. The VEBA Trust may pay benefits out of its assets until the assets are exhausted. The Plan Sponsor pays the remaining benefits out of the general assets of the Company.

At year-end, the Plan Sponsor may contribute such assets to the VEBA Trust as it reasonably determines necessary and appropriate to pay claims incurred but not reported (IBNR) in the current year under the various benefit plans for each year consistent with any limitations under Section 419 of the IRC, and will specifically indicate the allocation of such assets among the plans in the VEBA Trust. The Plan's assets held in the VEBA Trust are reported in the Plan's statements of net assets available for benefits. For the years ended December 31, 2024 and 2023, the Plan Sponsor elected not to fund the VEBA Trust and paid claims directly from the general assets of the Company.

**(d) *Administrative and Other Expenses***

The Plan pays certain expenses incurred in the administration and operation of the Plan, as permitted by the Plan document. The Plan Sponsor may elect to pay for certain expenses.

**(2) Summary of Significant Accounting Policies**

**(a) *Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

**(b) *Use of Estimates***

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosures of contingent assets and liabilities at the date the financial statements are prepared. Actual results could differ from those estimates and assumptions.

**(c) *Cash***

Noninterest bearing cash accounts are presented net of health claim checks issued but not yet cleared as of year-end. Overdraft accounts as of year-end are classified as "other liabilities" in the statements of net assets available for benefits, if any.

**(d) *Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date.

**(e) *Payment of Benefits***

Benefits for health claims and insurance premiums are recorded when paid.

Benefit payments are reported net of rebates and performance guarantees received by the Plan from certain providers.

The changes in actuarial assumptions and other gains and losses of the postemployment benefit obligations reflect an update in the mortality table and discount rate assumptions and other fluctuations in experience and demographics.

The weighted average health care cost-trend rate assumption has an effect on the benefit obligation reported. If the assumed rates increased by one percentage point, it would increase the postemployment obligation by \$861,000 and \$966,000 as of December 31, 2024 and 2023, respectively.

### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 – Quoted prices for identical instruments in active markets.
- Level 2 – Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which all significant inputs and significant value drivers are observable in active markets.
- Level 3 – Valuations derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable.

This hierarchy requires the Plan’s management to use observable market data, when available, and to minimize the use of unobservable inputs when determining fair value. As required by ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The methods described above may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (5) Risks and Uncertainties

The Plan's investments are held in various securities. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonable to expect that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health-care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported in the notes to the financial statements.

### (6) Tax Status

The IRS has determined and informed the VEBA Trust by a letter dated November 16, 1989 that the VEBA Trust is designed in accordance with applicable sections of the IRC and that, therefore, the VEBA Trust qualifies as tax-exempt under the IRC. Although the VEBA Trust and the Plan have been amended since receiving the determination letter, the Plan's administrator and the Plan's legal counsel believe that the VEBA Trust and the Plan, as amended, are designed and are currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Based on Plan's management review, the plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any open tax periods in progress. The Plan Sponsor believes the Plan is no longer subject to tax examination for years prior to 2021.

### (7) Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA. In the event of such termination, the net assets of the Plan shall be allocated to pay the benefit obligations of the Plan in accordance with ERISA.

### (8) Party-in-Interest Transactions

The Plan incurs costs for services provided by the Plan's claims administrators and fund managers. These transactions qualify as party-in-interest and are allowable under ERISA regulation.
