Citigroup Dental Benefit Plan:

Opinion

We have audited the financial statements of the Citigroup Dental Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with U.S. generally accepted accounting principles.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in



the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of the Plan

The following brief description of Citigroup Dental Benefit Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

(a) *General*

The Plan was established as a contributory welfare benefit plan that provides dental benefits to substantially all of the eligible employees of Citigroup Inc. (the Plan Sponsor or the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Sponsor established a qualified Voluntary Employees' Beneficiary Association (the VEBA) Trust under Section 501(c)(9) of the Internal Revenue Code (IRC), in part to fund future dental benefits for represented employees.

Bank of New York Mellon is the Trustee of the VEBA Trust.

(b) *Benefits*

The Plan provides dental benefits to all active benefits-eligible employees or employees on an approved leave of absence, their lawful spouses (regardless of gender), domestic partners, or civil union partners, eligible dependents, and eligible retirees. Participants are able to choose one of the following "coverage categories": (i) employee only; (ii) employee plus spouse/partner; (iii) employee plus children; or (iv) employee plus family.

Certain heritage retiree groups are covered under the Plan.

(c) *Contributions*

Participant contributions are made to fund a portion of the cost of the Plan.

A majority of the dental costs are paid by participants and the remainder of the costs are borne by the Plan Sponsor. Generally, the VEBA Trust pays benefits out of its assets until the assets are exhausted and then the Plan Sponsor pays the remaining benefits out of the general assets of the Company.

At year end, the Plan Sponsor may contribute such assets to the VEBA Trust as it reasonably determines necessary and appropriate to pay claims incurred but not reported (IBNR) in the current year under the various benefit plans for each year consistent with any limitations under Section 419 of the IRC, and will specifically indicate the allocation of such assets among the plans in the VEBA Trust.

(d) *Administrative Expenses*

The Plan pays certain expenses incurred in the administration and operation of the Plan, as permitted by the Plan document. The Plan Sponsor may elect to pay certain expenses.

(2) Summary of Significant Accounting Policies

(a) *Basis of Accounting*

The accompanying financial statements have been prepared under the accrual basis of accounting.

(b) *Use of Estimates*

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosures of contingent assets and liabilities at the date of financial statements. Actual results could differ from those estimates and assumptions.

(c) *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value.

Short-term investments are valued at cost, which approximates fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis.

(d) *Payment of Benefits*

Benefits for dental claims and insurance premiums are recorded when paid. Benefit payments are reported net of rebates and performance guarantees received by the Plan from certain providers.

(3) Benefit Obligations

(a) *Postretirement Benefits*

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Company.

The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan Sponsor and existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected benefit obligation that is attributed to the employee's service with the Company rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money and the probability of payment between the valuation date and the expected date of payment.

At December 31, 2024 and 2023, the Company maintained the Private Retirement Plans (PRI-2012) mortality table and the Mortality Projection 2021 (MP-2021) projection table. The PRI-2012 table is the white-collar mortality table with a 93% adjustment. The MP-2021 projection scale is projected from 2012 with convergence to ultimate rate of annual improvement by 2037.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

(b) Postemployment Benefits

Plan obligations for future dental benefits for disabled employees are actuarially determined using a discount rate of 5.45% in 2024 and 5.30% in 2023 to estimate present value.

The changes in actuarial assumptions and other gains and losses of the postemployment and postretirement benefit obligations reflect an update in the mortality and discount rate assumptions and other fluctuations in experience and demographics.

The weighted average health-care cost trend rate assumption has a significant effect on the postretirement obligation amounts reported. If the assumed rates increased by one percent, it would increase the postretirement obligation by \$68,000 and \$78,000 as of December 31, 2024 and 2023, respectively.

(4) Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 – Quoted prices for identical instruments in active markets.
- Level 2 – Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which all significant inputs and significant value drivers are observable in active markets.
- Level 3 – Valuations derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable.

This hierarchy requires the Plan’s management to use observable market data, when available, and to minimize the use of unobservable inputs when determining fair value. As required by ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The methods described above may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan’s management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's short-term investments at December 31, 2024 and 2023 consist of a short-term investment fund, which is reported as level 1 and insurance contracts payable on demand which are reported as level 2.

There were no transfers of investments among levels during the years ended December 31, 2024 and 2023. There were no changes in the fair value methodology used at December 31, 2024 and 2023.

(5) Risks and Uncertainties

The Plan's investments are held in short-term investments, which are monetary in nature. As a result, interest rates have a more significant impact on the Plan's investment performance than the general levels of inflation. Interest rates do not necessarily move in the same direction or in the same magnitude as the prices of goods and services, as measured by the consumer price index. The short-term investments are subject to risk conditions of the individual fund objective, interest rates, economic conditions, and overall market volatility.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health-care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported in the financial statements.

(6) Tax Status

The IRS has determined and informed the VEBA Trust by a letter dated November 16, 1989 that the VEBA Trust is designed in accordance with applicable sections of the IRC and, therefore, the VEBA Trust qualifies as tax-exempt under the IRC. Although the VEBA Trust and the Plan have been amended since receiving the determination letter, the Plan's administrator and the Plan's legal counsel believe that the VEBA Trust and the Plan, as amended, are designed and are currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. Based on the Plan's management review, the plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any open tax periods in progress. The Plan Sponsor believes the Plan is no longer subject to tax examination for years prior to 2021.

(7) Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plan, subject to the provisions set forth in ERISA. In the event of such termination, the net assets of the Plan shall be allocated to pay the benefit obligations of the Plan in accordance with ERISA.

(8) Party-in-Interest Transactions

The Plan incurs costs for services provided by the Plan's claims administrator and fund manager. These transactions qualify as party-in-interest and are allowable under ERISA regulation.
