Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

**Note 1. Plan Description**

The following brief description of the De Dietrich Process Systems, Inc. Savings Plan (the Plan) is for general information only. Participants should refer to the summary plan description and plan document for more complete information.

The Plan was established on October 1, 1987 and was amended and restated effective August 1, 2018. The Plan is a defined contribution plan covering all employees of De Dietrich Process Systems, Inc. (the Company). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

**Eligibility**

Employees are eligible to participate in the Plan and receive employer matching contributions upon the attainment of 21 years of age and the completion of one three-month eligibility period of service. Employees eligible to participate in the Plan are automatically enrolled on the first day of the month, immediately following or coinciding with the day they complete their eligibility requirements. Employees may elect not to participate in the Plan.

**Contributions**

The Plan provides each participant with an opportunity to make elective pre-tax and Roth contributions from 1% to 100% of their eligible compensation each pay period subject to the limitations of the Internal Revenue Code (IRC). Participants over the age of 50 are able to defer an additional amount, subject to limitations of the IRC (catch-up contribution). Participants are automatically enrolled at a pre-tax deferral percentage of 5%, unless the employee elects not to participate in the Plan, or chooses their own deferral rate. Employees that are automatically enrolled in the Plan will have the pre-tax deferral percentage automatically escalated by 1% each April 1, unless the employee makes a contrary election. The automatic escalation may not increase an employee deferral rate higher than a maximum rate of 10%. Participants may also make rollover contributions from other qualified plans.

The Company may make a discretionary matching contribution in accordance with the provisions contained in the plan document. For the year ended December 31, 2024, the Company made a contribution equal to 100% of participants' salary deferral contributions, limited to the first 5% of participants' eligible compensation. The Company is required to make a matching contribution equal to 100% of the participants' catch-up contributions.

**Vesting**

Participants are immediately and fully vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions plus actual earnings thereon is based on years of service, as follows:

***Participant Accounts***

Each participant's account is credited with their deferral contributions, employer contributions and the earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the plan document.

***Forfeitures***

The Plan requires that terminated employees who resume employment within five years have any forfeited amounts reinstated (reinstatement period). Subsequent to the reinstatement period, plan participants' forfeitures may be applied as a reduction of matching contributions made by the Company or as a reduction of plan expenses. Any excess forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions shall be allocated as of the last day of the plan year to participant accounts in accordance with the allocation formula defined in the agreement. For the year ended December 31, 2024, forfeitures from participants were \$63,009. During 2024, plan forfeitures of \$43,310 were applied in conjunction with the payment of the employer contributions, while there was net appreciation in investment value, dividends, and expenses of \$4,138 in aggregate. At December 31, 2024 and 2023, the available forfeiture balance was \$42,207 and \$18,370 respectively.

***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of a loan is five years; or ten years if the loan is for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus one percent (1%). Participant loans are valued at amortized cost, plus accrued interest, if any. Principal and interest are repaid ratably through payroll deductions. The interest rate at December 31, 2024 ranged from 4.25% to 9.50% on all outstanding loans with various maturity dates through February 2030.

***Payment of Benefits***

Upon normal retirement age (65), death, disability, or termination of service, vested benefits can be distributed in the form of a lump sum payment or through installment payments pursuant to specific guidelines as set forth in the plan document.

***Administrative Expenses***

All transaction fees are paid from participants' accounts. Substantially all other administrative expenses were paid by the Company.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices, if available, are used to value investments. See Note 4 for discussions of fair value measurements.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Subsequent Events***

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available for issuance.

Effective May 1, 2025 the Heinkel Filtering Systems Inc 401(k) Profit Sharing Plan and Trust was merged into the Plan.

Effective July 1, 2025 the Plan was renamed to De Dietrich USA Inc. Savings Plan.

**Note 3. Information Certified by the Plan's Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company (Principal or the custodian) a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Investment Contract with Insurance Company**

The Plan is party to investment contracts with Principal, at December 31, 2024 and 2023, respectively, whereby the custodian maintains certain of the Plan's contributions in a guaranteed income fund.

The guaranteed income fund is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by the custodian. The contract is included in the financial statements at contract value, (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses), because it is fully benefit-responsive. For example, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events could limit the ability of the Plan to transact at contract value with the custodian. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsors or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed income fund does not permit the custodian to terminate the agreement prior to the scheduled maturity date.

**Note 5. Fair Value Measurements**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the year ended December 31, 2024:

- Mutual funds: Shares held by the Plan at year-end are valued at unadjusted quoted prices in active markets.
- Common collective trusts: The fair value of the common collective trusts is determined by the trustee of the common collective trusts based on the fair value of the underlying assets, which represent net asset value, a practical expedient to fair value, of units held by the Plan. The common collective trusts do not have any unfunded commitments relating to its investments, or any restrictions on redemptions. Participant directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. If the Plan is terminated, the amount credited to the account of each participant will be fully vested.

**Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Principal. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's management believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 8. Risks and Uncertainties**

The Plan's investments are concentrated in common collective trusts and mutual funds that invest in various investment securities. Such securities are subject to various risks, such as interest rate, market, and credit risks that determine the value of the fund. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

**Note 9. Party-in-Interest Transactions**

Certain plan investments are invested in mutual funds, common collective trusts, and a guaranteed investment fund which are managed by Principal. Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to an affiliate of Principal by the Plan for management services amounted to \$74,022 for the year ended December 31, 2024.

**Note 10. Reconciliation of Financial Statements to Form 5500**

The Form 5500 was prepared on the cash basis for the Plan years ended December 31, 2024 and 2023 and the financial statements were prepared on the accrual basis.
