## REPORT OF INDEPENDENT AUDITORS

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of HGC 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### 1. DESCRIPTION OF PLAN

The following description of the HGC 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of HGC Construction Co. and related employers (the "Sponsor"). Employees become eligible after completing 3 months of service as defined in the Plan document and after reaching age eighteen. The Plan was amended on March 4, 2024, to make employees eligible after one month of service. They may enter the Plan on the 1<sup>st</sup> day of each calendar month after they have met the eligibility requirements. Employees become eligible to receive prevailing wage contributions as soon as they begin employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Contributions

Each year, participants may contribute up to the maximum amount allowable by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Plan allows participants to elect pre-tax contributions and/or Roth after-tax contributions. The Plan has an auto-enrollment provision for all newly eligible employees for pre-tax contributions unless they affirmatively elect otherwise. Contributions are invested in a designated balanced fund until changed by the participant.

The Sponsor contributes 25 percent of the first 7 percent of eligible compensation contributed to the Plan. The Sponsor may also, in its sole discretion, make profit sharing contributions and qualified non-elective contributions to the Plan in an amount necessary to meet the Sponsor's requirement under an applicable prevailing wage statute. Prevailing wage contributions will be made by the Sponsor at the hourly rate designated for each prevailing wage employee's employment classification for the construction project at which the work was performed.

Participants direct the investments of their contributions and the Plan Sponsor's contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, plus the Sponsor's contributions, and plan earnings. Participant's accounts are charged with an allocation of administrative expenses by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their voluntary contributions and Sponsor prevailing wage contributions, plus actual earnings thereon. Vesting in the Sponsor's discretionary contributions is based on years of continuous service as noted in the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 but less than 2	10%
2 but less than 3	50%
3 but less than 4	75%
4 years and over	100%

### Notes Receivable from Participants

Participants may borrow from their funds a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid in level payments generally through payroll deductions on at least a quarterly basis over a period not to exceed 5 years unless the loan is for the purchase of a principal residence upon which the loan repayment period may extend to 10 years.

### Hardship Withdrawals

Participants are able to withdraw amounts from their accounts in case of financial hardship as defined by the Plan. The withdrawal is subject to tax withholding and a 10 percent penalty, as required by the Internal Revenue Service (IRS). A participant's elective contributions are suspended for six months following a hardship withdrawal.

### Payment of Benefits

Upon termination of service, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawal distributions.

### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$58,146 and \$40,304, respectively. These accounts can be used to reduce future Sponsor contributions or to pay Plan expenses. During the years ended December 31, 2024 and 2023, plan administrative expenses of \$12,250 and \$6,025 respectively were paid for from forfeited non-vested accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts and common collective trusts, which are reported at contract value and Net Asset Value (NAV), respectively). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends and capital gain distributions are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

Expenses and costs of administering the Plan are paid by the Plan and the Sponsor. Administrative expenses include the preparation of the Form 5500, compliance testing, consulting, recordkeeping, documenting and updates. Investment-related expenses are included in net change in fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

## **3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets for benefits as of December 31, 2024 and 2023, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

## **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Money market mutual funds* – Valued at the daily closing price as reported by the fund. The money market fund held is an open-end market mutual fund that is registered with the U.S. Securities and Exchange Commission (SEC). This fund is required to publish its daily NAV and to transact at that price. The money market fund is deemed to be actively traded.
- *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan and are open-end funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.
- *Common/collective trusts* – valued at the NAV of units of the common/collective trusts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily; however, the trust may impose withdrawal restrictions at its discretion if warranted by operating conditions.

The following table sets forth by level, within the hierarchy, the Plan's assets measured at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.:

#### **5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has a single insurance group annuity contract with Putnam Fiduciary Trust Company. Putnam Fiduciary Trust Company maintains the contributions in a general account. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the

amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

## 6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Sponsor and certain others. Professional fees and the majority of other administration expenses of the Plan were paid by the Sponsor.

Certain investments of the Plan were held in investment funds managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the plan trustee and, therefore, these investments qualify as party-in-interest investments. Participant loans also qualify as party-in-interest transactions. Blue & Co., LLC is the independent auditor for the Plan. Woodbury Financial Services, Inc., Strategic Advisors, Inc. and Leafhouse Financial Advisors, LLC are advisors and receive payments from the Plan. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The Sponsor provides certain accounting, recordkeeping and administrative services to the Plan, for which it is not compensated.

## 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Sponsor contributions.

## 8. TAX STATUS

The Plan is based on a Non-Standardized Pre-Approved Profit Sharing Plan with Cash or Deferred Arrangement which has received a favorable opinion letter dated June 30, 2020, from the IRS that the Plan is designed to qualify as being exempt from Federal income taxes. The Plan has not separately applied for an opinion letter from the IRS. However, the plan's management believes that the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code and, therefore, no income taxes have been provided.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
