Independent Auditor's Report

To the Plan Administrator and Participants
Samaritan Health Services Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Samaritan Health Services Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Samaritan Health Services Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Samaritan Health Services Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Samaritan Health Services Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

1. Description of Plan

The following description of the Samaritan Health Services Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a 401(a) defined contribution money purchase pension plan covering eligible employees of Samaritan Health Services, Inc. (SHS) and any affiliate approved by SHS. The Plan has an effective date of January 1, 2001. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). SHS is the Plan's sponsor and serves as the plan administrator. The Principal Trust Company (Principal) serves as the trustee of the Plan

b. Eligibility

All employees are eligible to participate in the Plan after meeting the eligibility requirements, except leased employees and employees whose employment is governed by the terms of a collective bargaining agreement, unless such collective bargaining agreement expressly provides for inclusion of such employees as participants in the Plan. An employee is eligible to receive employer contributions when he or she reaches 18 years of age and completes 1,000 hours of service during a 12 consecutive month period, as defined by the Plan. Employees begin receiving contributions on the January 1st, April 1st, July 1st, or October 1st that follows the date on which they satisfied the eligibility requirements.

c. Contributions

SHS will contribute an annual amount equal to the sum of 4% of compensation plus 4% of compensation in excess of the social security taxable wage base up to the annual compensation limit allowed by the Internal Revenue Code (IRC). Contributions are made quarterly for those participants who have accumulated at least 250 hours during the quarter. The Plan does not allow for employee contributions other than eligible rollover contributions.

d. Participant Accounts

Each participant's individual account is valued daily and credited with employer contributions, plan earnings, and an allocation of administrative expenses, depending upon the fee structure of the investments used in the individual portfolio. Participants may direct their current contributions into a variety of investment options offered through the trustee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants may change their investment options at any time. The return on investment will vary for each investment option. Descriptions of investment objectives for each of the funds offered by the trustee can be obtained from the plan administrator.

e. Vesting

Participants are 100% vested in employer contributions and earnings at three years of service.

f. Forfeitures

The forfeited accounts of nonvested terminated participants may be used to pay administrative expenses of the Plan or to reduce future employer contributions. For the years ended December 31, 2024 and 2023, forfeitures totaling approximately \$830,000 and \$0, respectively, were utilized to reduce employer contributions. For the years ended December 31, 2024 and 2023, forfeitures totaling approximately \$0 and \$106,000, respectively, were utilized to pay administrative expenses. Forfeitures available to pay administrative expenses or reduce future contributions were approximately \$0 and \$832,000, respectively, at December 31, 2024 and 2023.

g. Payment of Benefits

Participants may receive all or a portion of their account balance upon termination of employment, death, disability, or the attainment of retirement age. Benefits may be paid in the form of a single lump sum if under \$1,000, or if the vested balance exceeds \$5,000, the participant can elect a lump sum or monthly, quarterly, semiannual, or annual cash installments over a period certain that does not extend beyond the participant's expected life or joint and last survivor expectancy of the participant and a designated beneficiary. The distribution of benefits must commence by April 1st of the year following the year in which the participant attains 70½ years of age or April 1st of the year following the year in which the participant retires from service, whichever is later.

In compliance with the Setting Every Community Up for Retirement Enhancement (SECURE) Act, the requirement to take distributions was waived.

Furthermore, for participants that attain 70½ years of age after December 31, 2020, the distribution of benefits must commence by April 1st of the year following the year in which the participant attains 72 years of age or April 1st of the year following the year in which the participant retires from service, whichever is later.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (the FASB), which establishes U.S. generally accepted accounting principles (GAAP) that are followed in reporting the statements of net assets available for benefits and statements of changes in net assets available for benefits.

b. Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

The Plan follows the fair value measurement and disclosure requirements of FASB Accounting Standards Codification Topic 820, *Fair Value Measurement* (ASC Topic 820), which defines fair value as the exchange price that would be received for the asset or paid to transfer a liability in

the principal or most advantageous market for the asset or liability. Investments are reported at fair value as defined by ASC Topic 820, except for the fully benefit-responsive investment contract with Principal, which is valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to a fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold during the year, as well as the changes in the unrealized depreciation or appreciation on those investments from one period to the next.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

d. Contribution Receivable

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company of the participants. Contribution receivables are recorded at cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

e. Other Income

Other income represents credits to the Plan as a result of revenue sharing agreements with the Plan's trustee, which are used to pay plan expenses or are credited to participant accounts based on their relative investment balances.

f. Payment of Benefits

Benefits are recorded when paid.

g. Administrative Expenses

Administrative expenses paid by the Plan consist primarily of investment management and audit fees. Certain of the Plan's expenses, such as legal fees, have been paid directly by SHS and are not included in these financial statements.

3. Investment Contract with Insurance Company

The Plan invests in the Principal Fixed Income Guaranteed Option (PFIGO), which is a fully benefit responsive group annuity contract with Principal Life Insurance Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer, Principal, is contractually obligated to repay

the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. In the event that the plan sponsor terminates the contract and requests an immediate payout, the contract payout would be subject to a 5% termination fee. The plan administrator does not believe that the occurrence of any such contract value events, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. SHS does not intend to terminate its interests in the PFIGO in the near future.

4. Fair Value Measurements

ASC Topic 820 establishes a framework for fair value measurement, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Risks and Uncertainties

The plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan may invest in shares in mutual funds and insurance contracts, which include securities with contractual cash flows. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies, or defaults, or both, and may be adversely affected by shifts in the market’s perception of the issuers and changes in interest rates.

6. Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103 8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosures under ERISA. The following information included in the financial statements and schedule was provided and

certified by the Plan's trustee, Principal, as of and for the years ended December 31, 2024 and 2023 as complete and accurate:

- Investments, at fair value
- Investment, at contract value
- Investment income
- Schedule of assets (held at end of year)

7. Party-in-interest Transactions

Certain plan investments are managed by Principal. As Principal is also the trustee, as defined by the Plan, these investments and investment transactions qualify as party in interest transactions.

8. Tax Status

On March 31, 2014, the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, qualifies under the IRC Section 401(a). The Plan has not applied for a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Plan Termination

Although it has not expressed any intent to do so, SHS has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

10. Subsequent Events

The Plan has evaluated subsequent events with respect to the Plan through October 10, 2025, the date the financial statements are available to be issued and concluded there are no material subsequent events that required recognition or additional disclosures in these financial statements.
